Judge Fawcett addressed the audience to explain the goal and what the funds would be used for. He also went over the need for a new Courthouse and Juvenile Detention Center.

Joe Weeks staff of Connection Christian Church spoke in support of a new Juvenile Detention Center. He also thanked the court for recognizing that the kids need better.

Jeff Russell spoke in opposition to the issuance of Certificates of Obligations and encouraged the court to put it to a citizen vote.

Dean Combs addressed the court in favor of issuing Certificates of Obligations.

Samuel J. Davidson spoke in opposition to the issuance of Certificates of Obligations.

Samantha Russell addressed the court to express that she is in favor of a new courthouse but not in favor of issuing certificates of obligation.

Angela Gardner addressed the court to stress her concerns that the courthouse is not ADA compliant and is in favor of this action.

Larry Robinson spoke in opposition to issuing debt without voter approval.

George Williford of Hilltop Securities addressed the court and gave a presentation regarding the timeline and cost of the planned Certificate of Obligation issuance.

Michelle Spinks addressed the court to encourage forward-thinking ideas for maintenance of buildings and would like to encourage rain catchment at each facility.

Commissioner Stringer made a motion to approve and authorize publication and posting of

Notice of Intention to issue Certificates of Obligation, including the adoption of a Resolution; a second was made by Judge Fawcett. MOTION PASSED 5-0

Commissioner Simmons made a motion to deny the request for outside security services; a second was made by Commissioner Stringer. MOTION PASSED 5-0

7. Bid Award: Medical Examiner Transport Services, Lucy Soto- Purchasing Director, Carl Rogers-Medical Examiner Director/Chief Investigator

To consider, discuss, and take any necessary action to approve the award for the *Medical Examiner Transportation Service*, Bid No. 2024-IFB-040, to A & H Funeral Transport, and authorize the County Judge to sign all documents associated with this agenda item.

A motion was made by Commissioner Simmons to approve the award for the Medical Examiner Transportation Service with changes to pricing. Transport roundtrip mileage cost will be \$2.50 for the first year beginning October 1, 2024, and escalating up to \$2.90 in the second year of the contract. The removal fee of \$585 would be decreased to \$400 for the first year and increase to \$585 in the second year and scene pickup pricing is reduced to \$700 for the first year and \$800 during the second year; Commissioner Gardner seconded the motion.
