1. Call to Order at 3:00 p.m. Prayer by Mayor Dusty Cornelius.
2. Billy Tidwell – Presentation of Declaration of Disaster. Cost Tracking Guide. Any city who needs to be reimbursed for anything will need to fill out a form from Billy and send it in on their own. Billy advised that everything needs to be filled out exactly correct and the funds would not be arriving soon.
3. Debbie Miller, Crosbyton Hospital Administrator advised that Crosbyton Hospital does not have any tests for Coronavirus. They are able to run labs and if you meet criteria, you can go to Lubbock to be tested. They have limited services and limited beds at the hospital. Sheila Womack from Crosbyton Ambulance Service advised that if you are sick and call 9-1-1, dispatchers will be screening symptoms. An assessment will be made before anyone is taken in. Also, Sheila advised that each ambulance will be cleaned entirely if someone with Coronavirus is taken to Lubbock.

EMS attendants will be screening each other twice a day for symptoms. All 3 cities will be working together and have plans in place for helping each other in case of emergencies. Because of the 50 person in one place rule, the Crosbyton Senior Citizens will be closed. Meals will be delivered to seniors. Margot Hardin said they would be closing their lobby and some of their employees could possibly help with the deliveries.

4. Crosbyton School Superintendent Shawn Mason informed that they were spending this week disinfecting the schools.

Lorenzo School Superintendent Kayla Morrison advised that the current talk was to be closed until April 1 but that Lubbock Schools were talking about not going back to school this year.

Ethan Villanueva-Crosby County Sheriff said he would visit with his deputies and they would help with whatever they can. Jail Standards also wants officers to screen anyone they might be taking to jail and to cite and release if any symptoms were shown.


