





1. Motion to approve minutes of the Regular Commissioner's Court meeting on August 12, 2019, the called meeting on August 19, 2019, the called meeting on August 30, 2019, and the called meeting on September 4, 2019 was made by Frank Mullins, seconded by Kevin Langdon, and approved by unanimous vote of the Court.
2. Motion to approve bills excluding M & W Auto Supply bill, was made by Frank Mullins, seconded by Larry McCauley and approved by unanimous vote of the Court.
  - (a) Motion to approve M & W Auto Supply bill was made by Larry McCauley, seconded by Kevin Langdon and approved by unanimous vote of the Court. Frank Mullins abstained.
3. Motion to approve audit reports was made by Frank Mullins, seconded by Larry McCauley and approved by unanimous vote of the Court.
4. Motion by Frank Mullins, seconded by Kevin Langdon, to ratify property tax increase reflected in Budget LGC 111.008(c), approved by unanimous vote of the Court.
5. Motion made by Frank Mullins, seconded by Kevin Langdon, to adopt the 2019-2020 Budget as changed. Motion approved by unanimous vote of the Court.
6. Motion made by Frank Mullins that the property tax rate be increased by the adoption of a tax rate of .5413, which is effectively a 5.87% increase in the tax rate. Motion seconded by Kevin Langdon and approved by unanimous vote of the Court.
7. Caitlyn Jackson talked to the Commissioner's Court about the Buy Board program. She obtained three quotes for a new vehicle. Frank Mullins made a motion to enter into an Agreement with The Local Government Purchasing Cooperative, motion seconded by Kevin Langdon, and approved by unanimous vote of the Court.
8. Motion by Frank Mullins, seconded by Kevin Langdon to approve the revised contract between the City of Lorenzo and Crosby County Sheriff's office. Motion approved by unanimous vote of the Court.
9. Motion made by Frank Mullins, seconded by Kevin Langdon to approve raising the per diem from \$35.00 per day to \$46.00 per day. Motion approved by unanimous vote of the Court.

10. Discussion about signed contract with LGS Software. Caty and Jonathan stated they have both been trying to talk to someone about when they would start transferring Crosby County files.
11. Motion by Frank Mullins, seconded by Kevin Langdon to approve Sheriff Villanueva accepting LEOSE check from the City of Lorenzo for training purposes. Motion approved by unanimous vote of the Court.

14. Sheriff's Report. Sheriff Villanueva reported on Paul Valerio, a Deputy Sheriff who has been ill. The Sheriff reported he is currently fully staffed. They have had over 150 calls this month. They did not get the grant for cameras.
