An Election is hereby ordered to be held on November 7, 2023, in Bailey County, Texas for the purpose of voting in a Special Election to adopt or reject the proposed Constitutional Amendments as submitted by the 88th Legislature (see Exhibit A), Regular Session and a Second Special Session of the State of Texas.




