6. First Public Hearing regarding the Proposed FY2017 Budget and Tax Rate. This hearing is for express purpose to invite public comment and discussion with the Commissioners' Court regarding the Proposed Budget and Tax Rate.
7. Adjourn.


Agenda items may be considered, deliberated and/or acted upon in a different order than set forth above.
