Commissioner Belt stated all the growth in the County is a factor in the budget. The Court agreed that they discuss and consider all budget requests during budget sessions and try to control increases as best they can.

Judge Celander read the Order Setting The 2013 Property Tax Rate For Gaines County, Texas. The tax rate is proposed in the following components: General Fund Maintenance and Operation Tax Rate \$0.251418 FC/Lateral Road Maintenance and Operation Tax Rate \$0.109684 Commissioner Yocom made a motion to adopt the 2013 Total Ad Valorem Tax Rate of \$0.361102 per \$100 assessed valuation on all taxable property within the County. The motion was seconded by Commissioner Belt, with all Court members voting aye, none against. The motion carried unanimously. (see attached)
