(No Personal Checks or Cash accepted) or you may pay by credit card (see forms of payment information below) Payments that are mailed, must be postmarked by the appearance date noted on your ticket.

If you hold a CDL, you are not eligible for deferred disposition. If you qualify for deferred disposition and the Court grants it, you will be placed on unsupervised probation for a period not to exceed 180 days, and if at the end of that period you have complied with the terms of your probation, your case will be dismissed. You MUST contact the Court for this option. If you are younger than 25 years of age, you must complete a driver safety course as a term of your probation. A fee will be required. Your request must be postmarked by the appearance date on your ticket.

To be eligible you MUST do ALL of the following:

- 1. Complete the REPLY FORM (other side Section A, Check Box 3).
- 2. Complete the AFFIDAVIT FOR DRIVING SAFETY COURSE AND HAVE FORM NOTARIZED (other side Section B).
- 3. Mail REPLY FORM with Notarized AFFIDAVIT, Proof of Insurance, and Cashier's Check or Money Order for \$146.00, (\$171.00 if in a school zone) All items must be postmarked by your appearance date to the court that is listed on your ticket. You may also pay the fee by credit card (see information below)
- 4. Request a certified copy of your driving record from DPS by applying online @ https://www.dps.texas.gov/internetforms/Forms/DR-1.pdf. You will check Box 3A OR CONTACT DPS @ 512-424-2000 to have a form mailed to you. A fee will be required to obtain your record.
