Court having been opened according to law the following proceedings were had to wit:

Motion was made by Commissioner Cartrite to approve the minutes of the Special Meeting of January 28, 2019. Motion was seconded by Commissioner Garcia. Motion carried. Commissioner Mixon "ABSTAINED."

Motion was made by Commissioner Cartrite to approve the Temporary Cash Investments dated February 11, 2019 as presented by James Allen, County Auditor, be approved and the County Treasurer's Report of Cash Disbursements of the same date be approved and duly recorded in the Commissioner's Court Minutes. Motion was seconded by Commissioner Vaughan. Motion carried. Copies of the Report and the Temporary Cash Investments are attached and made a part hereof by references.

Motion was made by Commissioner Mixon to approve moving Judge Rhoades position on the Panhandle Community Services Board from private to public representing Moore County. Motion was seconded by Commissioner Cartrite. Motion carried.

Motion was made by Commissioner Garcia to approve moving Genevie Sheets position on the Panhandle Community Services Board from public to private representing Safe Place. Motion was seconded by Commissioner Vaughan. Motion carried.

Travis Smith, Road & Bridge Supervisor gave an update on the department. Travis stated they are patching potholes, will move crusher back to the yard before moving back to the Sunray pit. Commissioner Cartrite stated he received a call from Aldo, Cactus City Manager asking the county to caliche the alleys in Etter. It was decided to that some of the alleys have caliche on them and the county will place additional caliche to repair major potholes and maintain the alleys going forward.
