Court having been opened according to law the following proceedings were had to wit:

During routine announcements and reports Judge Rhoades stated Moore County was recognized for zero lost time for the workers compensation program. Copy of certificate attached and made a part hereof by references.

Motion was made by Commissioner Mixon to approve the minutes of the Regular Meeting of March 10, 2025, Special Meeting of March 24, 2025 and Emergency Called Meeting of April 4, 2025. Motion was seconded by Commissioner Garcia. Motion carried. Commissioner Mixon "Abstained" from March 24, 2025; Commissioner Farni "Abstained" from March 10, 2025 and Commissioners Vaughan and Garcia "Abstained" from meeting of April 4, 2025.

Motion was made by Commissioner Garcia that the bills as presented by County Auditor, Coy Barton, be approved for payment and the County Treasurer is hereby directed to issue warrant-checks thereof. Motion was seconded by Commissioner Mixon. Motion carried.

Motion was made by Commissioner Vaughan to approve the Temporary Cash and Investments dated April 14, 2025 as presented by Coy Barton, County Auditor and the County Treasurer's Report of Cash Disbursements of the same date, be approved and duly recorded in the Commissioner's Court Minutes. Motion was seconded by Commissioner Garcia. Motion carried.

Judge Rhoades declared the meeting open for a public hearing at 9:08 A.M. regarding stop signs to be placed in Etter. It was stated there are no stop signs in the area and people do not slow down through the intersections. 
It appears there is no other business to come before the court. Motion was made by Commissioner Mixon to adjourn. Motion was seconded by Commissioner Farni. Motion carried.
