#### **COMMUNICATIONS**

Judge Rathmell stated that many got together for the Easter holiday. He added that Charlie Averitt passed away. He received a call from Congressman Cuellar who will be here on Friday for grant announcement for Sheriff's Office. Grant is for over \$660,000 for renovations. #### TAX / ASSESSOR COLLECTOR'S REPORT

Tax Assessor/Collector's office reported Hotel-Motel tax collections in the amount of \$10,138.46 for the month of March with a year—to-date total of \$58,600.99. Net collections were \$343,167.68 with tax collections at a rate of 85.77%. A total of \$892,690.00 was collected through the Home Owners Assistance Program. Utility Program is still ongoing.
