WHEREUPON, the following Orders and Proceedings were had by said Court, to-wit:

MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF COMMISSIONERS COURT INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Commissioner Solis stated that the signing of Attendance Matters Proclamation took place. He added that the Bravo Park ponds are being drained. Concerned citizens have been asking about the ducks; they migrate from the Bravo Park to the Golf Course; the ducks are safe.

Judge Rathmell commented that the Zapata Hawks beat Cigarroa 42-10. He added that Zapata missed heavy rains from Hurricane Harold. He thanked the commissioners for clearing creeks in Medina Addition. The lake situation is still critical.

Commissioner Garza stated that the school had the Gingerbread Man event.

David Vasquez, with Concession Assessment and Wellness Center, addressed the court and stated that he works with a pharmacy that offers the most advanced concession assessment. They will be working with health providers covered by most insurance plans. They also have a mobile and RV unit.
