#### **COMMUNICATIONS**

Commissioner Solis stated that they are backed on work at Pct. 3 due to last week's short work week.

Commissioner Morales thanked all for participating at the fair and thanked the Commissioners for helping set up for county fair.

He also asked for prayers for the Martinez-Medina family who suffered a fire at their residence.

Judge Rathmell congratulated and thanked parents and volunteers for their participation in the fair. It was a great event with great weather and the auction went very well.

Patricia Gonzalez, Indigent Program Director, reported that 137 people were serviced, 37 were assisted with utilities, and 14 were assisted with funeral expenses. She also commented that they are organizing a coalition with the library called Zapata Fuerte.
