**ORDER APPROVING TO RESCIND BID AWARD FROM FRANK'S
CONSTRUCTION AND AUTHORIZE TO REBID ZAPATA COUNTY CFC21-0191
NORTHWEST ZAPATA COLONIA PROJECT**

Motion was made by Judge Rathmell, seconded by Commissioner Garza, to rescind the bid award to Frank's Construction and authorize to rebid the Zapata County CFC21-0191 Northwest Zapata Colonia Project as requested by Manuel Gonzalez, Premier Engineering.

Discussion: Zapata County was awarded a \$665,000.00 grant. Frank's Construction Company has been unable to attain performance in payment bonding. Zapata County was going to match \$130,000.00. Mr. Kendra, on speaker phone, recommended that the bid award be rescinded. Zapata County will send re-bid to meet deadline. It takes up to 3 weeks for the bidding process.
