MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF COMMISSIONERS COURT INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Commissioner Solis stated that due to low water levels, the secondary ramp is being used at the boat ramp.

Judge Rathmell added that lake levels are now below conservation levels. México is behind on the water treaty water release.

Commissioner Garza suggested that children be current with immunization requirements.

Judge Rathmell stated that preliminary appraisals for 2024-2025 indicate substantial loss in valuations. There is less money coming in. Fund balance is almost depleted. He anticipates 15 - 20% budget cuts across the board.

Commissioner Mendoza added that ARM Ordinance will help, but most game room establishments are closed.

Christopher Davila approached the court and introduced himself. He is a local engineer, moved back to Zapata. He is available for event and city planning.

PUBLIC PARTICIPATION

Becky Gutierrez, Olga V. Figueora Library Librarian, informed the court that there are 120 applicants for the summer reading program. The program will be open June 3 – June 27, Monday – Thursday.
