# MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY HON. MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF COMMISSIONERS COURT PLEDGE OF ALLEGIANCE

### **COMMUNICATIONS**

Commissioner Solis thanked the Fire Department and Gabby Gonzalez for their assistance at a structure fire at South Siesta Shores after a propane tank exploded.

Judge Rathmell commented that Operation Lone Star reimbursement is up to date. Application for 2025 grant has been submitted; we will know more before the new budget. He added that a Hyper-Reach Anywhere app would soon be available.

Commissioner Solis encourage everyone to use the Hyper-Rech Anywhere app.

### ORDER APPROVING INVOICES

### TAX / ASSESSOR COLLECTOR'S REPORT

Tax Assessor/Collector's office reported Hotel-Motel tax collections in the amount of \$10,338.85 for the month of May with a year—to-date total of \$86,793.99. Net collections were \$248,417.94 with tax collections at a rate of 85.38%.

# ORDER APPROVING US OF DPS OFFICE AND PORTABLE OFFICE TRAILER TO PROVIDE FORENSIC INTERVIEWS AND THERAPY SERVICES IN ZAPATA

Mr. Gonzalez, Premier Engineering, reported that contractor commenced work. Foundation ring for ground storage tank has been installed. They have done clearing of land, placed 2-6x6 connections and 2-6x6 T's and 3-6" gate valves.

# ORDER APPROVING PAYMENT OF INVOICE AND STATUS REVIEW FOR MIRAFLORES PARK IMPROVEMENTS

Motion was made by Commissioner Mendoza, seconded by Commissioner Solis, to approve payment of invoice in the amount of \$27,491.01 for Miraflores Park Improvements as requested by Manuel Gonzalez, Jr., Premier Engineering.

Mr. Gonzalez reported that the Miraflores Park Improvements Project has been completed, including playground equipment and Bermuda grass. Ribbon cutting date is to be announced.

The above motion, being put to a vote, was approved by the affirmative vote of all members of the Court.

# ORDER APPROVING PAYMENT OF INVOICE AND STATUS REVIEW FOR TXDOT PAVING PROJECT RAMIREZ, PELICAN, AND MIRAFLORES

Motion was made by Commissioner Mendoza, seconded by Commissioner Solis, to approve payment of invoices for a total amount of \$30,763.24 for the TxDOT paving project Ramirez, Pelican, and Miraflores as requested by Manuel Gonzalez, Jr., Premier Engineering.

Mr. Gonzalez reported that this project has been completed. Ramirez street has been paid out. Pelican Street is pending \$15,041.76 and Ramirez Street is pending \$15,721.48 for a total of \$30,763.24.

# ORDER AUTHORIZING COUNTY JUDGE TO ENTER INTO TAX ABATEMENT AGREEMENT WITH IGNIS TEXAS SOLAR THREE, LLC

Motion was made by Commissioner Solis, seconded by Commissioner Garza, to authorize County Judge to enter into a Tax Abatement Agreement with Ignis Texas Solar Three, LLC, pending review by County Attorney, as requested by Jeff Snowden, Capex Consulting. Road and Bridge are exempt from Tax Abatement, a one-time \$50,000 donation will be made to Boys and Girls Club.

# ORDER AUTHORIZING COUNTY JUDGE TO ENTER INTO TAX ABATEMENT AGREEMENT WITH FALCON BESS, LLC

Motion was made by Commissioner Solis, seconded by Commissioner Garza, to authorize County Judge to enter into a Tax Abatement Agreement with Falcon BESS, LLC, pending review by County Attorney, as requested by Jeff Snowden, Capex Consulting. Road and Bridge will have full tax benefits.
