MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK FOR COMMISSIONERS COURT INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Commissioner Solis announced that school bus stop structures will be commenced soon. Each structure will measure 12' x 4', featuring a roof and concrete foundation, but no bench. Planned locations include Monterrey Lane, Pharr Lane, Ann Drive, Lake Front Lodge, and Cardinal Street.

Commissioner Morales noted that the circus was in town last week and saw a good turnout. Commissioner Garza reported that hunting season has begun, with a hunter dedication course scheduled for October 12.

Commissioner Morales added that a 10-acre ordinance is in effect, prohibiting the discharge of weapons on properties smaller than 10 acres

ORDER APPROVING INVOICES

ORDER APPROVING PAYMENT OF SPONSOR'S SHARE FOR TXDOT AIRPORT RUNWAY PROJECT

Motion was made by Commissioner Solis, seconded by Commissioner Garza, to approve payment of the Sponsor's share for the TxDOT Airport Runway Project, in the amount of \$33,399.00 out of Airport Enterprise Fund as requested by Ramon Montes, Airport Director.

ORDER APPROVING REQUEST TO USE ZAPATA COUNTY FAIR GROUNDS FOR FUNDRAISING HALLOWEEN EVENT

Motion was made by Commissioner Solis, seconded by Commissioner Morales, to approve request to use the Zapata County Fair grounds on October 24-31, 2024, for a fundraising Halloween event as requested by Nina Gutierrez, Parent Sponsor.

ORDER APPROVING REQUEST TO USE GRASSY HILL AT HIGHER TECHNOLOGY CENTER FOR DISPLAY OF CHRISTMAS FUNDRAISING DECORATIONS DURING MONTH OF DECEMBER

Motion was made by Commissioner Solis, seconded by Commissioner Morales, to approve request to use the grassy hill at the Higher Technology Center for the display of Christmas fund raising decorations during the month of December as requested by Nina Gutierrez, ZCFA Queens Contest.

ORDER APPROVING TO MOVE FORWARD WITH SUBMISSION OF WATER SMART DROUGHT RESPONSE PROGRAM GRANT APPLICATION ON BEHALF OF ZAPATA COUNTY TO SUPPORT A HYDROPANEL DRINKING WATER PROJECT IN DOLORES SUBDIVISION

Motion was made by Commissioner Solis, seconded by Commissioner Morales, to approve to move forward with submission of a Water SMART Drought Response Program grant application on behalf of Zapata County to support a hydropanel drinking water project in Dolores Subdivision, the county match is \$23,000. Approximately 50 homes would be serviced at no cost to the homeowner for the first 5 years, as requested by Fernando Ferreyra, SOURCE Global.

David Hersey made a presentation of SOURCE Global Water Smart proposal.

The above motion, being put to a vote, was approved by the affirmative vote of all members of the Court.

STATUS REVIEW OF FIRE STATION PROJECT

Manuel Gonzalez, Premier Engineering, reported on the Fire Station Project. He brought in plans; plans are at 90% completion. Plans will be reviewed before going out for bids. They include sleeping quarters, showers, dining room, offices, private quarters for females, storage, additional restrooms, waiting area, and training room. The project will also include generators for both fire station and EOS. The building will be facing Highway 16. No report was submitted for the record.

STATUS REVIEW OF SHERIFF'S OFFICE PROJECT

Manuel Gonzalez, Premier Engineering, reported on Sheriff's Office project. He brought in updated plans for review. County match is \$540,000.00. No report was submitted for the record.

ORDER APPROVING CHANGE ORDER NO. 1 AND APPROVAL OF PAYMENT OF INVOICES FOR SAN YGNACIO WATER PLANT PROJECT

Motion was made by Commissioner Solis, seconded by Commissioner Garza, to approve Change Order #1 for amount of \$92,000.00 and to approve payment of invoice from Mouflon Oilfield Services for \$60,000.00 (\$30,000 pump order and \$30.,000 pipe replacement) for San Ygnacio Water Plant project as requested by Manuel Gonzalez, Jr., Premier Engineering.

The above motion, being put to a vote, was approved by the affirmative vote of all members of the Court.

STATUS REVIEW OF NORTHWEST BOOSTER PROJECT

Manuel Gonzalez, Premier Engineering, reported on Northwest Booster Project. Material was received for fencing and pump room. Will give update at the October 1 board meeting. No report was submitted for the record.

ORDER APPROVING CDBG DRAINAGE PLANS AND SPECS TO GO OUT FOR BIDS

Motion was made by Commissioner Solis, seconded by Commissioner Morales, to approve CDBG Drainage Plans and Specs to go out for bids as requested by Manuel Gonzalez, Premier Engineering.

Mr. Gonzalez reported that some items have been revised. They will be working on channel beginning to end. Existing easement will be used. They will use county crews to do cleaning. Plans were presented for review. No report was submitted for the record.

ORDER APPROVING PAYMENT OF INVOICE FOR JAIL REPAIRS

Manuel Gonzalez, Premier Engineering, reported that project is 50% complete; eight cells have been repaired. Six cells and five doors have been reviewed for repairs.
