ORDER APPROVING INVOICES

Motion was made by Commissioner Solis, seconded by Commissioner Garza, to approve invoices from September 20-October 10, 2024, in the amount of \$899,546.55 as presented by Triunfo Gonzalez.

UPDATE OF USDA FOOD PROGRAM BY RAMIRO HERNANDEZ

Ramiro Hernandez provided an update on the USDA food program, sharing efforts to expand local support. He is working to bring two new programs to Zapata and is exploring grant opportunities to fund these initiatives.

The program has already served 363,600 meals to students, with meals available at multiple locations, including San Ygnacio, the library, the pavilion, Siesta Shores, Lopeño,

and the recreation center. Meal preparation takes place at a facility on Highway 16, and Mr. Hernandez also owns a mobile trailer that meets all necessary standards for food service.

While the pavilion remains an option for meal distribution, it may only be used when events are not scheduled. Mr. Figueroa will speak with Mr. Villarreal to explore the possibility of using the Lions Club as an additional venue. In an effort to avoid conflicts, Mr. Hernandez has decided to step away from using the pavilion.

Meals are provided on Monday, Tuesday, and Wednesday to children ages 1-18, or older if they have disabilities.

ORDER TO TABLE REQUEST BY JUDGE RATHMELL ON HIRING OF ZAPATA COUNTY CHIEF FINANCIAL OFFICER (CFO)

Motion was made by Commissioner Solis, seconded by Commissioner Garza, to table request by Judge Rathmell on hiring of a Zapata County Chief Financial Officer (CFO). This individual will serve in the capacity of Chief Financial Officer for the county, with responsibilities to include overseeing the financial operation of the county, nearing compliance with state and federal regulations, managing the County budget, supervising financial reporting, and providing fiscal recommendations to the Commissioners Court. Judge Rathmell commented on audit findings; he stated that there were time sheet discrepancies, earning statement discrepancies, hours worked and submitted time sheets and inventory issues, among other issues.
