## ORDER APPROVING PURCHASE OF PUMPER/TANKER FROM METRO FIRE APPARATUS SPECIALISTS, INC.

Motion was made by Commissioner Solis, seconded by Commissioner Morales, to approve the purchase of a Pumper/Tanker from Metro Fire Apparatus Specialists, Inc. for \$398,000.00. Funding will come from the Texas A&M Forest Service 2604 Grant, which is \$250,000.00. Remaining amount will be financed, not to exceed \$200,000 as requested by Fire Chief Daniel D. Arriaga from the Fire Department.

## ORDER APPROVING PAYMENT OF INVOICE FROM RAMIRO SANCHEZ FOR REPAIRS TO PUBLIC LIBRARY

Manuel Gonzalez reported that the project is about 90% complete. No report was submitted for the record.

### REVIEW STATUS ON ZAPATA DRAINAGE PROJECT

Manuel Gonzalez reported on the Zapata Drainage project: the contractor is ready. The area has been cleared, but a sewer line was found 3 feet deep. Dewatering will occur at night, likely resulting in a boil water notice. No report was submitted for the record.

## ORDER APPROVING PAYMENT OF INVOICES AND REVIEW STATUS ON LOS EBANOS WALKING TRAIL

Motion was made by Commissioner Solis, seconded by Commissioner Garza, to approve payment of Inv. #28403 for \$7,500.00 and Inv. #27298 for \$2,500 payable to Premier Engineering

for work performed at Los Ebanos Walking Trail as requested by Manuel Gonzale, Jr., Premier Engineering.

Manuel Gonzalez announced that all project bids were rejected due to discrepancies and will be rebid separately.
