EXHIBIT A

SCOPE OF WORK

The County of Polk is seeking to enter into an Administrative service contract with a state-registered administrator. The following outlines this request for proposal.

Funding Services

Respondent must be able to perform the tasks listed here in to be considered eligible for an award under this Solicitation. Respondents should provide a detailed narrative of their experience as it relates to each of the items below. Respondents should clearly indicate if they intend to provide services in-house with existing staff or through subcontracting or partnership arrangements. Administrative Services will be provided in conformance with the guidance documents and use forms provided by the recipient utilizing U.S. Department of Treasury and TDEM guidance.

The provider will work with the recipient and engineer, if applicable, to provide the concise information needed for project designs through each project completion, funding report submissions and other ARP related documents.
