The County of Polk is seeking to enter into a services contract with well qualified engineering service provider(s) to assist the County in the management of a portion of its American Rescue Plan of 2021 allocation activities, funded through the U.S. Department of Treasury to be administered by TDEM and/or other state agency.

SCOPE OF WORK

The County of Polk is seeking to enter into an engineering/architectural service contract with a state-registered engineer. The following outlines this request for qualifications.

DESCRIPTION OF SERVICES AND SPECIAL CONDITIONS

Respondent must be able to perform the tasks listed here in order to be considered eligible for an award under this Solicitation. Respondents should provide a detailed narrative of their experience as it relates to each of the items below. Respondents should clearly indicate if they intend to provide services in-house with existing staff or through subcontracting or partnership arrangements. Engineering Services will be provided in conformance with the guidance documents and use forms provided by the recipient utilizing U.S. Department of Treasury and TDEM guidance. The providers shall furnish funded engineering services to complete the water and sewer infrastructure projects, including, but not limited to the following:

- Improvements to drinking water infrastructure
- Building or upgrading facilities and transmission
- Storage system installation or repair
- Replacement of water lines
- Generator installs and repairs
- Facilitate water reuse
- Construct publicly owned water treatment infrastructure
- Manage and treat stormwater or subsurface drainage water

Funding Services

The provider will work with the recipient and Administrator, if applicable, to provide the concise information needed for project designs through each project completion, funding report submissions and other ARP related documents.

Engineer will complete infrastructure, and eligible projects approved for disaster recovery funding. The selected engineering firm must follow all requirements of the U.S. Department of Treasury for the Coronavirus State and Local Fiscal Recover Funds.
