Honorable Judge Ramos, City Mayor Pro-tem Aaron Trevino, Estella Anzualda, Board Member, Adrian Reyes, School Board President, Jordan Garcia, Board Member, Marty Cabrera, City Councilman, Dr. Casas, Superintendent, Erica Woodruff, BEHOLD, Ann Awalt, CACOST, Marissa Utley-Trevino, Martin Cuellar, VFW member, Nikki Alviar-Garcia, CACOST addressed the Court with ideas on the above matter.

Honorable Judge Eric Ramos addressed the Court on the above matter; Brooks County will be receiving 1,375,000.00, Brooks County ISD will be receiving \$8,500,000.00 and the City of Falfurrias will be receiving \$1,049,000.00, and in picking 5 project that is out of reach and benefits the Community in some away which is agreed upon all 3 entities. Judge Ramos addressed to the Court, City and the Board with a quick presentation on the needs of these 5 Project. Adrian Reyes, School Board President agreed with Judge Ramos in choosing projects and them coming back to choose the one they want as a whole, but would need to agree by next week, since Congressman Gonzalez wants to do the project soon.
