Dr. Armando O'Cana, Mayor of Mission, Texas addressed the Court on the above matter, stating that this interlocal agreement is asking to do a feasibility study in order to do right of ways. It was discussed that this train project (passenger/freight) will be to build a train station in our County making this a 3-nation connection. The intent is to start construction in 2025 and to be completed by 2027, making Brooks County a stop either towards Hebbronville or Alice. Judge Ramos had a question on the agreement, in reference to it reading that the County would accrue some cost. Dr. Armando O'Cana stated that this would be at no cost to the County, any cost would be covered by the City of Mission. Honorable Judge Eric Ramos read resolution in open Court.
