I, THE DEFENDANT NAMED ABOVE, understand that the Court may establish any period of deferral, aka "probation", from 1 to 180 days in length; and, that the Court may stipulate additional condition(s) during a period of deferral.

I, THE DEFENDANT NAMED ABOVE, understand that if I am UNDER (25) TWENTY-FIVE YEARS IN AGE, that I will be required to complete a driver safety course as an additional condition for this requested deferral.

I, THE DEFENDANT NAMED ABOVE, understand that my FINE amount is suspended if this request is approved (meaning that I will not pay a fine); and, that the Court shall assess a SPECIAL EXPENSE FEE in lieu of a fine. In the event of a final conviction, then the special expense fee shall convert to the fine. The minimum, total amount due will be at least \$250, which includes court costs and a special expense fee. The Court shall determine what my total amount will be for this deferral. Payment of the total amount, determined and required by the Court, shall be due and payable, immediately upon approval of this, my, request.
