District Clerk Michelle Pitcox and Justice of the Peace Maggie Sawyer spoke to the court stating the budget had already been adopted with a 3% raise across the board and any change to affect just a few was not good and would cause more harm within the County. Bills for September 23, 2019 were approved with Commissioner Behrens making the motion and Commissioner Kemp seconded. - The court approved the Proclamation for National 4-H week on October 6-12, 2019 with Commissioner Quinn making the motion and Commissioner Behrens seconded. All in favor motion carried 5-0
- Dale Pearce came to the Court to request monies from the Sheriff's Auction be designated to purchase a highspeed Buffer, Tornado Auto Scrubber and Vacuum for floor maintenance. Commissioner Deans made the motion with Commissioner Kemp seconded. All in favor motion carried. 5-0
- The Court approved the K-9 MOU between the McCulloch County Sheriff's office, McCulloch County, and McCulloch County Deputy Bryon Cervantez. Deputy Cervantez owns the K-9. We will provide insurance, medical and food for the K-9 officer. Commissioner Behrens made the motion with Commissioner Deans seconded. All in favor motion carries. 5-0
- 4. Interlocal Agreement for Jail Services with Burnet County was discussed and approved with cost going up from \$40.00 to \$45.00 per inmate. Commissioner Quinn made the motion and Commissioner Behrens seconded. All if favor motion carried. 5-0
- Commissioner Deans came to court to get line item adjustment of \$3,500 from materials to balance for FY 2018-2019. Commissioner Behrens made the motion with Commissioner Kemp seconded. All in favor motion carried. 5-0
- McCulloch Soil and Water Conservation District #249 requested \$5,000.00 for maintenance of the 2 flood prevention sites. The Court approved with Commissioner Quinn making the motion and Commissioner Deans seconded. All in favor motion carried. 5-0
- 7. The Court approved the renewal contract option 2,B with West Texas Rural Counties Association for property coverage for Wind and Hail Deductible for 2019-2020.

- Commissioner Kemp made the motion with Commissioner Behrens seconded. All in favor motion carried. 5-0
- 8. The Court approved the budget amendment to accept revenue from Richards Memorial Library Association in the amount of \$7,225.00 for donation of auto front door. Commissioner Behrens made the motion with Commissioner Quinn seconded. All in favor motion carried. 5-0
- 9. Consider and act on approving job distinctions for Assistant 1 and 2 with established pay rates at the McCulloch County Library had no action taken at this time.
- 10. Consider and act on line item adjustment within library 2019-2020 FY to allow for new job title to be given to 2 employees at the McCulloch County Library had no action taken at this time. Revisit at a later date with new employee handbook and packets of job descriptions and duties.
- 11. The court discussed the wrecked Veteran's Van damage and if County need to continue with insurance on vehicle or drop and accept insurance money in the amount of \$3500.00. The court approved to send letter to Veterans representative stating we will no longer carry insurance. Commissioner Quinn made the motion with Commissioner Deans seconded. All in favor motion carried. 5-0
