KNOW BEFORE YOU GO

- The Courthouse is open 8:00am-12:00pm and 1:00pm-4:30pm, Monday thru Friday.
- The application process takes 20-30 minutes per applicant. Take this into account when planning your arrival time.
- Friday afternoons and school holidays are peak periods with some waiting. Please plan accordingly.
- Passport application processing is done on a first come, first serve basis.
- Bring your completed application, all proper documentation and fees with you to process your application. (2 payments per application)

Current Processing Times (excluding mail time)

- Routine: 6-8 Weeks
- Expedite (Additional \$60 fee): 2-3 Weeks

Adult Applications (16 yrs. and older)

- □ Completed DS-11 form
- Original or Certified copy of the long form Birth Certificate; or Naturalization Certificate; and/or Expired Passport
- □ Valid Driver's License
- Check or Money Order to U.S.Department of State
- □ Check or Money Order to Hamilton County District Clerk's Office
- □ Photo for application

Applications for Children (under 16)

- □ <u>Both parents must be present</u> with their driver's licenses
- □ Completed DS-11 Form
- Bring previous passport for minor, if applicable. If no prior passport, Original or Certified Copy of the long form birth certificate; or Naturalization Certificate
- Check or Money Order to U.S.
 Department of State
- □ Check or Money Order to Hamilton County District Clerk's Office
- $\hfill\square$ Photo for application

Adult Applicants (16 years and older)

Passport Card	\$ 30.00
Book & Card	\$160.00

Minor Applicants (under 16)

Passport Book	\$100.00
Passport Card	\$ 15.00
Book & Card	\$115.00

Optional Fee for any passport book: Expedite Fee \$60.00

Cash, check or money order for each applicant

Photo	\$15.00
Acceptance Fee	\$35.00

General Information

- Use black ink; no mark throughs or scratch throughs
- Completely fill out the application. Failure to do so could cause the Department of State to reject your application.
- Do not sign the signature section
- Each application will need a separate check to U.S.D.S.
- For each applicant, there will be a payment to Hamilton County District Clerk's office
- Photos can be done at another facility and brought in, or we can do them in our office
- U.S. Birth Certificate, Long Form required Hospital birth certificates, notarized copies and photocopies are <u>not acceptable</u> to the Department of State.
