



NOTICE OF FORECLOSURE SALE


4. *Terms of Sale.* The sale will be conducted as a public auction to the highest bidder for cash. 

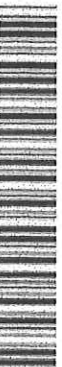
