The Last Will and Testament of Decedent is not self-proved or the self-proving affidavit does not comply with the requirements for a self-proved will required by Chapter 251 of the Texas Estates Code.

No children were born to or adopted by Decedent after the making of Decedent's will.

Decedent was previously married to DANNY VILLARREAL and the marriage ended in divorce on or about on 1976. Decedent married Applicant on Jan. 20, 1988 and was married to
