**APPLICATION FOR LETTERS OF ADMINISTRATION**

BRITTANY MARIE PRESCOTT ("Applicant") furnishes the following information to the Court concerning the Estate of ROBERT ALAN PRESCOTT, Deceased ("Decedent") and for issuance of letters of administration to Applicant:

1. Applicant is an individual interested in this estate, domiciled in and residing at 15 Harwood Drive, Danbury, Connecticut 06810, is entitled to letters of administration, is not disqualified by law, and is Decedent's daughter. The last three numbers of Applicant's driver's license number are 225, and the last three numbers of Applicant's Social Security number are 091.
2. Applicant will appoint a resident agent in the State of Texas.
3. Decedent died intestate on December 26, 2019 in Tacloban City, Leyte, Philippines, at the age of 67 years. The last three numbers of Decedent's driver's license number are 936, and the last three numbers of Decedent's Social Security number are 669.
4. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence in this county on the date of death.

5. Decedent owned personal property described generally as his residence (not affixed to the land), cash, securities, household goods and personal effects of a probable value in excess of \$200,000.00.

6. The name and address, whether the heir is an adult or a minor, and the relationship to Decedent of each heir is as follows:

8. Decedent's first marriage was to CATHY SAHLIN. Decedent and CATHY SAHLIN divorced on November 10, 1976. Decedent's second marriage was to SUSAN NAPOLITANO. Decedent and SUSAN NAPOLITANO divorced on April 5, 1983. Decedent's third marriage was to BRENDA PRESCOTT. Decedent and BRENDA PRESCOTT divorced on September 6, 2002. Decedent's fourth marriage was to LARYSA Y. KOSYNSKA. Decedent and LARYSA Y. KOSYNSKA divorced on November 9, 2017. Decedent was purportedly

married at the time of his death to LERMA B. CABREZA. However, that purported marriage did not occur in the State of Texas or in the United States. LERMA B. CABREZA has never traveled to the United States. LERMA B. CABREZA is a citizen of the Philippines. Some evidence of a marriage between the Decedent and LERMA B. CABREZA has been furnished to the Applicant, but the evidence is not sufficient to verify that a marriage existed between Decedent and LERMA B. CABREZA. In acknowledging the possibility that Decedent and LERMA B. CABREZA were married at the time of his death, Applicant does not admit that a valid marriage existed that would be recognized in the State of Texas. Applicant reserves her right to request that a court void or disregard the purported marriage if sufficient evidence of a legally valid marriage does not exist, or if the Decedent did not have the mental capacity to consent to the marriage or understand the nature of the marriage ceremony, if a ceremony occurred. LERMA B. CABREZA's name is included in this Application as a putative heir solely to comply with the requirements of Section 301.052 of the Texas Estates Code, and is not included as an acknowledgment or admission that LERMA B. CABREZA is a legal heir of Decedent.

9. A necessity exists for the administration of this estate.

Applicant prays that citation issue as required by law to all persons interested in this estate; that Applicant be appointed administrator of this estate; that letters of administration be issued to Applicant; that appraisers not be appointed; and that all other orders be signed as the Court may deem proper.
