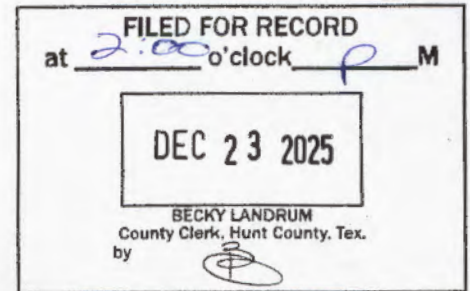

**IN THE COMMISSIONERS COURT
OF
HUNT COUNTY, TEXAS
ORDER REVISING ELECTION PRECINCTS**



BE IT REMEMBERED, that on the 23 day of December, 2025, the Commissioners Court of Hunt County, Texas, after providing notice pursuant to Chapter 551, Texas Government Code, adopted the attached revised boundaries for certain of its Election precincts, pursuant to Chapter 42 of the Texas Election Code.

WHEREAS, during the 89th Legislature, 2nd Called Session, the Texas Legislature approved House Bill 4 relating to the composition of the districts for the election of members of the United States House of Representatives from the State of Texas, CONGRESSIONAL DISTRICTS – PLANC2333. This legislation was approved by the Texas Senate and the House of Representatives and signed into law by the Governor on August 29, 2025. The provisions of House Bill 4 changed the congressional district boundaries within Hunt County, requiring realignment of certain election precincts in Hunt County.

WHEREAS, the 89th Legislature, 2nd Called Session, adjourned on September 4, 2025.

WHEREAS, House Bill 4 did not receive a vote of two-thirds of all members elected to each house; therefore, House Bill 4, the composition of the districts for the election of members of the United States House of Representatives from the State of Texas, CONGRESSIONAL DISTRICTS – PLANC2333, takes effect on the 91st day after the last day of the legislative session, December 4, 2025.

WHEREAS, pursuant to the provisions of Chapter 42, Texas Election Code, the Commissioners Court hereby approves the following realignment of the following County Election Precincts:


Election Precincts (Old)	Election Precinct (Change)	Reason for Change
319	318	In order to comply with Chapter 42 of the Texas Election Code and the CONGRESSIONAL DISTRICTS – PLANC2333; House Bill 4 from the 89th Legislature, 2nd Called Session, portions of Original Precinct 319 are required to be moved and combined with existing Precinct 318. <i>See attached maps.</i>
323	325	In order to comply with Chapter 42 of the Texas Election Code and the CONGRESSIONAL DISTRICTS – PLANC2333; House Bill 4 from the 89th Legislature, 2nd Called Session, portions of Original Precinct 323 are required to be moved and combined with existing Precinct 325. <i>See attached maps.</i>




NOW, THEREFORE, IT IS HEREBY ORDERED THAT:



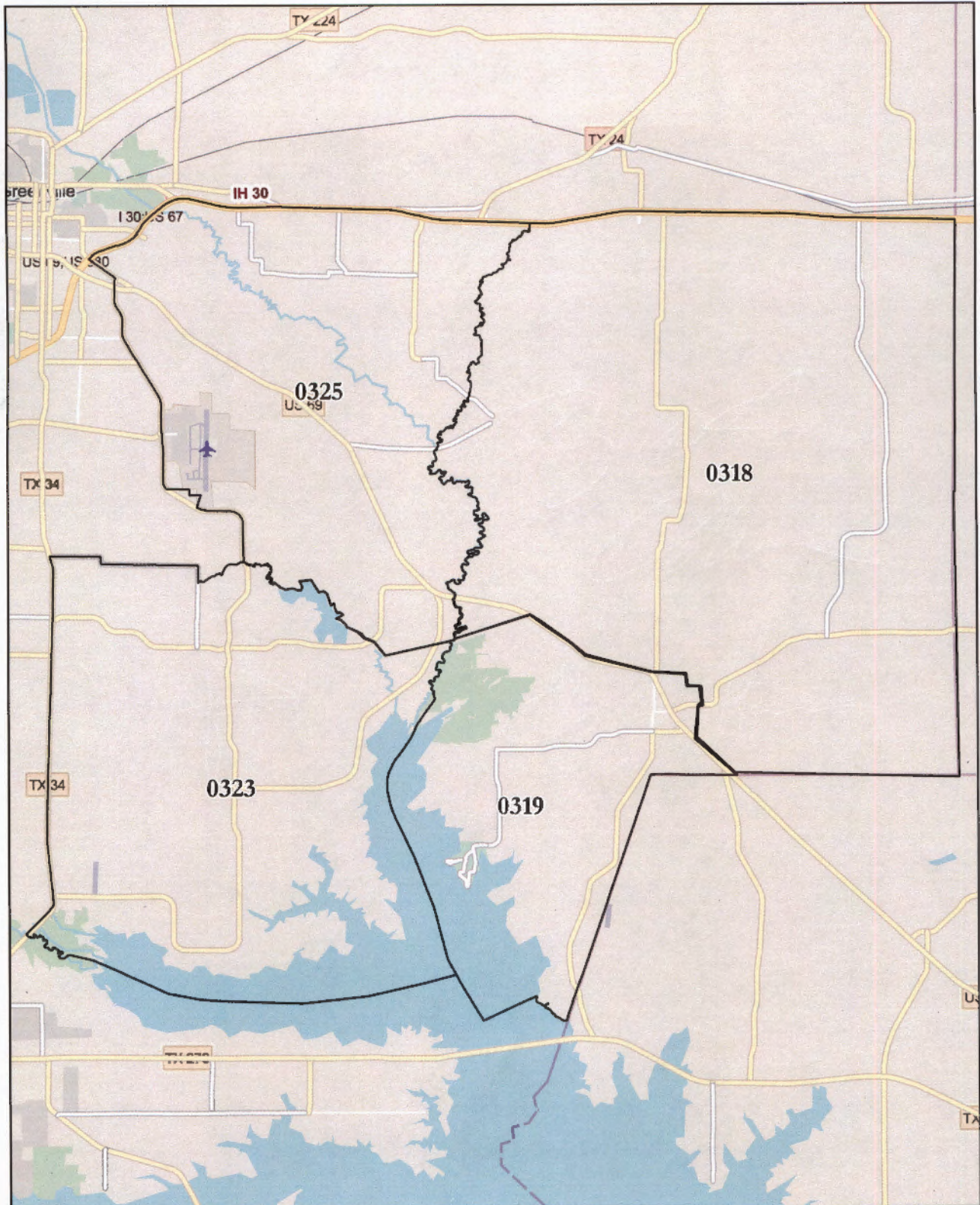



Commissioner, Precinct 2
