#### MILAM COUNTY ARES NEWS

In last month's newsletter I mentioned possible changes coming to the West Gulf Division's ARES organization. Since that time we have had a few changes in E.C.'s for some of the counties in STX. We also have a few changes in requirements for being in ARES and being qualified to help in

an actual emergency for you local ARES group.

One of the big changes is that ICS-300, and ICS-400 are no longer required classes for being an E.C. for ARRL, as well as being an active member of an ARES group. So if you have 100, 200, 700, and 800 you are practically finished with the basic requirements for being an ARES member.

The other big change is that all Officers, that are below the Section Manager, either appointed or elected, the SEC, DEC's, and all EC's in ARRL STX will be required to resign their current positions in the very near future and then reapply for the same position if they wish to continue in that position. If you wish to reapply you will need references, and list your qualifications. If you do not meet the requirements, you will not be allowed to obtain your old position. And they will look at other candidates, if there are no other applicants for that position it will either not be filled at that time, or if that position is an EC that position may be consolidated under another EC. For which that EC will now just have another county to manage.

The reason I mention this to you is that with Milam County having no hospitals, and so few active hams in the county the requirements for being an ARES member have become even easier. So with that being said, I expect more licensed hams in Milam County to not only sign-up on the ARRL STX Depot site for Milam County ARES, but to also become more active on the local nets.

As of the writing of this newsletter there are several big changes coming to Milam County. Just a few months ago the Milam Amateur Radio Club put on air the first of hopefully a few Yaesu C4FM Fusion repeaters in Milam County. It is not connected to WIRES-X, yet, but the club is making big strides to move Milam County into the 'new' digital era. There are other changes coming that I can't mention right now, but they are coming in the very near future.

It is approximately 150 feet AGL.
