mentioned time and place by filing a written answer contesting such application should they desire to do so.

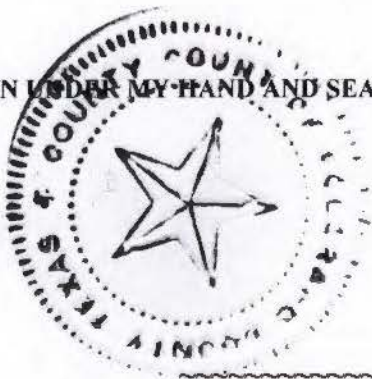
All interested persons are further advised that they have the right to employ an attorney and that if they or their
