The group presented petition sheets containing 111 approved signatures, a descripton of the proposed boundaries, a Resolution signed by the City of Shamrock and a statement from two petitioners stating they will be obligated to pay not more than \$150.00 of the costs associated with the formation of the proposed district, inclduing the costs of publishing notices, election costs, and other necessary and incidental expense.
