**1. Restoration of Roadway**

Applicant shall repair the roadway to the condition that existed before commencement of the work on the roadway and;

**2. Indemnification**

Applicant agrees to indemnify and hold harmless Crane County from any and all losses, damages, liabilities, expenses, or costs resulting from actions, suits, or proceedings arising out of or related to the work performed by the Applicant, its agents, employees, contractors, or subcontractors.

**3. Future Road Work**

If it becomes necessary to widen the county roadway after the date of this agreement, the Applicant shall be fully responsible for any and all costs associated with adjusting, lowering, deepening, or casing the pipeline to accommodate such changes.

**4. Sinking or Settlement Repairs**

If any portion of the roadway previously cut by the Applicant settles, sinks, or becomes damaged within five (5) years of repair, the Applicant will be held responsible for any and all associated repair costs. If repairs are not completed in a timely manner, Crane County reserves the right to perform such repairs and bill the Applicant accordingly.

**5. Notice Before Commencing Work**

No work may commence under this permit until **the Applicant receives written approval**. The Applicant must notify the County Road & Bridge Supervisor, Brandon Graham, at **432-220-1962** at least **24 hours** before beginning any work.
