The Board of Directors of the Post Oak Savannah Groundwater Conservation District will hold a public hearing in the Post Oak Savannah Groundwater Conservation District Offices, 310 East Avenue C, Milano, Texas 76556, on Tuesday, September 10, 2019, at 5:30 P.M., for the purpose of receiving public comments on the following applications for amendments to existing permits.

Notice is hereby given of the following public hearing that will be held at the time and place listed above on the following applications, to-wit:

Amendment to Operating Permits. Burlson Sand, LLC, 6100 North Western Avenue, Oklahoma City, OK 73118, submitted an application on June 17, 2019 for amendment to two Operating Permits for water wells to produce less than or equal to 250 gallons per minute each, with total production for each well not to exceed 360,000 gallons per day and 400 acre feet per year, to be used for Industrial Use.

These wells are located on the 727.120 acres, more or less, in the Sterling C. Robertson League, Abstract, and the Emelious Savage League, Abstract 218, Burlson County, Texas. These wells are to be located approximately 1400 feet north of Farm to Market Road (FM) 908 approximately 3.5 miles west of State Highway 21. The following provides directions to each well site.

Begin at the intersection of State Highway 21 and FM 908, and go west approximately 3.5 miles on FM 908, and then turn right onto Burlson Sand, LLC property. Well #1 is approximately 700 feet from the south property line, 800 feet from the east property line and 1450 feet from the north property line at 30°30'47.13" N 96°47'50.52" W. Well #2 is approximately 1400 feet from of the south property line and 1500 feet south from the north property line at 30°30'58.2" N 96°47'54.7" W.
