Procedure:

Once the application is received from the requester, a representative of the Coryell County Road and Bridge Department will visit the location and determine the feasibility and timeline for clearing of the right of way.

County Road Fence Line Clearing Requirements:

Coryell County may clear the fence line along Coryell County Roads for an adjacent property owner free of charge. In return, Coryell County requires that:

- 1.) If the property owner elects to rebuild the fence, it will be rebuilt at either the existing fence location or 25' from the centerline of the County Road, whichever is greater.
- 2.) Coryell County will be allowed to rework/rebuild the ditches at the time of the fence R.O.W. clearing to facilitate removal of water from the roadway.
- 3.) The property owner is responsible for disposal of any brush and/or fence in accordance with State and Local regulations. Coryell County will place all materials cleared from the fence R.O.W. on the landowner's property.
- 4.) The requester is responsible for all cost associated with the construction of new fence, and for disposal of all materials cleared from the R.O.W.
- 5.) The requester shall hold harmless Coryell County and its duly appointed agents and employees against any action for personal injury or property damage sustained by reason of the clearing of the R.O.W. hereunder.
