

FIRST AMENDMENT TO TAX ABATEMENT AGREEMENT
Between
HASKELL COUNTY, TEXAS and KING CREEK WIND FARM 1 LLC

This First Amendment to Tax Abatement Agreement (this "Amendment") is entered into by and between Haskell County, Texas (the "County") duly acting herein by and through its County Judge, and King Creek Wind Farm 1 LLC, a Delaware limited liability company (formerly known as King Creek Wind Farm LLC, together with its successors and assigns, "Owner") effective as of the 12th day of July, 2022.

Recitals:

A. Tax Abatement Agreement. The County and Owner entered into that certain Tax Abatement Agreement dated June 23, 2020 (the "Agreement") as approved by the Commissioners Court of Haskell County, Texas (the "Commissioners Court") pursuant to the *Texas Property Redevelopment and Tax Abatement Act*, as amended, providing for a tax abatement in connection with the proposed construction by Owner of Improvements (as defined in the Agreement) consisting of wind powered generation facilities located within the Reinvestment Zone (as defined in the Agreement) with a capacity of at least 38 megawatts.

B. Delay Notice. Owner experienced delays in construction of the Improvements from factors outside of its control and provided notice to the County of such delays and other matters applicable to the Agreement pursuant to that certain letter dated January 20, 2022 (the "Delay Notice"). A copy of the Delay Notice is attached to this Amendment as Exhibit A.

C. Amendment. The County and Owner now desire to enter into this Amendment to confirm the matters set forth in the Delay Notice and certain other matters related to the Agreement.

D. Notice of Action on this Amendment.

i. To Other Taxing Entity. As required by TEX. TAX CODE §§312.402(a-2) and 312.2041 written notice of the date, time and place of the meeting at which the Commissioners Court acted on this Amendment was sent to the presiding office of each other taxing unit in which the property to be subject to the Amendment is located by certified mail, return receipt requested and included a copy of this proposed Amendment not less than 7 days prior to the meeting. A true copy of such notice is attached hereto as Exhibit B.

ii. Posted Notice. As required by TEX. TAX CODE §312.207(c) notice of the meeting which this Amendment was acted upon by the Commissioners Court was posted more than 30 days in advance of such meeting at the Haskell County Courthouse and on the internet website maintained for the County by the Texas Association of Counties as required by Chapter 551, Texas Government Code. Said posted notice contained the information required by TEX. TAX

CODE §312.207(c). A true copy of such notice certified by the County Judge is attached hereto as Exhibit C.

E. Adoption of Amendment Approved at a Regularly Scheduled Meeting. This Amendment was approved at a regularly scheduled meeting of the Commissioners Court, as required by TEX. TAX CODE §312.207(a).

F. Quorum. A quorum of the County Commissioners were present at the meeting at which this Amendment was approved and not less than a majority of those Commissioners present voted in favor of the approval of this Amendment.

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements set forth herein, the parties do hereby agree as follows:

AMENDMENT

1. Approval of Delay Notice. The County hereby approves the Delay Notice and acknowledges that substantial completion of construction of the Improvements occurred by March 31, 2022 as contemplated by the Delay Notice. The County and Owner acknowledge and agree that the Agreement did not terminate and the abatement commenced as of January 1, 2022.

2. Ratification. The County and Owner hereby ratify the Agreement, as amended by this Amendment, and confirm that the Agreement remains in full force and effect in accordance with its terms, as amended by this Amendment.

3. Incorporation of Exhibits. All exhibits attached hereto are incorporated herein. The exhibits attached to this Amendment are:

Exhibit B – Copy of notice to Other Taxing Entities

Dear Judge Thompson:

I am writing to provide an update on our project that is the subject of the Agreement and to request your acknowledgment and agreement to certain matters related to the Agreement as follows.

1. Our project is expected to come on-line in the first quarter of 2022. In that connection, the Project Company experienced delays in construction from factors outside of its control as defined in Section 9.7 of the Agreement, which it has worked to remedy with all reasonable dispatch as required by the terms of the Agreement so that construction was substantially complete with all major activities and connected to the grid electrically by December 31, 2021. For greater clarity, the Project Company requests your acknowledgment on behalf of the County that the date for achieving substantial completion under Section 1.2 of the Agreement has been extended by such delays and that achievement of substantial completion by March 31, 2022 will satisfy the Project Company's obligation to use all reasonable dispatch to remedy such delay.
2. The Project Company provided notice to the County on December 20, 2021 of its election that the Commencement Date for the Abatement Period (as such capitalized terms are defined in the Agreement) begin on January 1, 2022. Accordingly, the Project Company requests your acknowledgment on behalf of the County of waiver of receipt of this election and that such notice constituted, and is valid and effective as, notice of election by the Project Company that the Commencement Date for the Abatement Period will begin on January 1, 2022.
3. The Agreement was executed by the Project Company in its former name, King Creek Wind Farm LLC, because that was its name at the time of the application. This letter will serve as notice to the County of the subsequent change in the name of the Project Company to King Creek Wind Farm 1 LLC and confirm that, notwithstanding the execution and delivery of the Agreement in its former name, such actions were on behalf of and binding upon the Project Company in its new name, King Creek Wind Farm 1 LLC. Please make note of the change in the name of the Project Company in the County's records for this Agreement.





Map


