1. Attached proof of vehicle insurance; waste collections and disposals yearly report, Records of disposal site.
2. Attached certificate of surety bond or non-revocable bank letter of credit, and
3. Check, Cashier's Check or Money Order for \$150.00 **PER** transport vehicle made payable to **POLK COUNTY TEXAS**.

ONLY COMPLETE APPLICATIONS WILL BE ACCEPTED FOR CONSIDERATION

Please read the application carefully. Make special note of the requirements found in the Exhibits of the Application. These provisions are established by order of the Polk County Commissioners Court. Failure to adhere to those requirements will be a violation of the Order, which is a Class C misdemeanor.

Permits must be renewed annually and expire at midnight on September 30 of the year they were issued. Waste haulers not renewing permits prior to October 1 who operate, or continue to operate in Polk County, Texas will be charged with the offense of Operating without a valid permit.

IMPORTANT NOTICE TO ALL WASTE HAULERS IN POLK COUNTY

In compliance with Texas Health & Safety Code, Section 368.012, the Polk County Commissioners Court now requires that all waste haulers operating for compensation in unincorporated areas of Polk County—unless legally exempt—must be licensed and permitted.

Polk County Permit to Transport Grease Trap, Sand Trap, and/or Septic Waste

Key Deadlines

Vehicle Inspection & Permitting Deadline: October 1, 2025

Annual Permit Renewal Deadline: September 15 of each following year

INSPECTION & PERMITTING PROCESS

Submit Applications: to the Environmental Enforcement Office.

Scheduling: The Maintenance Department will arrange your vehicle inspection and notify the Environmental Enforcement Office of the date and time.

Inspection Day: Bring your vehicles in for inspection at the scheduled time with the inspection form already filled out.

Clearance: After inspection, return to the Environmental Enforcement Office to receive written clearance.

Final Step: The Environmental Enforcement Department will provide the official Waste Hauler Permit.

Do certify by my signature below that the operator(s) of the vehicle(s) described on the Drivers Information form and the Vehicle In-Service form will not pick up hazardous, Class I industrial non-hazardous, infectious or any other waste not permitted in a Type I landfill. I further certify that I:

1. Will unload all waste collected on my route only at a state permitted facility;
2. Will retain all receipts and related records for a minimum period of one year.
3. Will provide all receipts upon request to the Environmental Enforcement office when requested.
4. Will pick up waste on my route on a regular basis (to be determined by the applicant), but not more than seven days between pickups;
5. Will maintain my equipment in a clean and sanitary manner to prevent loss of liquid or solid waste;
6. The load shall be fully enclosed and at vehicle speeds exceeding 30 miles per hour shall be completely covered and the covering firmly secured so as to prevent spillage or loss of load;
7. Will promptly remove all spillage of waste resulting from my collection operation;
8. Will promptly remove all spillage of waste that may occur along my collection route during transportation to an approved landfill;
9. Will not store or hold trash or waste on my vehicle(s), trailer(s), property or any other location for more than twenty-four hours except for periods of time during which Polk County Landfill is closed and in such instance said storage shall not exceed forty-eight hours;
10. Will, within twenty-four hours of issuance of license, affix my company name, telephone number and waste hauler license number on both sides of my vehicle(s)/trailer(s) used to transport commercial solid waste in such a way as to be clearly visible at all times. Letters and numbers shall be clearly legible, not in the manner of graffiti, of a height not less than three inches, and of a color sufficiently different from the body of the vehicle so as to be clearly legible from a distance of 100 feet; and
11. Will comply with all applicable state laws and comply with the TCEQ regulations.

NOTE: License fee shall be \$150.00 annually per transport vehicle. Prior to expiration, license will be considered for renewal. Applicant must attach to completed application: check/money order for \$150.00 for license per vehicle and a \$500.00 surety/property bond or non-revocable bank letter of credit and proof of vehicle insurance to the above referenced mailing address or email. All Solid Waste transporters/Haulers must keep records for waste collections and disposals and submit a yearly report with this application. Provide a record of all disposal sites for septic, waste, and landfill.

SEPTIC WASTE TRANSPORTER PERMITTING

Person(s) who plan to transport sewage sludge, water treatment sludge, domestic septage, chemical toilet waste, grit trap waste or grease trap waste. Regulated under this Order shall first apply for registration with the Polk County Environmental Enforcement Office at the address referenced above on forms furnished by Polk County and receive a permit from the Polk County Environmental Enforcement Office prior to commencing operations.

Failure to submit a complete and accurate application or other information requested by the Polk County Environmental Enforcement Office will result in the return of the application to the applicant. Applications for transportation registrations shall include:

1. A complete application form(s);
2. The verified legal status of the applicant(s);
3. The signature of the applicant(s);
4. The attachment of technical reports and supporting data required for the application and; any other information as may be reasonably required by the Polk County Environmental Enforcement Office.

Person(s) who apply to the Polk County Environmental Enforcement Office for registration and receive a permit shall maintain a copy of the registration authorization, as annotated by the Polk County Environmental Enforcement Office with an assigned permit number, at their designated place of business and in each vehicle operated under that registration.

The expiration date of the registration/permit shall be midnight on September of the year in which it was issued. Registrations/permits are required to be renewed annually, prior to expiration date. Application for renewal shall be submitted by September 15 of the year in which the registration/permit expires. Any registrant shall notify the Polk County Environmental Enforcement Office in writing within 15 days of the cessation of operation and request that the registration/permit be cancelled.

1. Change in ownership of the operating entity; or
2. Determination by the Polk County Environmental Enforcement Office that operations or management methods are no longer adequately described by the existing registration/permit.

Transporters shall notify the Polk County Environmental Enforcement Office, in writing within 15 days of the following changes of their operation:

1. The office or place of business is moved or its address or telephone number changes;
2. The name of the operating entity is changed; or
3. A transporter plans to handle a waste not included in the existing registration/permit.

SEPTIC WASTE TRANSPORTER- VEHICLE(S) EQUIPMENT

A. **Marking and identification.** Owners or operators of specially equipped vacuum pump trucks, tanks, or container used for the collection and/or over-the-road transportation of wastes regulated under this application shall affix the decal provided by the Polk County Environmental Enforcement office to the upper center portion of the windshield of each registered vehicle. Said decal is the property of Polk County. Registrant shall immediately remove said decal from vehicles no longer authorized by Polk County, Texas to haul waste, or if ownership of the vehicle is transferred from the person(s) holding registration.

B. **Sanitation standards.** All vehicles and equipment used for collection and transportation of regulated waste shall be constructed, operated, and maintained to prevent loss of liquid or solid waste materials, and to prevent health nuisance and safety hazards to operating personnel and the public, and shall be maintained in a sanitary condition to preclude nuisance conditions such as odors and insect breeding.

C. **Mixing of incompatible wastes.** Mixing of incompatible wastes within the same container is prohibited. Transporters shall not use the same container or pumping equipment to collect or transport incompatible waste without first emptying and cleaning the container and equipment of all previously handled waste. For purposes of the application, incompatible waste, are defined as, wastes which have different processing, storage or disposal requirements. However, transporters may mix wastes with different characteristics provided the facility to which the waste is being transported is authorized to store, process, or dispose of such mixed wastes.

D. **Site gauges.** All closed vehicles, tanks or containers used to transport regulated liquid wastes shall have sight gauges maintained which can be used to determine whether or not a vehicle is loaded and the approximate capacity. Gauges are not required to read in gallons or liters, but shall show what percentage of the tank capacity is filled.

E. **Septage transport.** If the vehicle(s), tank(s), or container(s) are used to transport domestic septage to a beneficial use site, the registrant shall keep records showing how the domestic septage met the pathogen and vector attraction reduction requirements listed 312.82© and 312.83 of Title 30, Texas Administrative Code. Copies of records pertaining to the pathogen and vector attraction reduction requirements shall be maintained on the vehicle(s) for a minimum of one month and at the beneficial use site and transporter office for a minimum for five years.

F. **Discharge valves.** All closed vehicles, tanks, containers used to transport regulated liquid shall prominently mark all discharge valves and ports. All discharge ports shall be visible and readily accessible from the outside of the vehicle. Discharge vales that may be operated from inside the cab of the vehicle are strictly prohibited.

G. Inspection. All transport vehicles shall include, but are not limited to trucks, portable tanks, trailers, barges, or similar transport vehicles/receptacles and are subject to inspection by Polk County, Texas staff at any time and/or location within Polk County, Texas. If a transport vehicle fails the inspection, the Polk County, Texas authorization sticker shall be removed from the vehicle and that vehicle is not authorized to transport waste until the vehicle is re-inspected and passes.

H. Record keeping. Record keeping shall be in accordance with requirements of Rule 312.145 TAC. Failure of a transporter to properly and correctly maintain records, trip tickets, or other documents, or failure of a transporter to submit to the Polk County Permit Office correct information on a report or an application for registration by the required due date, or unauthorized discharges or sewage sludge, water treatment sludge, domestic septage, chemical toilet waste, grit trap waste, solid waste, or grease trap waste shall be sufficient cause for the Polk County Permit office to revoke or otherwise void the transporter's registration and authorization to transport such wastes in unincorporated area of Polk County, Texas

The Polk County Environmental Enforcement Office may also take any other action authorized by law.

An opportunity for a formal hearing on the revocation may be requested by the registrant within 20 days after a Notice of Revocation has been sent from the Polk County Environmental Enforcement Office to the last known address of the registrant. If the registration is revoked or voided, a transporter is prohibited from hauling regulated wastes.

A surety bond, executed pursuant to this Regulation, must comply with the insurance laws of this state.

CRIMINAL PENALTY. Every violation of this Regulation constitutes a separate and distinct offense, and is a Class C misdemeanor, punishable by a fine of not more than \$500.

GROUND S ESTABLISHED FOR SUSPENDING OR REVOKING COMMERCIAL WASTE HAULER LICENSE/PERMIT

1. More than three convictions received for violating any of the provisions of the order or state laws pertaining to litter/solid/septic waste and the Health 7 Safety Code for a period of one fiscal year.
2. In the event that a grievance is filed in a court of law due to the operations of the company.
3. If three times in one year, waste is proven stored in vehicle(s), trailer(s), or on property for more than twenty-four hours except for periods when disposal site is closed.
4. Fine formal complaints during one fiscal year. Complaints must be formal complaints, signed, and dated by the complainant. complaints must be investigated and verified pursuant to the formal complaint.
5. Vehicle(s) not having insurance and registration or inspection during term of permit.
6. If found guilty in a court of proper jurisdiction for disposal of regulated waste at a site that is not a state approved solid waste site.
7. Permit holder shall not be in arrears for disposal fees at a Polk County Landfill.

Violations listed above will be submitted, along with any evidence, the Board of Review for their consideration. Board of Review will make determination for suspension or revocation of permit.

POLK COUNTY SEPTIC WASTE TRANSPORTER VEHICLE /TRAILER IN-SERVICE INSPECTION GUIDLINE

1. Check for up to date DPS safety stickers.
2. Current TCEQ sticker
3. Waste vessel must be equipped with a site glass or other visual-device, which permits inspection of transported waste. Unless permitted by the US EPA or have a letter from the tank manufacturer stating that a sight glass or tube would compromise the tank integrity.
4. Each vehicle must be sufficiently loaded at least half full in order to check for leakage when inspected. Valves may not leak with the drip cap.
5. The name and local phone numbers be highly visible on both sides of the truck. This can be either the truck doors or tank.
6. The five digit TCEQ on both doors in block letters at least 2" tall.
7. Also inspection of all hatches and valves for leaks. This includes the tank itself for cracks and welded patches will need properly maintained.
