1. Permit Hearing for the following Drilling/Production Permit Application:


- **One (1) new well for Donald Smart (Drilling Permit #2770, Production Permit #2770)** located at N 28.909043, W -97.699226, in Karnes County for Industrial use. The total acreage of the property is 212. The well will produce from the Jasper Aquifer at a proposed depth of 300 ft. The proposed capacity of the well is 200 GPM. Total maximum annual production from the well will be 241.84 acre feet.
- **One (1) new well for Mike Pawelek (Drilling Permit # 2771, Production Permit # 2771)** located at N 28.995162, W -97.852828, in Karnes County for Irrigation use. The total acreage of the property is 137.2. The well will produce from the Yegua/Jackson Aquifer at a proposed depth of 350 ft. The proposed capacity of the well is 100 GPM. Total maximum annual production from the well will be 91.46 acre feet.
- **One (1) new well for Halff Brothers Ranch (Drilling Permit # 2772, Production Permit # 2772)** located at N 28.904093, W -99.182283, in Frio County for Irrigation use. The total acreage of the property is 19,500. The well will produce from the Carrizo Aquifer at a proposed depth of 1,500 ft. The proposed capacity of the well is 1,200 GPM. Total maximum annual production from the well will be 1,451.04 acre feet.

2. Permit Amendments on Existing Wells:

- **One (1) Amendment for Ectero (Drilling Permit #2120, Production Permit #2120)** located at N 29.05921, W -97.79949, in Karnes County. The total acreage of the property is 350.10. Original acreage was 288.20. New allotment will be 1,050.30 acre feet.
