Notice of Foreclosure Sale

1. Property to be Sold. The Property to be sold is described as follows: (including buildings, fences, windmills and tanks, pumps, motors, watering and irrigation equipment and apparatus and any other improvements and fixtures now or later affixed to or used on the described land):

All that certain lot, tract or parcel of land situated in the City of Comanche, Comanche County, Texas, and being part of Lots Nos. 8 and 9, in Block 8, Lakeside Addition to the City of Comanche, Texas as per the plat of said Addition of record in Volume 64, Page 432, Deed Records of Comanche County, Texas, and described by metes and bounds as follows, to-wit:

BEGINNING at a stake on the South line of Paine Avenue, said stake being 10 feet West of the Northwest corner of Lot 10, Block 8, of said addition, same being 351.6 varas West and 354.6 varas North of the Southeast corner of the Railroad Survey, and the Northeast corner of the D. Barnhill Survey;

THENCE West with the South line of Paine Avenue at 40 feet pass the Northwest corner of said Lot No. 9, 58 feet to a stake for the Northwest corner of this tract;

THENCE South 140 feet to a stake for the Southwest corner of this tract;

THENCE East at 18 feet pass the Southwest corner of said Lot 9, 58 feet to a stake for the Southeast corner of this tract, said stake being 10 feet West of the Southwest corner of said Lot 10, Block 8, of said addition;

THENCE North 140 feet to the place of beginning.

Being the same land and premises described in Warranty Deed dated April 21, 1953, from Edward E. Isham, et ux to S. J. Wall, recorded in Volume 274, Page 98, Deed Records of Comanche County, Texas, to which record reference is here made for all purposes.

2. Instrument to be Foreclosed. The instrument to be foreclosed is the Deed of Trust dated November 18, 2024 recorded in Volume 532, Page 352, Deed of Trust Records of Comanche County, Texas.

3. Date, Time and Place of Sale. The sale is scheduled to be held at the following date, time and place:

Date: July 1, 2025

Time: 10:00 am – 1:00 pm

Place: Comanche County Annex located at 204 E. Oak Avenue, Comanche, Texas 76442

The deed of trust permits the beneficiary to postpone, withdraw, or reschedule the sale for another day. In that case, the trustee or substitute trustee under the deed of trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the sate of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code. The reposting or refiling may be after the date originally scheduled for this sale.

4. Terms of Sale. The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the deed of trust permitting the beneficiary thereunder to have

the bid credited to the note up to the amount of the unpaid debt secured by the deed of trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay their bid immediately in cash if their bid is accepted.

The sale will be made expressly subject to any title matters set forth in the deed of trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the deed of trust. The sale shall not cover any part of the property that has been released of public records from the lien of the deed of trust. Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.

Pursuant to the Deed of Trust, the Beneficiary has the right to direct the Trustee to sell the property in one or more parcels and/or to sell all or only part of the property.

Pursuant to section 51.009 of the Texas Property Code, the property will be sold in "as is, where is" condition, without any express or implied warranties, except as to the warranties of title (if any) provided for under the deed of trust. Prospective bidders are advised to conduct an independent investigation of the nature and physical condition of the property.

Pursuant to section 51.0075 of the Texas Property Code, the trustee reserves the right to set further reasonable conditions for conducting the sale. Any such further conditions shall be announced before bidding is opened for the first sale of the day held by the trustee or any substitute trustee.

5. Type of sale. The sale is a nonjudicial deed of trust lien foreclosure sale being conducted pursuant to the power of sale granted by the deed of trust executed by Grantor therein. The real property and personal property encumbered by the deed of trust will be sold at the sale in accordance with the provisions of the deed of trust and as permitted by section 9.604(a) of the Texas Business and Commerce Code.


6. Obligations Secured. The deed of trust provides that it secures the payment of the indebtedness and obligations therein described (collectively, the "Obligations") including but not limited to (a) the promissory note in the original principal amount of \$10,000.00, executed by Esteban Ibarra and Maria Ibarra, and payable to the order of Thomas C. Mazurek III and Patricia Mazurek; (b) all renewals and extensions of the note; and (c) any and all present and future indebtedness of Grantor to Beneficiary. Thomas C. Mazurek III and Patricia Mazurek is the current owner and holder of the Obligations and is the beneficiary under the deed of trust.
