CAUSE OF LOSS

Based on the information collected during our onsite investigation, it is the opinion of HVAC Investigators that the primary cause of loss to 22 HVAC systems is Hail.

The findings of our onsite inspection indicate that 20 HVAC systems sustained minor hail related damages. Of these 20 systems, 17 systems sustained minor surface damages to their condenser coils from the hail impacts. The condenser coils were not punctured in any areas and the coil fins were not torn. Small indentations were present in the top panels for 2 of these systems and the wire fan guards for 13 were bent. Also, the filter screens on 2 sustained damage. Round dents were evident on the exterior ductwork insulation for 3 systems as well. This damage is not affecting the performance of the systems and their metal ductwork was not damaged. No other components showed any visual or measured signs of hail damage.

Our onsite inspection also determined that 2 HVAC systems sustained moderate to severe hail related damages. The systems sustained damages to their condenser coils including flattened fins that cannot be straightened with a fin combing tool. Also, the severity of the hail impacts caused coil fins to tear. Once torn, aluminum coil fins cannot be repaired to pre-loss condition. Small indentations were present in their top panels from contact with hail as well. No other components showed any visual or measured signs of hail damage.

Based on the information collected during our onsite investigation, it is the opinion of HVAC Investigators that **2 HVAC** systems evaluated are Non-Damaged.

The findings of our onsite inspection indicate that 2 systems were not damaged and were operating properly. There was no evidence of hail related damages noted to any of the systems' components. Therefore, no repairs or replacement of the systems are required at this time.

****** RECOMMENDATION

If coverage is afforded, HVAC Investigators recommends that 22 HVAC systems be repaired. Based on the onsite assessment conducted in association with this claim, our findings indicate that repairs would sufficiently restore the HVAC systems and the insured to pre-loss condition. Thus, a full replacement of the HVAC systems is not required.

In our opinion, the minor hail damage to 20 HVAC systems can be repaired. By professionally straightening their condenser coil fins with a fin combing tool, 17 systems can be repaired. Of these 20 systems with minor damage, 2 require

replacement of their top panels and 13 require replacement of their fan guards. Replacement of the exterior ductwork insulation is required for 3 systems and 2 systems need new filter screens. No additional repairs or further actions to the systems are required at this time as these actions will repair all hail related damages.

It is our recommendation to replace the condenser coils and top panels to repair the hail damage to 2 systems and restore to pre-loss condition. After completion of the repairs, system start up and operational testing is recommended to ensure proper performance and maximum efficiency. We have allocated for this testing in our recommended settlement.

Based on the evidence collected during our onsite investigation, it is the opinion of HVAC Investigators that 2 HVAC systems evaluated are Non-Damaged.

Through our onsite evaluation, 2 systems were determined to be unaffected by hail. Therefore, no repair, replacement, or further actions to the HVAC systems are recommended at this time.

Repair and replacement estimates are based on average market rates at the time this report was prepared. Market prices can, and often do, substantially change over time, and therefore these prices are only valid for 30 days from the date of report issuance.

CALDWELL COUNTY, TEXAS DECLARATION OF LOCAL DISASTER PROHIBITION OF OUTDOOR BURNING

WHEREAS, Section §418.108 of the Local Government Code provides that the County Judge can declare a slate of Local Disaster within the county) and order, may prohibit outdoor burning in the unincorporated area of the county when he finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning and,

WHEREAS, the County Judge does find that circumstances present in all of the unincorporated area of the county create a public safety hazard that could be exacerbated by outdoor burning;

BE IT THEREFORE ORDERED, that the following emergency regulations are hereby established for all unincorporated areas of Caldwell County, Texas that are not subject to public ownership or stewardship for the duration of the above mentioned declaration:

I. Action Prohibited:

- (a) A person violates this order if he/she burns an) combustible materials outside of an enclosure, which serves to contain all flame and/or sparks, or orders such burning by others.
- (b) A person violates this order if he /she engages in any activity outdoors which could allow flames or sparks that could result in a fire, unless done in an enclosure designed to protect the spread of fire, or orders such activities by others.

2. Enforcement:

- (a) Upon notification of suspected outdoor burning the tire department assigned shall respond to the scene and take immediate measures to contain or extinguish the fire.
- (b) If requested by a fire official, a duly commissioned peace officer, when available, shall be notified and sent to the scene to investigate the nature of the fire.
- (c) If, in the opinion of the officer investigating and the fire official, the goal of this order can be obtained by informing the responsible party about the prohibitions established by this order the officer may at his discretion notify the party about the provisions of this order and request compliance with it, or issue a citation for: **Violation of Bum Ban Order**.

Therefore it is in accordance with Local Government Code 352.08 I, a violation of this order is a class C Misdemeanor, punishable by a fine not to exceed \$500.00.

- 3. This Order does not prohibit prescribed fire(s) conducted in compliance with guidelines set forth by federal or state natural resource agencies and conducted by a prescribed burn manager certified under Section 153.048 Natural Resources Code, and meets the standards of Section 153.047, Natural Resources Code, burned under a burn plan approved by such agencies, or outdoor burning activities related to public health and safety that are authorized by the Texas Commission on Environmental Quality for:
 - (a) Firefighter training
 - (b) Public utility, natural gas pipeline or mining operations
 - (c) Planting or harvesting of agricultural crops

IT IS FURTHER ORDERED that an exemption be hereby granted for a bona fide commercial land clearing business, allowing said business to burn as long as all other provisions of the Order and applicable laws and ordinances are adhered to as set forth herein, and contact is made and the burning approved by the Caldwell County Emergency Management Coordinator at 1403 Blackjack St. Lockhart, TX at phone Number 512-398-1822, and receiving permission, prior to any outdoor burning.

IT IS FURTHER ORDERED that an exemption be hereby granted to those businesses where welding is an essential function of the business, allowing welding operations to proceed as long as the area of welding operations has been cleared of vegetation for a distance of no less than ten (10) feet in all directions, that there be a second capable person acting as a fire spotter with a sufficient water source available to extinguish fires which may be ignited from stray sparks, and only when all other provisions of the Order and applicable laws and ordinances are adhered to as set forth herein.

BE IT ALSO ORDERED, that the purpose of this order is the mitigation of the hazard posed by wildfire during the term of the dry, weather by curtailing outdoor burning; which purpose is to be taken into account in any enforcement action based upon this order.

This order will remain in effect for a period of 14 days, and shall expire at the end of said period.

WHEREAS, the Commissioners Court is authorized to require that the granting of a variance shall be contingent upon the recordation / codification of special conditions and requirements, provided that the variance must be based on the general intent of the Ordinance and deemed to be in the public interest, or of negligible negative impact to the public interest;

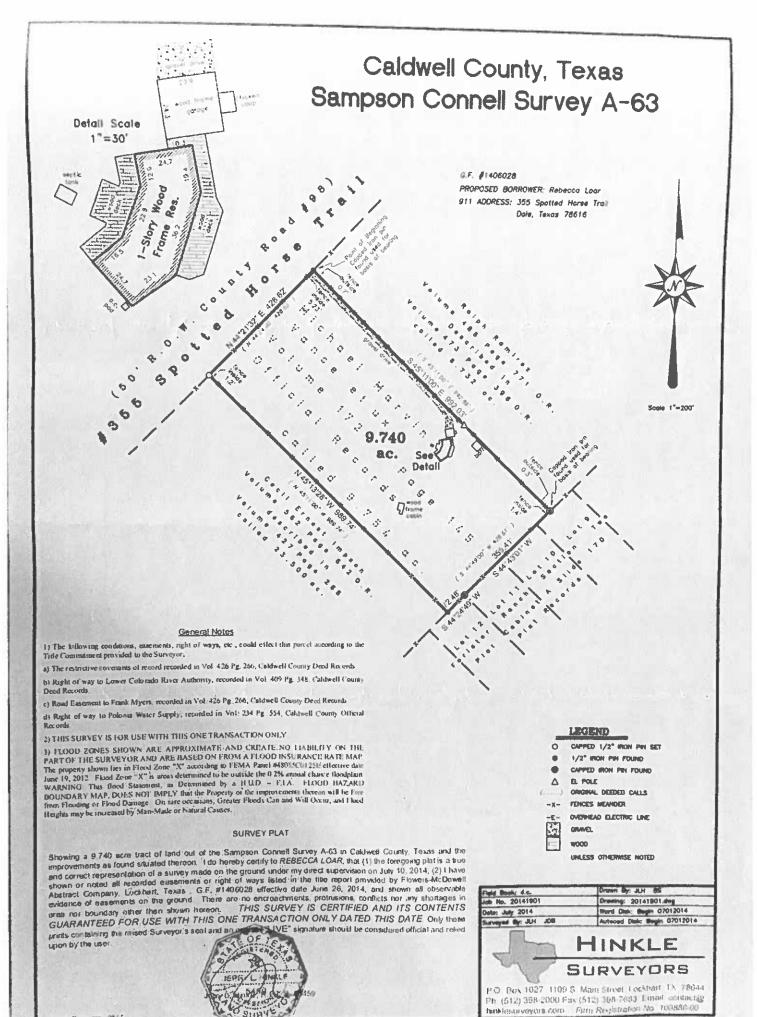
WHEREAS, pursuant to Section 3.12, Kyle Vanderhoof has requested a variance regarding the subdivision and conveyance of a parcel of real property located at 355 Spotted Horse Trail, Dale, Texas 78616, Property Number 10672, (the Property) in the unincorporated area of Caldwell County;

NOW THEREFORE, BE IT RESOLVED BY THE CALDWELL COUNTY COMMISSIONERS COURT THAT the variance request regarding the Property is approved and the Property may be subdivided into two (2) tracts, provided that the proposed subdivision and the parent tract shall be subject to the following conditions and/or restrictions:

- 1. No more than one single family residential structure may be erected on the Property or any resulting tract; and
- 2. Any further subdivision of either tract is prohibited.
- 3. The foregoing restrictions and/or conditions shall remain in effect until such time as the Property and any resulting tract gain or achieve secondary access.
- 4. The foregoing restrictions and/or conditions shall be made part of any conveyance of the Property, or any part thereof, and recorded in the Official Public Records of Caldwell County.

§A.1.E states "More than one independent access to an arterial or collector road is required for any subdivision with more than 30 residential lots." The purpose of this rule is public safety originally pushed by fire marshals in the adoption of fire codes across the country. The standard of limiting the number of lots to 30 from a single point of access is now nationally accepted standard adopted in most jurisdictions across the country (with many adopting the newer fire code standard of max of 20 lots).

When we did the plat for Spotted Horse Acres I did not notice that it was at the end of a dead end with more than 30 existing homes. However, if I had noticed, the situation for Spotted Horse Acres is fundamentally different than the proposed division of 355 Spotted Horse Trail. Specifically, Spotted Horse Acres already had 3 existing homes on it and was being split in to 3 one-acre tracts (in other words, the subdivision made legal lots for each existing home but resulted in zero new residences). In the situation of Spotted Horse Acres, had I noticed the single access and number of homes, that subdivision would have been a candidate for a variance (since the division did not further exasperate the access issue that is the intent of §A.1.E).

The proposed division at 355 Spotted Horse Trail will result in more homes from the single point of access (which already exceeds the rule). Since I first became aware of this issue we have become diligent in checking for deadend access issues and have told multiple people on Spotted Horse and other roads that they are not eligible for subdivision unless they can resolve the access issue. If the County grants a variance for 355 Spotted Horse, the County needs to be prepared for several other land owners on Spotted Horse (as well as other dead end streets throughout the County) to request the same variance.

Letter of Intent

This Letter of Intent is in support of our request for a variance to the front yard section, along County Road 98 – Spotted Horse Trail. The intention is to divide the existing property, 355 Spotted Horse Trail – Property# 10672, into 2 separate parcels roughly 4.9 acres in size, such that a new single family home may be built on the newly created parcel.

After discussing noted intent for the newly created parcel with Linda Hinkle, (Hinkle Survey Company), a pre-meeting was held with the county engineer, Tracey Branton, to discuss the proposal on 10/12/2020. Mr. Branton, immediately stated that the property could not be split, due to potential evacuation issues, considering Spotted Horse Trail terminates in a cul-de-sac, and if there ever is a natural disaster there could be potential evacuation issues. Linda, then stated this last year another larger parcel, in the cul-de-sac was split a multitude of times, see Appendix A. During this discussion with Linda, she stated the best approach for acceptance would be a request for variance from the County Commissioner. Kyle Vanderhoof, the primary land owner, scheduled a meeting to discuss this issue with Joe Roland on June 11th, during the discussion, all issues were discussed, including the concerns of Mr. Branton, and the conclusion was hopeful provided a Letter of Intent in support for a request of variance was provided.

What is perhaps most relevant here and what we would ask the board to consider, is (1) the splitting of 355 Spotted Horse Trail, would not change the overall footprint (see Appendix B), even with the variance, of the collective parcels of land (existing and newly proposed), (2) the existing property would still have adequate access and not create any "land-lock" situation, and the newly proposed property would have adequate road access also, (3) the proposed project would be an improvement to the "neighborhood" and result in an overall increase in property value and tax base created by improvement.

Dear Commissioner,

My name is Timothy Harper Jr., I am currently residing with my wife, Julia Boykin Harper, and our daughter, Haylie Harper, at 105 W. Olive St. Lockhart, TX, in Leonard and Minnie Petrosky's home. We have lived in the Lockhart area for a majority of our lives. We both graduated from Lockhart High School in the year of 2009, both in the top of our class. We are a quiet family, we tend to stay to ourselves, and stay on the right side of the law. Our little family is quickly outgrowing the home, as well as our wish for a larger garden, desire to keep bees, raise chickens, and be closer to Haylie's grandparents.

My family, has also lived and served Lockhart and the surrounding areas for well over 100 years. My great-grandfather, Leonard Petrosky, was a police officer in Lockhart, who later became the police chief until he retired. When Leonard's family arrived from Poland around the 1870s, through the port of Galveston, they eventually ended up settling down in Texas, and soon Minnie's family arrived from Germany. Minnie's family began settling down in the Mendoza area, consider the naming of roads in the area: "Homann Rd, Homannville Rd, Grandpa Rd, and Barth Rd," all named after the family. Minnie Homann eventually married Leonard Petrosky and they acquired a piece of land close to Minnie's family, now known as 12145 FM 1854. This land was used for hay, and cattle over the years.

Leonard and Minnie Petrosky had three children Carol-Diane, Wayne Lee, also known as "Bubba", and Diana. Leonard and Minnie raised them in their small humble house in Lockhart. Carol-Diane married Wayne Odell, and built a home on the Petrosky farm. Minnie and Leonard were getting older and found it harder to maintain the area, so they gifted 4 acres to Carol-Diane and Wayne Odell for their home site. During this time, they (Carol and Wayne Odell) raised Sheri Odell, my mother. Sometime later, Sheri married Tim Harper Sr., and moved into a small home on a portion of John Harper's property on CR98 (Spotted Horse Trail) where I was raised until I was about six. Wayne and Carol-Diane ended up setting aside 2 acres of their 4 acres for Sheri, on the Petrosky farm, so we then moved to the farm. Years later, Leonard passed leaving everything to Minnie. Prior to Minnie passing, she split the land officially with the children. Diana and her husband Troy, built a home on their share of the property, and moved Bubba in to help care for him. Wayne and Carol still live in their home with my mother and father next door. Rabecca and Alyssa (Diana and Troy's children) eventually placed home sites on the Petrosky farm, as well. Please see attached diagram, "Petrosky Farm."

My wife, Julia, lived in Buda, TX until she was eight. Her father and mother, Bobby and Kathy Boykin, eventually bought the home at 925 Spotted Horse Trail, Dale, TX where they raised her and her sister. When Julia and I met and started dating, we quickly realized our childhood homes were about two miles apart. Please see attached diagram, "925 Spotted Horse to Petrosky Farm." Julia lived at 925 Spotted Horse Trail until we were married. Shortly after we moved to Kyle, TX. Although we loved our first home together, we missed being close to all of our family, and didn't have a large enough lot to have a garden, bees, and chickens. When we lived in Kyle, Minnie passed away leaving her home vacant. Julia and myself discussed with Leonard and Minnie's children (Carol, Bubba, and Diana), asking if we could live at 105 W. Olive St. until we could buy a portion of land on Spotted Horse Trail from Kyle

Vanderhoof, the current owner of 355 Spotted Horse Trail, Dale, TX a very close/good friend to Julia and myself.

After the approval from the family, we sold our home in Kyle and began our plan to start buying the portion of property from Kyle Vanderhoof. As I am sure you are well aware, the property taxes have been climbing the last few years. Kyle is desperately wanting to sell this piece of land to us to downsize his 9.74 acres into a manageable size so he does not have to sell his home, as well as, help us move closer to family down the road (both on 1854 and Spotted Horse Tr.). Please see documentation on "355 Spotted Horse Trail".

Furthermore, this process to sub-divide started over a year ago. In which Linda Hinkle, from Hinkle Survey, stated that we need to have a pre-plat meeting with the county engineer and commissioner for the area. She did this on Kyle's and my behalf. This meeting was, at the time, a success and everyone agreed there were no issues sub-dividing the current plat. Then 2020 hit with all of it's setbacks and slowed our plan, and everything was placed on hold. When plans started to move forward again in 2021, the county engineer, stated he had concerns with sub-dividing the property at 355 Spotted Horse. He stated that we would need to request for a "variance" from the county commissioner in the precinct. The engineer mentioned that the county ordnance only allows a certain number of plats on a "dead-end" road. While writing the "Letter of Intent," we found out that a piece of property was allowed to be subdivided on Spotted Horse Trail, in the cul-de-sac, with no concerns (known as Spotted Acres), less than a year ago. Please see "Letter of Intent," as well as "Spotted Acres," documentation. The variance request was submitted. After a few weeks, I reached out and asked what came of the variance request. The request was not considered, and would be returned.

We have discussed the situation with a majority of the individuals that live on Spotted Horse Trail, and there was a large amount of support for us to petition, asking the county commissioners to allow the sub-division. Please see the attached copy of the "Signatures for Appeal." The petition is nothing close to a formal document, but it shows that the constituents welcome familiar faces to the area.

I come to you today humbly asking for your consideration to allow the sub-division of 355 Spotted Horse Trail. This sub-division would help Kyle Vanderhoof maintain his home and it would help my small family move closer to Haylie's grandparents on Spotted Horse Trail (925 Spotted Horse) as well as her grandparents and great-grandparents, at the Petrosky farm (12143 and 12145 FM 1854). We have grown up in this area and love it very much. This is our home, and we want it to be known. We do not wish to buy the plot, flip it, and sell it. We want to settle down and build our forever home with a healthy garden, chickens, and honey bees. We want our daughter to grow up enjoying a quiet spot in the country, same as her parents did when we were young, all while being close to family and friends.

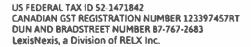

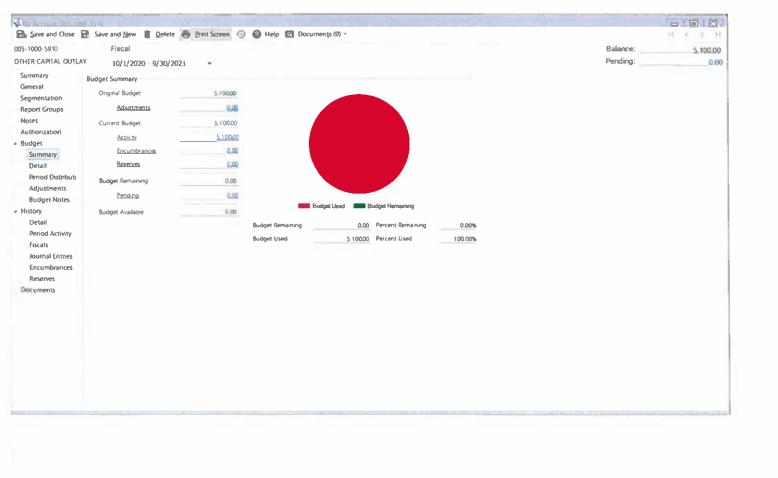

The following represents our understanding of the services we will provide Caldwell County.

You have requested that we audit the financial statements of the governmental activities, the business-type activities, the discretely presented component unit, each major fund, and the aggregate remaining fund information of Caldwell County, as of September 30, 2021, and for the year then ended and the related notes to the financial statements, which collectively comprise Caldwell County's basic financial statements as listed in the table of contents. We are pleased to confirm our acceptance and our understanding of this audit engagement by means of this letter. Our audit will be conducted with the objective of our expressing an opinion on each opinion unit.

Accounting principles generally accepted in the United States of America, (GAAP,) require that certain required supplementary information (RSI), such as management's discussion and analysis (MD&A) and budgetary comparison information be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board (GASB), who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. As part of our engagement, we will apply certain limited procedures to Caldwell County's RSI in accordance with auditing standards generally accepted in the United States of America, (GAAS). These limited procedures will consist primarily of inquiries of management regarding their methods of measurement and presentation, and comparing the information for consistency with management's responses to our inquiries. We will not express an opinion or provide any assurance on the RSI. The following RSI is required by GAAP and will be subjected to certain limited procedures, but will not be audited:

- 1) Management's Discussion and Analysis
- 2) Budgetary Comparison Schedule General Fund and Unit Road Fund
- 3) Schedules of Contributions and Changes Defined Benefit Pension Plan and Other Post-Employment Benefits

Supplementary information other than RSI will accompany Caldwell County's basic financial statements. We will subject the following supplementary information to the auditing procedures applied in our audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America.

We intend to provide an opinion on the following supplementary information in relation to the financial statements as a whole:

- 1. Comparative Balance Sheet and Statements of Revenues, Expenditures and Changes in Fund Balance for Each Major Fund
- 2. Combining Balance Sheets and Statements of Revenues, Expenditures and Changes in Fund Balance Nonmajor Funds and Budget to Actual Statements if a legally adopted Budget.
- 3. Combining Statements Agency Funds

Auditor Responsibilities

We will conduct our audit in accordance with GAAS. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the basic financial statements are free from material misstatement. An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to error, fraudulent financial reporting, misappropriation of assets, or violations of laws, governmental regulations, grant agreements, or contractual agreements.

STATE AGENCY LEASE AGREEMENT

1. PARTIES

This Lease Agreement (the "Lease") is made by and between Caldwell County, Texas ("Lessor"), and the State of Texas, acting by and through the Health and Human Services Commission ("Lessee"), for and on behalf of the Health and Human Services Commission and Departement of State Health Services("Occupying Agency"), each a "Party" and collectively the "Parties," pursuant to Lessee's delegated authority from the Texas Facilities Commission and in accordance with the provisions of *Texas Government Code* § 2167.051.

2. LEASE REPRESENTATIVES

The following will act as the designated representative authorized to administer activities, including but not limited to, non-legal notices, consents, approvals, requests, or other general communications, provided for or permitted to be given under this Lease. 3. PURPOSE AND PROPERTY LEASED

This Lease is entered into for the purpose of leasing real property owned by the Lessor to Lessee for use by one or more of its department(s) and/or the Occupying Agency

The real property to be leased shall be 3,834 (Suite G) and 650 (Suite F) to total 4,484 usable square feet, including shared or common area space. This real property is more commonly described as the property located at 1403 Blackjack St., Suite G & F, Lockhart, Texas 78644 (the "Premises").

In consideration of Lessee's or the Occupying Agency's covenants contained in this Lease, Lessor shall lease the Premises to the Lessee.

In return for use of the Premises as described in this Lease, Lessee agrees to pay rent to the Lessor from Lessee's or Occupying Agency's current revenues available; provided, however, and as more particularly described below, the Lessor waives all rental charges for Suite F of the Premises, except for HHSC's and Occupying Agency's proportionate share of any reimbursable expenses, if any. The Lessor agrees to waive all rental charges for Suite F and grant exclusive rights of use for Suite F in consideration of

HHSC's or Occupying Agency's delivery of services to residents of Caldwell County and the state of Texas, or other uses as deemed necessary by HHSC or Occupying Agency.

4. LEASE TERM

This Lease shall be for the initial period of <u>60</u> months commencing on <u>September 1, 2022</u> (the "Commencement Date"), and ending on <u>August 31, 2027</u> the "Termination Date"), unless renewed, extended, or terminated pursuant to the terms and conditions of this Lease.

5. MONTHLY RENTAL

The Lessee or Occupying Agency agrees to pay Lessor a base monthly rent of \$2,889.88 for Suite G during the initial term of this Lease in accordance with <u>Attachment A, Rent Schedule, which is attached to, incorporated, and made a part of this Lease for all purposes</u>. The monthly rentals shall be due and payable by Lessee or Occupying Agency in advance on the first day of the month during the Lease term.

Lessor understands that all obligations of Lessee or Occupying Agency under this Lease are subject to the availability of state funds. If such funds are not appropriated or become unavailable, the Lease may be terminated by Lessee.

6. RENEWAL OPTION

By mutual agreement between Lessee and Lessor, this Lease may be renewed for any period or periods of time no greater than a cumulative total of ten years, which ten year period includes the initial lease term. Lessee shall give Lessor written notice of intention to either renew or not renew this Lease at least 60 days prior to expiration of this Lease, or any extensions thereof.

7. GENERAL LEASE COVENANTS

- 7.1 <u>Lessee's Covenants</u>. This Lease is made upon the following additional express conditions and limitations, each of which Lessee will observe and perform throughout the initial term of this Lease and any extension thereof. Violation of any condition or limitation, followed by written notice of the violation given by the Lessor's designated representative, if not cured by Lessee within 30 calendar days of notice shall give Lessor the option to terminate this Lease:
 - (a) The Premises shall be used and occupied by one or more of Lessee's department(s) and/or the Occupying Agency, to facilitate the delivery of social services to residents of Texas and Caldwell County or other uses as deemed necessary by Lessee or the Occupying Agency.
 - (b) Lessee or the Occupying Agency shall make no alterations, additions, or improvements in, to, or about the Premises without prior written consent of Lessor.
 - (c) Lessee or Occupying Agency will conform to reasonable regulations which may be established from time to time by Lessor, for the general convenience of all of the tenants, except when such regulations conflict with federal and state laws or regulations, or agency procedures.
 - (d) Lessee shall maintain the Premises in leasable condition and, at the expiration or other termination of this Lease, shall surrender the Premises and fixtures in as good condition as reasonable use will permit. All injury to the building or fixtures caused by moving the property of the Lessee or Occupying Agency in or out of the building, and all breakage or

- any other injury done by the Lessee or Occupying Agency, or its agents, employees, or invitees, when authorized by Lessee, shall be repaired by Lessor at the expense of Lessee or Occupying Agency.
- (e) Lessee or Occupying Agency, upon receiving 48 hours' written notice, will permit Lessor's designated representative, to enter upon and examine the Premises for the purposes of inspection and any repairs which Lessor deems necessary for the protection of the building and leased premises. In the event of emergency or disaster, Lessor shall not have to give notice.
- 7.2 <u>Lessor's Covenants</u>. This Lease is made upon the following additional express conditions and limitations, each of which Lessor will observe and perform throughout the initial term of this Lease and any extension thereof. Violation of any condition or limitation, followed by written notice of such violation given by the Lessee's designated representative, if not cured within 30 calendar days of notice, shall give Lessee the option to terminate this Lease:
 - (a) Lessor shall allow Lessee to peaceably hold and enjoy the Premises.
 - (b) Lessor shall provide Lessee or Occupying Agency the necessary services for the operation and maintenance of the building, including but not limited to heating, air-conditioning, mechanical work, plumbing, and general upkeep of the complex.
 - (c) In the event the Premises or any part thereof shall at any time during the Lease term be damaged by fire or other casualty, so as to be unfit for Lessee's or Occupying Agency's use and occupancy, Lessee's or Occupying Agency's obligation to make monthly rental payments, or a just and proportionate part as to the damaged portion of the Premises, according to the nature and extent of the damage sustained, shall be abated until the Premises is fully repaired and restored by the Lessor. In the event said Premises are destroyed, or unfit for Lessee's or Occupying Agency's continued use and occupancy, then at the election of either Lessor or Lessee, this Lease may be terminated and the Parties shall be released from all obligations under this Lease.
 - (d) During the term of this Lease, Lessor will not rent, lease, or otherwise furnish space in this complex or any adjacent building under its control to any enterprise, which in the usual exercise of its business, could be expected to create noise or odors injurious or disruptive to the Lessee's or Occupying Agency's normal governmental operations. Lessor shall not lease space that would locate or collocate any regulated parties which have an interest in the Lessee or Occupying Agency, or whose occupation of these premises would cause the Lessee or Occupying Agency to be in violation of a state statute.
 - (e) Lessee or Occupying Agency may bring on the Premises any furniture, fixtures, and equipment reasonably necessary for the efficient exercise of Lessee's or Occupying Agency's governmental responsibilities, and the Parties agree that all such property shall remain the property of Lessee or Occupying Agency.
 - (f) The Lessor, in accordance with the Lessee's or Occupying Agency's written specifications, shall provide a temperature-controlled, secure room to house the Lessee's or Occupying Agency's network equipment and permit Lessee or Occupying Agency to establish network connectivity via cabling throughout the Premises to accommodate the Lessee's or Occupying Agency's needs.
 - (g) Lessor shall maintain the Premises and buildings in tenantable condition and promptly cure all defects and/or make required repairs with seven calendar days of notice from Lessee. Lessor shall cure conditions presenting life, safety, or security breaches no later than 24 hours after receiving notice. Lessor's failure to maintain the Premises and buildings, cure defects and make repairs as required herein may result in the Lessee's or Occupying

- Agency's completing needed repairs at the Lessor's expense. The Lessee or Occupying Agency may deduct commercially reasonable repair costs from the following month's rent.
- (h) Lessor must maintain a policy of all-risk property insurance, issued by an insurance company licensed in the State of Texas, covering the Premises and leasehold improvements (exclusive of contents), in an amount equal to not less than 100% of the replacement cost thereof. Lessee or Occupying Agency shall have no interest in the policy or policy proceeds and Lessor shall not be obligated to insure any furnishings, equipment, trade fixtures, or other personal property that Lessee or Occupying Agency may place or cause to be placed upon the Premises.
- (i) Lessor must maintain a policy or policies of comprehensive general liability insurance insuring Lessor against loss of life, bodily injury and/or property damage with respect to common areas, operation of the buildings, parking lots and other improvements associated with the land upon which the Premises are located, and any other losses caused by or related to the duties and obligations of Lessor under this Lease. Lessor shall designate Lessee as an additional insured on the policy.
- (j) Lessor acknowledges that, because Lessee and Occupying Agency is an agency of the state of Texas, liability for the tortious conduct of the agents and employees of Lessee or Occupying Agency (other than medical liability of medical staff physicians) or for injuries caused by conditions of tangible state property is provided for solely by the provisions of the "Texas Tort Claims Act," Texas Civil Practice and Remedies Code Chapters 101 and 104, and that Workers' Compensation Insurance coverage for employees of Lessee or Occupying Agency is provided by Lessee or Occupying Agency as mandated by the provisions of Texas Labor Code Chapter 503. Lessor further acknowledges that, as an agency of the state of Texas, Lessee or Occupying Agency has only such authority as is granted to Lessee or Occupying Agency by state law or as may be reasonably implied from such law, and that Lessee or Occupying Agency shall have the right, at its option, to (a) obtain liability insurance protecting Lessee or Occupying Agency and its employees and property insurance protecting Lessee's or Occupying Agency's buildings and the contents; or (b) self-insure against any risk that may be incurred by Lessee or Occupying Agency as a result of its operations under this Lease. Any obligation by Lessee under this Lease to obtain insurance is expressly made subject to the Lessee's authority under state law to obtain such insurance. No insurance carrier of either Party shall have a right of subrogation against the other Party to this Lease.

8. LEASE REQUIREMENTS

- 8.1 <u>Condition of Premises</u>. Lessor warrants that it is not in violation of any city, state, or local ordinance or statute or any restrictions imposed against the Premises for the Lessee's or Occupying Agency's intended governmental purpose, and Lessor shall continue to operate and own the Premises so as to not do so for the entire duration of this Lease.
- 8.2 Adverse Building Conditions. Lessee reserves the right of inspection and may reject Premises space based on adverse building conditions, including but not limited to general cleanliness, appearance of carpet or tile, grounds, finished interiors or exteriors, odors, pests, insects, or other problems relating to improper extermination, or any other condition that would create unsanitary, unattractive, or unsafe conditions.
- 8.3 <u>Minimum Square Footage</u>. As a condition of occupancy, Lessor certifies that the Premises contains the minimum usable square footage specified in this Lease.

- Payment of Utilities. Lessor shall provide, and pay for, all utility services. The Lessee will be responsible to reimburse Lessor for one hundred (100) percent of Lessor's recurring payment for utility services for the entire 3,834 square feet in Suite G within 30 calendar days of receipt of a monthly invoice from Lessor. Lessee or Occupying Agency will be responsible to reimburse Lessor for thirty six (36) percent of Lessor's recurring payment for utility services for the entire 650 square feet in Suite F within 30 calendar days of receipt of a monthly invoice from Lessor. Lessor will be responsible for providing Lessee access to all utilities services, meters, and connections necessary for the proper and intended use of the space. These utilities are continuous hot and cold water, wastewater, electricity and natural gas, if required for heating and cooling. Lessor shall allow Lessee or Occupying Agency to separately meter the Premises, at Lessee's or Occupying Agency's sole cost and discretion, at any time during the term of this Lease. Lessees or Occupying Agency shall not be responsible for any repairs relating to any utility unless Lessee or Occupying Agency is solely responsible for the damaged to be repaired.
- 8.5 <u>Telecommunications System</u>. Lessor shall be responsible for providing and maintaining a KSU, KSU-Less, PBX, hosted PBX, or VoIP, telephone system, that includes, but is not limited to, handsets, power supplies, and routers, for local/long distance phone services at the Premises. Lessee or Occupying Agency shall be responsible for providing and maintaining long distance service and equipment at its own expense.
- 8.6 <u>Security Alarm System</u>. Lessor shall be responsible for the provision and maintenance of an actively monitored security alarm and locking systems at the Premises.
- 8.7 Exterior Doors and Keys. All exterior doors shall be keyed with keys that are inscribed as duplication prohibited. Lessor shall furnish keys, individually numbered, as requested by Lessee. All exterior exit doors shall be solid core doors (where applicable) and equipped, unless otherwise required by code, with deadbolt locks with a minimum one-inch throw bolt. All door hardware and automatic door closers shall be of sufficiently sturdy construction to ensure security.
- 8.8 Janitorial Services and Supplies. Lessee shall provide janitorial services and supplies.
- 8.9 <u>Pest Control</u>. Lessor shall provide quarterly interior and exterior pest control services, and any additional pest control services as needed.
- 8.10 Maintenance of Building. Lessor shall be responsible for keeping the Premises and building(s) in good repair and condition during the Lease term. Lessor shall provide maintenance services to include, but not be limited to the following: repair and patch wall, ceiling, and floor surfaces; painting as needed; replacement of broken window glass; repair of window shades, blinds and/or drapes, fasteners, and sash cord or chains; roof and ceiling leaks; building exterior, interior; plumbing, heating, air conditioning and ventilating equipment and filters; fire protection equipment; miscellaneous valves; woodwork, locks, floor surfaces and coverings; lighting fixtures, and the replacement of all inoperable light bulbs, fluorescent tubes, ballasts, and starters. Any touch up paint must match the existing wall paint and if the touch up paint is unacceptable, as solely determined by the Lessee, repainting is required. Lessor, if requested by Lessee, shall repaint the Premises no less often than every five years and replace floor coverings no less often than every 15 years. If the Lessee or Occupying Agency, or its agents, cause damage to the property that goes beyond "normal wear and tear" the Lessee or Occupying Agency is responsible to repair or pay for those repairs.
- 8.11 Non-Smoking Area. Lessor shall designate the Premises as a "non-smoking area."

- 8.12 <u>Parking</u>. Lessor shall provide ample off-street parking for client and staff vehicles. Parking must be under the direct control of the Lessor and must be located within a reasonable distance of the entry to the Premises. Lessor shall also provide accessible parking spaces in accordance with the Texas Accessibility Standards ("TAS").
- 8.13 Exterior Building Maintenance. Lessor shall maintain the exterior of the building and adjacent grounds in an appropriate manner as determined by Lessee. Lessor agrees to make diligent efforts to landscape with Texas flora. All grass, trees, shrubbery, and other landscaping must be maintained on a regular basis. Water used by Lessor for landscaping and/or decorative purposes shall be paid for by Lessor.

9. GENERAL TERMS AND CONDITIONS

- 9.1 Conversion to Limited Month-to-Month Lease. Lessee may, upon written notice to the Lessor at least 30 days prior to termination of this Lease or any extension, remain in possession of the Premises for a period specified in the notice, not to exceed 180 days. The Lessee or Occupying Agency shall pay the Lessor the monthly rent in effect at the termination of this Lease (or if Lessee or Occupying Agency only occupies the Premises for part of a month, a pro-rata sum of the monthly rent) for the space occupied by the Lessee or Occupying Agency during this period.
- 9.2 <u>Termination for Convenience</u>. Lessee reserves the right, at any time within the initial or any renewal period, to terminate this Lease with regard to either or both suites for convenience without incurring any further liability after termination with regard to the terminated suite(s). Lessee or Occupying Agency may terminate this Lease with regard to Suite F by providing written notice not less than 60 calendar days before the specified termination date. Lessee or Occupying Agency may terminate this Lease with regard to Suite G by providing written notice not less than 180 calendar days before the specified termination date. If there is a termination with regard to one suite alone, then the Lease, and any renewal or amendment thereof, shall remain in full force and effect with regard to the remaining suite to the extent that the Lease provisions apply to the remaining suite.
- 9.3 <u>Payment of Taxes</u>. Lessor, when applicable, shall be responsible to pay all taxes of whatever nature, levied and assessed and to be levied or assessed, on or against the Premises and improvements during the term of this Lease.
- 9.4 <u>Signage</u>. Any signs necessary to indicate the Lessee's or Occupying Agency's name, location, and governmental purpose shall be prepared and installed by Lessor consistent with signage for other lessees in the property and in keeping with building décor. Lessor shall provide the Lessee with a copy of its standardized signage rules prior to execution of this Lease. Any special signage requirements of Lessee or Occupying Agency must be stated in writing and made a part of this Lease. Any cost of compliance with this section in excess of the amount that would be required for the Lessor's standard signage shall be borne by the Lessee or Occupying Agency.
- 9.5 Property of Lessee. On termination of this Lease, by lapse of time or otherwise, the Lessee or Occupying Agency may for 180 calendar days thereafter, at its option and expense, remove from the Premises any and all improvements, equipment, appliances or other property placed or owned by Lessee or Occupying Agency. The Parties, by mutual written agreement, may either reduce or extend the time allowed for the Lessee or Occupying Agency to remove its property. Lessee shall deliver the Premises to Lessor in good order and condition, excluding reasonable use and ordinary wear and tear.

- 9.6 <u>Condemnation</u>. If, during the term of this Lease, the Premises, or any portion thereof, shall be condemned for any public purpose, Lessee or Occupying Agency shall have the option of terminating and canceling this Lease upon 30 days' notice to the Lessor.
- 9.7 Commencement of Occupancy. Lessee or Occupying Agency is not obligated to pay rent or for utilities, if applicable, under this Lease until the Premises are made available by Lessor to Lessee or Occupying Agency for full occupancy, and Lessee or Occupying Agency determines the Premises are suitable for use as office space for a state agency. If Lessor is unable to give Lessee full possession of the Premises on the Commencement Date for any reason, Lessor shall give Lessee immediate written notice of the cause for the delay and the date the Premises will be ready for occupancy. If full possession is delayed, Lessee, in its sole discretion, may terminate this Lease at any time without liability to the state of Texas, Lessee, or Occupying Agency, and seek other leased space.

Pending readiness of the Premises for full occupancy, if the Lessee elects, the Lessee may continue to treat this Lease as if in full force and effect for a period of no more than one hundred twenty (120) calendar days after the Commencement Date. During this time, or for as long as possession does not commence, Lessee or Occupying Agency's shall not be required to pay rent.

- 9.8 <u>Abandonment</u>. The Lessee or Occupying Agency will not, without notifying the Lessor, abandon the Premises, or allow the Premises to become vacant or deserted. In the event the Lessee's or Occupying Agency's need to occupy the Premises terminates, the Lessee will make every reasonable attempt to notify the Lessor 180 calendar days before vacating the Premises, but will accrue no liability if such notice is not given.
- 9.9 <u>Assignment</u>. Lessee reserves the right to assign any agency of State government to occupy all or any part of the Premises or to assign or sublet all or any part of the Premises to any private entities (persons or corporations) it deems to be in the best interest of the state of Texas.
- 9.10 <u>Default by Lessor</u>. In the event Lessor shall breach or be in default in the performance of any of the covenants or obligations imposed upon Lessor by this Lease, and shall remain in default for a period of 30 calendar days after written notice of such default, Lessee shall have the right to terminate this Lease, and shall have the remedies now or hereafter provided by law for recovery of damages occasioned by the default. Lessee or Occupying Agency specifically shall be entitled to deduct amounts expended on repairs necessary to maintain the suitability and habitability of the Premises.
- 9.11 <u>Default by Lessee</u>. If Lessee or Occupying Agency fails to pay rent or otherwise fails to perform its obligations under this Lease and this failure is not cured within 60 calendar days after written notice from Lessor to Lessee of such failure, then Lessee is in default, and Lessor may terminate this Lease and may enter and take possession of the Premises, and will have the remedies now or hereafter provided by law for recovery of rent, repossession of premises, and damages occasioned by Lessee's or Occupying Agency's default.
- 9.12 <u>Failure to Enforce</u>. The failure of the Lessee or Lessor to insist in any one or more instances on a strict performance of any of the covenants or conditions of this Lease shall not be construed as a waiver or relinquishment of such covenants or conditions in future instances, but the same shall continue and remain in full force and effect.

9.13 <u>Legal Notices</u>. Any legal notice required under this Lease shall be deemed delivered when deposited by Lessee either in the United States mail, postage paid, certified, return receipt requested; or with a common carrier, overnight, signature required, to the address set forth below for Lessor. Legal notice given by Lessor will be deemed effective when received by Lessee at the address below. The addresses are as follows:

- 9.14 <u>Public Information Act</u>. Information, documentation, and other material related to this Lease may be subject to public disclosure pursuant to Chapter 552 of the Texas Government Code (the "Public Information Act" or "PIA"). In accordance with Section 2252.907 of the Texas Government Code, Lessor is required to make any information created or exchanged with Lessee or the Occupying Agency pursuant to this Lease, and not otherwise excepted from disclosure under the Texas Public Information Act, available in a format that is accessible by the public at no additional charge to Lessee or the Occupying Agency.
- 9.15 State Auditor's Right to Audit. The state auditor may conduct an audit or investigation of any entity receiving funds from the state directly under this Lease or indirectly through a subcontract under this Lease. The acceptance of funds directly under this Lease or indirectly through a subcontract under this Lease acts as acceptance of the authority of the state auditor, under the direction of the legislative audit committee, to conduct an audit or investigation in connection with those funds. Under the direction of the legislative audit committee, an entity that is the subject of an audit or investigation by the state auditor must provide the state auditor with access to any information the state auditor considers relevant to the investigation or audit.
- 9.16 <u>Texas Accessibility Standards</u>. In signing this Lease, the Lessor certifies that the Premises to be occupied shall comply with all applicable federal, state and local laws, statutes, ordinances, codes, rules, and regulations, which include compliance with all applicable handicapped accessibility requirements. Acceptance of the Premises by Lessee or Occupying Agency does not excuse the Lessor from meeting all requirements. No requirement may be waived by the Lessee or Occupying Agency.

- Lessor specifically covenants and warrants that the Premises and leased space will at all times comply with the TAS requirements for persons with disabilities administered by the Texas Department of Licensing and Regulations.
- 9.17 Sovereign Immunity. The Parties expressly agree that no provision of this Lease is in any way intended to constitute a waiver by Lessee, the Occupancy Agency, or the State of Texas of any immunities from suit or from liability that Lessee, the Occupying Agency, or the State of Texas may have by operation of law.
- 9.18 Governing Law and Venue. This Lease shall be governed by and construed in accordance with the laws of the state of Texas, without regard to the conflicts of law provisions. The venue of any suit arising under this Lease is fixed in any court of competent jurisdiction of Travis County, Texas, unless the specific venue is otherwise identified in a statute which directly names or otherwise identifies its applicability to HHSC or the Occupying Agency. Lessor irrevocably waives any objection, including any objection to personal jurisdiction or the laying of venue or based on the grounds of forum non conveniens, which it may now or hereafter have to the bringing of any action or proceeding in such jurisdiction in respect of this Lease.
- 9.19 Entire Lease and Amendments. This Lease and all attachments incorporated and made a part of the Lease constitute the entire agreement between the Parties. All prior proposals, negotiations, notices, and representations not incorporated in this Lease are void and have no legal effect. Any future amendment or modification to this Lease is not valid unless evidenced in writing and signed by the Lessor and Lessee.

INTERLOCAL AGREEMENT

This interlocal agreement (the "Agreement") is made by and between the **REGIONAL PUBLIC DEFENDER OFFICE LOCAL GOVERNMENT CORPORATION** ("RPDO"), and **CALDWELL COUNTY, TEXAS** ("PARTICIPANT"), a political subdivision of the State of Texas, (also, individually, a "Party" or, collectively, the "Parties"). This Agreement is made pursuant to the Fair Defense Act, Texas Code of Criminal Procedure 26.044(b), and Texas Government Code Chapter 791.

RECITALS

WHEREAS, Chapter 791 of the Texas Government Code, also known as the Interlocal Cooperation Act, authorizes all local governments to contract with each other to provide a governmental function or service that each party to the contract is authorized to perform individually and in which the contracting parties are mutually interested; and

WHEREAS, the RPDO is a public, non-profit corporation organized under Subchapter D, Chapter 431 of the Texas Transportation Code a "local government" pursuant to Section 791.003(4)(B) of the Texas Government Code and is authorized to participate on behalf of Lubbock County to oversee and provide defense services to indigent defendants in counties which enter into interlocal agreements with the RPDO to provide defense services; and

WHEREAS, Participant has a need for and desires the RPDO to provide defense services to indigent defendants in Caldwell County, Texas outlined herein; and

WHEREAS, each Party finds: 1) that the subject of this Agreement is necessary for the benefit of the public; and 2) that it has the legal authority to perform and to provide the government function or service which is the subject matter of this Agreement; and,

WHEREAS, the performance of this Agreement by RPDO and PARTICIPANT will be in the common interest of the Parties;

NOW, THEREFORE, the Parties agree as follows:

ARTICLE I PROGRAM

Program Purpose and Term. The Regional Public Defender for Capital Cases (the "RPDO"), funded proportionately by the Texas Indigent Defense Commission Multi-Year Discretionary Grant Program Funds (the "TIDC"), will provide court-appointed counsel for individuals charged with the offense of capital murder (death-eligible) in the participating counties and who cannot afford to hire their own attorney. Inmates in units of the Texas Department of Criminal Justice within the region who are charged with capital murder will continue to be represented by the State Counsel on Offenders, or by private counsel in the case of a conflict. Capital murder cases filed against inmates in units of the Texas Department of Criminal Justice shall not be counted in the average number of capital murder cases filed in a county.

Participant recognizes that counties from other Administrative Judicial Regions ("Region") are also participating in the program. Each county's participatory costs are based upon funding received from the Texas Indigent Defense Commission ("TIDC"). The remaining portion of the program's budget is cost-sharing commensurate with all eligible counties' applicable inclusion in the program.

In order to provide sustainable funding for the RPDO and a fund balance for emergency situations, participating counties will contribute (with a minimum contribution of \$1,000 per county) per the detailed county allocation schedule marked as Attachment 1 and incorporated herein for all purposes. Based upon this cost-sharing approach, participating counties shall provide the remaining operating costs based upon a formula taking into account the population of the county as a percentage of the whole of the participating counties (50%) and the average number of capital murder cases filed between 2011 and 2020 as a percentage of the participating counties (50%).

The Interlocal Agreements shall become effective October 1, 2021 and continue through September 30, 2022. Thereafter, the agreements shall automatically renew each October 1st for a successive one-year term through September 30, 2023, unless terminated under this Agreement.

- Judges Authorized to Appoint RPDO. The District Courts in the 1st, 2nd, 3rd, 4th, 5th, 6th, 7th, 8th, 9th, 10th, and 11th Administrative Judicial Regions in eligible counties may participate in the Program. The Program allows the Honorable Judge(s) of the Judicial District having jurisdiction within PARTICIPANT's geographic boundaries to appoint the RPDO for the trial defense of death-eligible capital murder cases. In the event of a conflict of interest among defendants or a legal liability for the RPDO to accept appointment, the trial court shall appoint an attorney or attorneys other than the RPDO at the PARTICIPANT's expense.
- 1.03 Duties and Responsibilities of the RPDO. Subject to the terms and conditions outlined herein, the RPDO will represent defendants at the trial or re-trial phase only. All decisions pertaining to the presentation of the case will be at the sole discretion of the RPDO and the RPDO attorney will at all times be guided by and comply with the RPDO's attorney's duties as a licensed attorney in the State of Texas and the Texas Disciplinary Rules of Professional Conduct in making these determinations. It is understood and acknowledged by the parties that the duties and responsibilities of the RPDO to provide the services and legal representation under this Agreement are subject to the application of the following, as determined at the sole and absolute discretion of the RPDO: (i) the Texas Disciplinary Rules of Professional Conduct; (ii) the State Bar of Texas Guidelines and Standards for Texas Capital Counsel; (iii) the Supplementary Guidelines and Standards for the Mitigation Function of Defense Teams in Texas Death Penalty Cases; (iv) the American Bar Association Guidelines for the Appointment and Performance of Defense Counsel in Death Penalty Cases; (v) the American Bar Association Supplementary Guidelines for the Mitigation Function of Defense Teams in Death Penalty Cases; (vi) all applicable state statutes including but not limited to Article 26.044(j) of the Texas Code of Criminal Procedure; and (vii) any applicable case load management policies as may be adopted by the RPDO.
- 1.04 Right to Audit. The RPDO will conduct an annual audit that, upon written request, will be made available to the PARTICIPANT. PARTICIPANT may request and be provided with an opportunity to audit any relevant and non-confidential records of the RPDO directly related to PARTICIPANT's agreement with the RPDO that support the calculations of charges invoiced to the PARTICIPANT under this Agreement. Such audits shall be conducted at PARTICIPANT's sole cost and expense and under mutually acceptable terms at RPDO's premises in a manner that minimizes any interruption in the daily activities at such premises.
- 1.05 <u>Data for the Analysis</u>. As consideration for its participation in the Program, PARTICIPANT agrees to provide the RPDO information as needed to conduct the analysis, including the current payment schedule for court-appointed counsel on capital murder cases and the previous five fiscal years' data on the amount PARTICIPANT paid for appointed counsel on capital murder cases, if available.
- 1.06 <u>Additional Experts.</u> PARTICIPANT will continue to incur the expense of additional experts as approved by the local court.

- 1.07 Fact Investigators and Mitigation Specialists. The RPDO will provide a fact investigator and mitigation specialist to cases assigned to the RPDO office.
- No other Costs Incurred. Neither the TIDC nor the RPDO will assume any additional costs associated 1.08 with representation of indigent defendants. Costs of interpreters or any other collateral cost must be absorbed by PARTICIPANT.

ARTICLE II OTHER TERMS AND CONDITIONS

2.01 Notice and Addresses. Any notice required by this Agreement shall be deemed to be properly served, if (i) provided in person, by e-mail with delivery confirmation; or (ii) deposited in the United States mail by certified letter, return receipt requested, addressed to the recipient at recipient's address shown below, subject to the right of either party to designate a different address by notice given in the manner just described:

- 2.02 Governmental Function/No Waiver of Immunity. The parties to this Agreement acknowledge that the services contracted for in this Agreement relate to the governmental functions of the PARTICIPANT and the RPDO. Nothing in this Agreement shall be construed to impair or affect any sovereign or governmental immunity or official immunity enjoyed by or otherwise available to the PARTICIPANT, the RPDO, or their respective officers and employees. No waiver of sovereign or official immunity, whether express or implied, is intended or made by this Agreement.
- 2.03 No Partnership. Nothing contained in this Agreement is intended to create a partnership or joint venture between the Parties, and any implication to the contrary is hereby expressly disavowed. This Agreement does not create a joint enterprise, nor does it appoint any Party as an agent of the other Party, for any purpose whatsoever.
- 2.04 Employee Status. RPDO shall have the sole obligation to employ, direct, control, supervise, manage, discharge and compensate all of its employees. RPDO's employees will not be considered, for any purpose, employees of PARTICIPANT within the meaning or the application of any federal, state or local law or regulation, including without limitation, laws, rules or regulations regarding or related to

- unemployment insurance, health insurance, old age benefits, workers compensation, labor, personal injury or taxes of any kind.
- 2.05 <u>Waiver</u>. The failure of any Party to insist upon the performance of any terms or provision of this Agreement or to exercise any right granted hereunder shall not constitute a waiver of that Party's right to insist upon appropriate performance or to assert any such right on any future occasion.
- 2.06 <u>Benefit of the Parties</u>. The terms and conditions of this Agreement are solely for the benefit of the Parties and are not intended to create any rights, contractual or otherwise, for any other person or entity.
- 2.07 **Force Majeure.** If the performance of any obligation under this Agreement is delayed by something reasonably beyond the control of the Party obligated to perform ("Force Majeure"), that Party shall be excused from performing the obligation during that period, so that the time period applicable to the performance shall be extended for a period of time equal to the period that Party was delayed due to the event of Force Majeure.
- 2.08 Severability. In case any one or more of the provisions contained in this Agreement shall for any reason be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision and this Agreement shall be construed as if the invalid, illegal, or unenforceable provision had never been contained herein.
- 2.09 Non-Appropriation. RPDO and PARTICIPANT recognize that any payments made for performance under this Agreement and any services provided shall be and are subject to the current revenues available to the respective party. Either party may terminate this Agreement, without incurring any liability to the other except to pay for any services already rendered, if funds sufficient to pay the obligations hereunder or to provide the services are not appropriated by the respective governing bodies of the parties. Unless terminated pursuant to other applicable termination provisions contained in this Agreement, in the event of non-appropriation of funds by a governing body of one of the parties to this Agreement for services provided under this Agreement, this Agreement shall terminate automatically on the last day of the then-current fiscal year or when the appropriation made for the then-current fiscal year for the services covered by this Agreement is spent, whichever occurs first.
- 2.10 <u>Prior Agreements Superseded</u>. This Agreement constitutes the only agreement of the Parties and supersedes any prior understanding or written or oral agreements between the Parties respecting the within subject matter.
- 2.11 <u>Amendments</u>. In order to be binding, an amendment to this Agreement must be in writing, dated subsequent to the date of this Agreement, and executed by the Parties.

2.12 Withdrawal by Party.

- (a) <u>Voluntary Withdrawal</u>. Voluntary withdrawal by PARTICIPANT from the Agreement shall occur upon the affirmative decision by PARTICIPANT's Commissioners Court to withdraw from the Agreement and the withdrawing PARTICIPANT giving at least one hundred and eighty (180) calendar days' notice in writing to RPDO and the RPDO. The effective date of voluntary withdrawal shall be one hundred and eighty (180) calendar days after the withdrawing Participant gives written notice to RPDO.
- (b) <u>Involuntary Withdrawal</u>. PARTICIPANT shall be deemed to have involuntarily withdrawn from the Agreement upon the failure by the PARTICIPANT to pay any cost-sharing payment by the due date, as provided in a notice to the PARTICIPANT. PARTICIPANT shall be given thirty (30) days written

notice of non-payment by RPDO and shall not be deemed to be in default until the expiration of thirty (30) days after receipt of the written notice.

(c) In the event that PARTICIPANT withdraws under (a) or (b) and the RPDO is representing an individual or individuals after having been appointed by a court in PARTICIPANT'S county, beginning on the effective date of the withdrawal, PARTICIPANT shall be responsible for timely payment of \$150.00 per hour for the first chair attorney, \$125.00 per hour for the second chair attorney, \$60.00 per hour for the mitigation specialist and \$50.00 per hour for the investigator. Additionally, PARTICIPANT shall also timely pay upon receipt and documentation all investigative costs incurred by the RPDO including but not limited to travel, lodging, meals and records collection.

GUIDE FOR APPOINTMENTS TO THE TECHNICAL ADVISORY COMMITTEE

The Technical Advisory Committee (TAC) serves as an advisory group to the Transportation Policy Board (TPB). The TPB relies on the TAC to review technical information provided by the CAMPO staff or other relevant organizations to support the development of the Long-Range Plan, the 10-Year Program of Projects required by House Bill 20, and the Transportation Improvement Program. The TPB expects the TAC to provide recommendations to the TPB on a slate of transportation projects and activities upon completion of their review of all relevant technical information.

In order to ensure that the TAC functions as intended, it is important that each member jurisdiction of the TPB appoint TAC members and alternates that have the knowledge, experience, and responsibility to represent them. A TAC appointee and their alternate should hold a college degree and have substantial experience in civil engineering or transportation planning. Each TAC appointee and their alternate should also be a senior member of the organization and should have the level of responsibility to encumber public funds on behalf of the appointing jurisdiction. Most importantly, the TAC appointee and their alternate should have direct responsibility for the development and implementation of transportation projects.

Please find below a guide that may be used when considering the appointment of a TAC member. The guide gives some indication as to the level of responsibility a TAC appointee and their alternate should hold in their organization. The guide is not an exhaustive list. Ideally, a TAC appointee and their alternate will fall into one of the job titles (or a title closely equivalent) below:

Section I. Introductory and General Provisions

1. Declaration of Purpose

It is the purpose of this Policy to specify the general policies and procedures of Caldwell County relating to Road Districts, and replace any pre-existing rules or policies.

2. Definitions

In this Policy, the following definitions apply:

Affected City means an incorporated city or town that contains, or whose extraterritorial jurisdiction contains, territory that is included in a Proposed Road District;

Applicant means a Person applying for the creation of a Road District under this Policy;

Application means an application for the creation of a Road District under this Policy;

Appraised Value has the meaning defined for that term in Section 1.04 of the Texas Property Tax Code:

Average District Appraisal means the number obtained by dividing the aggregate appraised value of all taxable real property in a Proposed Road District by the total acreage in such district; Bond Issuance Costs means the costs incident to the issuance of Road District bonds, including, but not limited to the fees and expenses of bond counsel, any bond purchaser, underwriter, or placement agent and its counsel, any party, counsel or consultant rendering services in connection with the issuance of the Bonds, paying agent/registrar fees and printing expenses, as allowed by law and approved by the District;

Bonds means Road District Bonds, including any form of indebtedness a Road District may lawfully incur;

Commissioners Court means the Commissioners Court of the County;

County means the County of Caldwell, Texas;

District Attorney means the Criminal District Attorney of Caldwell County or his designated representative;

County Financial Advisor means the financial advisor retained by the County;

County Reviewing Authority means, all of the following: the County Judge, the District Attorney, the County tax assessor-collector, and the supervisor of each other County office, department, or division designated by the Commissioners Court, or their respective designated representative;

District Commissioner means each County commissioner in whose precinct a Road District or Proposed Road District is wholly or partially situated;

Estimate means an assessment of present conditions or a forecast or projection of anticipated future events or conditions, based upon reasonable assumptions;

Estimated Value of Right-of-Way means with respect to the right-of- way required for the improvements in any Proposed Road District, the product obtained by multiplying the Average District Appraisal by the total acreage required for such right-of-way and multiplying that

product by two, plus an amount equal to the estimated cost of affected improvements upon tracts of land needed for the right-of-way.

Improvements means the roads and other facilities authorized by the County Road and Bridge Act (TEX. REV. CIV. STAT. ANN. Article 6702-1, Vernon's Supplement 1988) to be financed with Road District Bonds;

Policy means the Caldwell County Road District Policy and Procedure as amended by the Commissioners Court;

Prescribed Debt Limit means the limit on the amount of Road District bonds prescribed by Section V.6 of this Policy;

Professional Service Agreement means an agreement entered into pursuant to Section VI.3 of this Policy;

Proposed Bonds means the Road District Bonds proposed to be issued to finance the Improvements specified in the Unified Report;

Proposed Improvements means the Improvements specified in the Unified Report that are proposed to be financed by Road District Bonds;

Proposed Road District means the Road District specified in an application that is proposed for creation by the County;

Proposed Roads means the roads specified in the Unified Report that are Proposed Improvements; **Right-of-Way Easement Acquisition Documents** means, collectively, the right-of-way easements, right-of-way letters of credit, and Right-of Way Title Deeds;

Right-of-Way Easement means any easement for right-of-way included in an application pursuant to Section III.7 of this Policy;

Right-of-Way Letter of Credit means any letter of credit, meeting County fiscal standards, securing the acquisition of right-of-way included in an application pursuant to Section III.7 of this Policy;

Right-of-Way Title Deed means any title deed to right-of-way included in an application pursuant to Section III.7 of this Policy;

Road District means a Road District created pursuant to the County Road and Bridge Act, Article 6702-1 V.A.T.S.;

Road District Bonds means Bonds authorized to be issued by a Road District under the County Road and Bridge Act, TEX. REV. CIV. STAT. ANN. Article 6702-1 (Vernons Supp. 1988)

Road District Operations Agreement means an agreement with a Road District entered into pursuant to this Policy;

Taxable Value means the total amount of value for which the tax rate would be applied for tax billing purposes by the taxing entity; and

Unified Report means the report on an application required under Section IV.6 of this Policy;

3. Timeliness of Actions

When this Policy requires the delivery, submission, or filing of an Application, notice, or other document within a specified period or before a specified deadline, the delivery, submission, or filing is timely, except as otherwise provided by this Policy, if the document is actually received by the appropriate Person within the period or before the deadline.

4. Delivering and Submitting Documents

When this Policy requires the delivery, submission, or filing of an Application, notice, or other document with a specified Person, a delivery, submission, or filing with an employee of the Person at the Person's usual place for conducting official business constitutes delivery, submission, or filing (as applicable) with the Person.

The Person to whom this Policy requires a delivery, submission, or filing to be made, may accept the document at a place other than the Person's usual place of conducting business.

Except as otherwise provided by this Policy, a delivery, submission, or filing of a document under this Policy may be made by personal delivery, mail, or any other method of transmission.

5. County Not Responsible for Costs

The County assumed no responsibility to pay or reimburse an Applicant, or any other Person for any costs incurred by such Person in connection with the Application, creation, or operation of a Road District or with the issuance of Road District Bonds. These costs are payable only from the proceeds of a Road District bond issue, as provided in Part IV of this Policy.

6. Control Over Road Districts

The Commissioners Court is the governing body of each Road District and shall control the activities and operation of each County Road District.

Section II. Road District Creation Procedure

1. Application Required

- a. The County shall not consider the creation of a Proposed Road District unless a complete Application is submitted in accordance with this Policy.
- b. The Applicant shall be a Person who owns property in the Proposed Road District, or the Person's authorized agent, and desires to finance improvements through the creation of the Road District.

2. Notice of Intent to Submit Application; Resubmission Conference

- a. An Applicant shall deliver written notice of his intent to submit an application to the County Judge at least 60 days before the date of submission of the Application. The applicant shall include a \$______ presubmission fee with the notice. The notice shall contain:
 - 1. the name, address, and telephone number of the Applicant;
 - 2. a map of the boundaries of the Proposed Road District;
 - 3. a general description of the Proposed improvements, locations for placement of the Proposed Improvements within the Proposed Road District, and a general estimate of the costs:

- 4. a general description of the plan of development and responsible parties for such development, if applicable;
 - 5. the aggregate amount of a proposed bond issue; and
 - 6. the number of owners of property in the Proposed Road District; and
- 7. the name, address and telephone number of all consultants and professionals the Applicant intends to engage and has engaged in connection with the preparation of the notice and Application.
- b. Upon receipt of the notice, the County Judge shall schedule a presubmission conference with the Applicant, the District Commissioner, and the District Attorney to occur within thirty days after the date of receipt of the notice, to discuss the application process and to identify any potential problems and issues concerning the Proposed Road District.
- c. Following the submission conference with the Applicant, the County Judge and/or Precinct Commissioner will confer with the Applicant as necessary concerning the proposed Application.
- d. The County Financial Adviser shall submit a written report to the Commissioners Court, within fourteen business days after the presubmission conference, regarding the proposed Application, the presubmission conference, and any subsequent discussions with the Applicant.
- e. Following the submission conference with Applicant, and submission of the County Financial Advisor's written report, the County Judge will place the notice on the agenda for a work session of the Commissioners Court.

3. Notice of Application to Property Owners and Lienholders

- a. At least 14 days before submitting an Application, the Applicant shall cause written notice, in form and content satisfactory to the District Attorney, of the Application to be delivered in accordance with subsection "c" below to each record owner and lienholder of real property in the Proposed Road District.
 - b. The notice shall contain:
 - 1. the name of the Proposed Road District;
 - 2. a statement that the addressee of the notice owns or holds a lien (as applicable) on real property in the Proposed Road District;
 - 3. a brief description of Proposed Improvements;
 - 4. a statement informing the addressee that the Proposed Improvements will be financed with Bonds issued by the Proposed Road District, and that the Bonds will be payable from taxes assessed against the real property in the district, and stating for the addressee the expected total bond authorization sought by the applicant, the total cost of Proposed Improvements, the expected date of the election on the Proposed Bonds and the expected date of issuance of the Proposed Bonds, and the expected tax rate necessary to pay such Bonds; and
 - 5. a statement informing the addressee of the expected date of submission of the Application for the creation of the Proposed Road District.
- c. The notice required by this section delivered by first class United States mail, certified mail, return receipt requested, is considered timely if deposited in the mail, postage prepaid and properly addressed, before the deadline specified by Subsection (a) of this section.

- d. The Applicant shall submit an affidavit upon filing an Application, stating that it has provided all owners and lienholders of real property within the Proposed Road District with notice in accordance with this section, and shall attach to the affidavit the receipts returned from the notices mailed as exhibits.
- e. Although all property owners and lienholders must receive notice pursuant to this Section II.3, the Commissioners Court may, in the exercise of its discretion, create the proposed district without consent of all property owners within the proposed district.

4. Application Fee

- a. The fee an Applicant will pay for submitting an Application is \$_____
- b. The fee will be allocated as follows:
- 1. \$_____to defray the cost of review of the application by the District Attorney;
- 2. \$_____ to defray the cost of review of the application by the County Financial Advisor; and
- 3. \$_____as the Commissioners Court may designate to defray other administrative costs.
- c. Any fees and expenses the County incurs in excess of amounts provided in Subsection (b) will be reimbursed by the Applicant in due course as provided in Section II.5.
- d. The Application fee must be paid by certified or cashier's check, payable to Caldwell County, Texas, at the time of submission of the Application.
- e. The Application fee is reimbursable to the extent permitted by law, from the proceeds of a proposed bond issue, if issued.

5. Reimbursement of Costs by Applicant

- a. Applicant must agree in writing to reimburse the County for all costs incurred by County and the County's consultants and professionals, as a consequence of the Application, the creation of the district and the offering, sale and issuance of Bonds, in excess of such costs that are not covered by the Application fee required in Section II.4.
- b. The reimbursement agreement required by this section shall be in form and content acceptable to by the District Attorney.

6. Submissions, Acceptance, and Filing of Application

- a. The Applicant shall submit 20 copies of the Application to the District Attorney.
- b. The District Attorney shall not accept an Application tendered for submission unless the Application;
 - 1. contains the information required in Sections III.2-III.7 of the Policy.
 - 2. is accompanied by the Application fee in the amount and in the form of payment required by Section II.4 of this Policy;
 - 3. is accompanied by the affidavit required by Section III.7 of this Policy; and
 - 4. is accompanied by the reimbursement agreement required by Section II.5 of this Policy.

- c. If an Application is determined to be incomplete, the District Attorney shall deliver a notice to the Applicant outlining the deficiencies in such Application. The District Attorney shall not accept an Application until the Applicant remedies all deficiencies outlined in the notice.
 - d. Upon acceptance of an Application, the District Attorney:
 - 1. shall file a copy of the Application with the County Clerk. The copy shall be retained by the County Clerk as a permanent record; and
 - 2. shall immediately deliver the Application fee to the County Treasurer for deposit in a current restricted account established for the Proposed Road District.

7. Improper Representations by Applicant

Neither an Applicant nor the Applicant's representative(s) shall make any representation, directly or indirectly, to any lender, contractor, or any other Person engaging in or contemplating a business relationship with the Applicant:

- 1. before the Proposed Road District has been created, that suggests the Commissioners Court has agreed or in any way committed to approve the Application or create the Proposed Road District; or
- 2. concerning any matter in connection with the Application that is contrary to the information contained in the Application.

Section III. Contents of Application

1. Requirements for Complete Application

To be complete, an Application must contain the components required under Sections III.2 through III.7 of this Policy, be accompanied by a cover letter assessing the adequacy of the Proposed Road District by addressing each of the criteria listed in Section V.1, and must be in form and content acceptable to the District Attorney.

2. Summary of Basic Information

An Application shall contain a summary of basic information concerning the Proposed Road District, as follows:

- 1. the proposed name of the Road District;
- 2. the name, address, and telephone number of:
 - A. the Applicant;
 - B. the Person acting as the Applicant's agent (if any) in the application process;
- C. each consultant or professional engaged, or proposed to be engaged, by the Applicant in connection with the creation of the Proposed Road District.
- D. a general, narrative description of the Proposed Road District, of the proposed improvements therein, and of the financing for the Proposed Improvements, including the following:
 - i. the total area and net taxable are of the Proposed Road District in acres;

- ii. the names, acreage owned and number of owners of real property in the Proposed Road District;
- iii. the names and addresses of all registered voters of the Proposed Road District; and
- iv. the benefit the Proposed Improvements would provide the Proposed Road District, and the County;
- 3. if the Applicant proposes that the Proposed Road District purchase partially or totally complete Improvements with the proceeds of a Road District bond issue, a statement of such intent.

3. Creation Engineering Report

An Application shall contain a creation engineering report, prepared by a registered professional engineer, who has affixed his seal to the report, which contains the following;

- 1. a map showing the location of the Proposed Improvements in relation to any County or Area Transportation Plan and showing the existing roads and mass transit network in the Proposed Road District up to a distance of two miles from the district boundary line of the Proposed Road District (measured along an imaginary straight line perpendicular to the boundary line);
 - 2. a site location map of the Proposed Road District;
- 3. a topographical map of the Proposed Road District, with scale no less than one inch for every 400 feet with contour intervals not to exceed 10 feet, showing the following:
 - A. the boundaries of the Proposed Road District and the boundaries of each other taxing unit that intersect or coincide with the boundaries of the district;
 - B. the name of each owner of real property in the Proposed Road District, the boundaries and area of the property owned by such owner;
 - C. the existing:
 - i. arterial roads;
 - ii. collector roads; and
 - iii. bridges, major drainage facilities, and other structures
 - iv. an identification of the existing and approved real estate developments that might be affected by the Proposed Improvements;
 - v. the location of the 100-year flood plain and watershed boundaries;
 - vi. three locations within the Proposed Road District most likely to provide notice to residents of the Proposed Road District if a notice were posted.
- 4. a preliminary estimate (showing the assumptions upon which the Estimate is based) of the acquisition cost of the right-of-way for the Proposed Improvements, itemized, for both in the following categories: drainage facilities, bridges, roads, utility relocation, and miscellaneous features;
- 5. an on-the-ground metes and bounds description of the territory proposed to be contained within the Proposed Road District, accompanied by closure sheets, prepared by a registered professional surveyor, with seal impressed thereon; and
- 6. environmental considerations regarding the construction, maintenance and operation of Proposed Road District improvements, and the studies upon which the considerations were based.

4. Market Study

The Applicant shall submit a market study which projects probable value of the land within the Proposed Road District for the succeeding twenty-five year period. The study shall be conducted and prepared by a professional firm recognized in the field of real property appraisal, market analysis, and demographics. The study shall consider all factors affecting the potential value of the land within the district including, but not limited to: the plan of development, restrictive ordinances, competitive forces and regional peculiarities.

5. Development Plan and Applicant/Developer Qualifications

The Applicant shall furnish:

- 1. a copy of maps, plats, and other visual and written materials which will display the preliminary plan of development for properties within the Proposed Road District which is expected to produce the anticipated Taxable Value. Such preliminary development plan shall be in sufficient detail to relate it to the other elements of the Application;
- 2. a resume for all persons responsible for carrying out the development plan including information as to the experience of such Persons in connection with development work of similar scope of complexity; and
- 3. information on the financial ability of such persons to carry forward the plan of development and to pay the taxes expected to be levied on the properties such persons may own within the Proposed Road District.

6. Notice to Future Property Owners

- a. An application shall contain the following documents to provide for notice to future owners of real property within the Proposed Road District: An agreement executed by all property owners in the Proposed Road District, in the form and content acceptable to the District Attorney, stating that the property is located within a Road District.
- b. The notice required by Section III.6.a shall be held in escrow by the District Attorney, until the Proposed Road District is created. If such district is created, the District Attorney, at the Applicant's expense, shall record such notice in the deed records of the County.
- c. The day an Applicant files an Application with the District Attorney, he shall place an advertisement in a newspaper of general circulation in the area where the District is proposed notifying the general public of the filing of the Application.
- d. Each landowner in a Proposed Road District shall submit an affidavit stating he will provide, within any contract, notice of the Proposed Road District to any party he enters into negotiations with for the sale of the property within the Proposed Road District.

7. Miscellaneous Application Components

An Application shall contain the following:

a. a petition for the creation of the Proposed Road District, addressed to the Commissioners Court and is signed by all persons owning real property in the proposed district who

are requesting its creation. The petition must contain, for each signing property owner, the owner's name (in printed or typed form), residence address and the amount of acreage owned;

- b. a certification form the central appraisal district of both the Appraised Value and the Taxable Value of all real property in the Proposed Road District;
- c. a list furnished by a title insurance company of the names of all the records owners and lienholders of the real property in the Proposed Road District;
- d. a brief narrative stating the reasons for creating the Proposed Road District and showing that the Proposed Improvements are feasible and will benefit all the taxable real property in the Proposed Road District;
- e. a letter of credit, except as provided in Section III.7.e.11, below, to secure the acquisition of right-of-way in the Proposed Road District, in an amount equal to the Estimated Value of Right-of-Way.
 - 1. The Right-of-Way Letter of Credit is not required to cover the Estimated Value of Right-of-Way of the right-of-way that is to be donated for the Proposed Improvements to the extent that the Application included:
 - A. title deeds to the donated right-of-way; or
 - B. blanket easements for right-of-way to be more accurately defined upon completion of engineering design of the improvements
 - 2. The Right-of-Way Acquisition Documents shall be held in escrow by the County, in the custody of the District Attorney, pending disposition as provided in Part III of this Policy Statement.
 - 3. If an Application is withdrawn or the Proposed Road District is not created, the Right-of-Way Acquisition Documents shall be returned to the Applicant.
 - 4. Any combination of the above Right-of-Way Acquisition Documents acceptable to the District Attorney shall be acceptable to fulfill the requirement of this subsection.
 - f. a statement by the Applicant that the Applicant will comply with this Policy;
- g. a sworn affidavit stating that the Applicant has complied with the requirements of Section II.3;
 - h. any other item specifically required by the County Judge and the District Attorney.

Section IV. Review of Application Prior to Commissioners Court Consideration

1. Distribution of Application

Upon acceptance of the submission of an Application, the District Attorney shall distribute one copy (except as otherwise indicated below) of the Application to each of the following Persons and retain any remaining copies:

- 1. County Judge;
- 2. each County Commissioner;
- 3. County Tax Assessor-Collector;

- 4. County Auditor;
- 5. County Financial Adviser;
- 6. District Engineer of the Texas State Department of Highways and Public Transportation; and
 - 7. City Manager of any Affected City (3 copies);

2. Report of County Financial Advisor on Application

Upon receipt of an Application from the District Attorney, the County Financial Adviser shall review the Application and furnish a written report on it to the Commissioners Court which shall include the following:

- 1. a feasible plan of financing;
- 2. the impact of the plan of financing upon the credit of the County and its credit rating and upon any present or future bond issues anticipated by the County;
- 3. the effect of the Proposed Road District debt and tax rate on individual taxpayers within the Proposed Road District when added in conjunction with tax levies by other overlapping jurisdictions; and
- 4. a statement that, in the opinion of the County Financial Adviser, the Proposed Road District, if created and financed as proposed, will be financially viable and is not expected to affect adversely either the general credit of the County or the ability of the County to proceed with its overall operation in a financially sound and timely manner.
- 5. The report of the County Financial Adviser shall be delivered to the County Judge not later than the 15th working day after the date of the County Financial Adviser received the Application.

3. Reports of County Reviewing Authority on Application

- a. Upon receipt of an Application, each member of the county Reviewing Authority shall review the Application and may prepare a written report on the Application addressed to the Commissioners Court.
- b. A report may comment on such matters as the member considers appropriate and shall comment on any matter specifically requested by the Commissioners Court.
- c. A County Tax Assessor-Collector's report shall include one analysis showing any property, within the County owed by the Applicant or its principals, which may show a record of being delinquent in property tax payment.
- d. Each member of the County Reviewing Authority (other than the County Judge) shall deliver its report to the District Attorney not later than the 15th working day after the date the authority received the Application.

4. Participation by Affected Cities, State Authorities

a. The city manager of any Affected City and the Texas State Department of Highways and Public Transportation District Engineer (with jurisdiction in the County) may each submit a report on an Application to the County Judge.

- b. Each city manager's report and the District Engineer's report shall be addressed to the Commissioners Court and may cover any matter regarding the Application that the City Manager or District Engineer, respectively, considers appropriate.
- c. The District Attorney shall include each city manager's and the District Engineer's report in the Unified Report if those reports are received by the County Judge in time to be so included. Otherwise, the District Attorney shall deliver, promptly upon receipt, a copy of each city manager's or district engineer's report to the County Judge, each County Commissioner, the County Clerk, and County Financial Adviser.

5. Consultation on Application

The District Commissioner, the County Judge, the other County Reviewing Authorities and the County Financial Adviser shall advise and consult with each other and the Applicant, as appropriate, in an effort to identify and correct any deficiencies in an Application.

6. Unified Report on Application

- a. The District Attorney shall compile or reference and attach the County Reviewing Authorities' respective reports on an Application into a single, unified report addressed to the Commissioners Court, providing an analysis of the reports and comments received.
- b. Each County Reviewing Authority shall make such revisions in its report as are necessary to finalize the Unified Report for timely submission to the Commissioners Court.
- c. The District Attorney shall deliver a copy of the Unified Report to each County commissioner and the applicant, not later than the 10th working day after the date that the District Attorney receives the last report.

7. Coordination by the County Judge

The District Attorney shall coordinate the activities of the County Reviewing Authorities under this Subpart C in an effort to achieve the timely delivery of the Unified Report to the Commissioners Court.

8. Revision of Application Prior to Commissioners Court Consideration

- a. After an Application has been submitted, the Applicant may revise the Application, as provided by this section.
- b. Before an Application may be revised, the form and content of the proposed revision must be approved by the District Attorney and by the County Financial Adviser.
- c. After the required approval of a proposed Application revision is obtained, the Applicant shall deliver _____ copies of the revision to the District Attorney and one to the County Clerk. Upon receipt of the copies, the District Attorney shall distribute them to the same Persons as are required by Section IV.1 of this Policy to receive copies of the Application upon its original submission.
- d. If a proposed Application revision is approved, the County Reviewing Authorities and the County Financial Adviser shall make corresponding revisions to their respective reports

and opinions on the application that are necessitated by the revision, and the District Attorney shall do likewise with respect to the Unified Report.

Section V. Creation of a Road District

1. Criteria for Road District Creation

- a. Upon consideration of an Application, the Commissioners Court, in the exercise of its discretion and in accordance with law, may create the Road District as proposed.
- b. In determining whether to create a Road District, the Commissioners Court will consider the following criteria:
 - 1. the Proposed roads are highways or arterials designated by the Area Transportation Plan.
 - 2. the Proposed Road District will be able to meet its financial obligations, including the payment of the Proposed Bonds, at a reasonable cost to the affected taxpayers;
 - 3. the plan of financing the Proposed Improvements complies with the Prescribed Debt Limit or with any increase in the Prescribed Debt Limit approved by the Commissioners Court;
 - 4. the County or other affected governmental entity will be able to maintain the Proposed Improvements;
 - 5. opposition to the creation of a Proposed Road District by Persons owning real property within the boundaries of the Proposed Road District;
 - 6. all taxable real property in the Proposed Road District will be benefitted by the Proposed Improvements, if created;
 - 7. all benefitted real property adjacent to the Proposed Improvements is included in the Proposed Road District;
 - 8. the Proposed Improvements will provide an efficient enhancement to the County's road system;
 - 9. the Application complies with this Policy;
 - 10. the extent to which the right-of-way for the Proposed Improvements is to be donated for that purpose;
 - 11. anticipated environmental impact;
 - 12. relative need for the Proposed Improvements in relation to their cost;
 - 13. priority of the Proposed Improvements in relation to other roads proposed or scheduled for improvement within the County; and
 - 14. a road district is the most appropriate method of financing for part or all of the Proposed Improvements;

2. Commissioners Court Work Session on Application

a. Upon receipt of a Unified Report, the County Judge will place the application referenced in the Unified Report on the agenda for a work session of the Commissioners Court.

The County Judge may place a notice of the work session in a newspaper of circulation within area where the Proposed Road District will be located.

- b. The Applicant shall brief the Commissioners Court on the Application in work session. The County Judge shall then brief the Commissioners Court on the Unified Report. If requested, the County Reviewing Authorities and County Financial Adviser shall comment on the Application in work session.
- c. The Commissioners Court cannot take actions on the creation of a Proposed Road District in work session.

3. Modification of Application and Reports Following Work Session

- a. After the Commissioners Court completes its review of an Application in work session, the Applicant shall modify the Application as requested by the Commissioners Court. The County Reviewing Authorities and the County Financial Adviser shall make corresponding modifications in their respective reports and opinions, if requested by the Commissioners Court. The District Attorney shall also modify the Unified Report to reflect such change.
- b. If, after the Commissioners Court completes its review of an Application in work session, the Applicant chooses to make substantive modifications to the Application, it must submit the revised Application in accordance with Section II.6 of this Policy. The County Reviewing Authorities and County Financial Adviser shall make corresponding modifications in their respective reports and opinions. The District Attorney shall modify the Unified Report to reflect such change. Upon receipt of the amended Unified Report, the County Judge will place the Application on the agenda for work session of the Commissioners Court.

4. Action on Application by Commissioners Court

- a. After the Commissioners Court completes its review of an application in work session, the County Judge may place the Proposed Road District on the agenda for a Commissioners Court meeting as an action item.
- b. The Commissioners Court will consider the Application and do one of the following:
 - 1. by written order, create the Proposed Road District;
 - 2. postpone taking action on the Application;
 - 3. Deny the Application; or
 - 4. Take no action on the Application.

5. Use of Estimated Appraisals to Determine Compliance with Debt Limit

If the Commissioners Court is considering creation of a Proposed Road District before the time that a periodic reappraisal, for property tax purposes, of property in the Proposed Road District is to occur, and the time of issuance of the Proposed Bonds is expected to occur after the periodic reappraisal is completed, then, in determining whether the plan of financing the Proposed Improvements complies with the Prescribed Debt Limit, the Commissioners Court, in its discretion, may consider a written Estimate, if available, from the central appraisal district, of the

Appraised Value and Taxable Value expected to be applicable to the real property in the Proposed Road District at the expected time of issuance of the Proposed Bonds.

6. Indemnification Fee

- a. Before a Commissioners Court will consider the creation of a Road District, the Applicant shall pay an indemnity fee either in the amount of \$______ or in the amount equal to 1/10 of 1 percent of the aggregate principal amount of the Proposed Bonds, whichever is greater.
- b. The indemnity fee shall be paid by certified or cashier's check, payable to the County.
- c. The indemnity fee shall be delivered to the County Treasurer who shall deposit it into a current restricted account separate from all other County funds. The moneys on deposit in this account shall be used only for the purpose of indemnifying the County and the members of the Commissioners Court (past and present) for any cost, liability, or damage (including attorneys' fees) arising from or incurred as a result of the creation, operation or administration of any Road District and the offering, sale and issuance of any Road District Bonds.
- d. The indemnity fee is not reimbursable from County or Road District funds (including the proceeds of any Road District Bonds).

7. Indemnification by Applicant

- a. In addition to any other indemnification required by this Policy, the Commissioners Court, in its discretion, may condition its creation of a Road District on the Applicant agreeing in writing, to indemnify the County, the Commissioners Court (collectively and individually), all other County officers, all County employees and its employees and agents for any cost, liability, or damage (including attorney's) fees arising from or incurred as a consequence of the Application, the creation or administration of the Proposed Road District, or the offering, sale, or issuance of the Proposed Bonds.
- b. The Commissioners Court may require that the indemnification referenced in Subsection (a) of this Section be provided by an insurance provider acceptable to the Commissioners Court. The form and content of the agreement providing insurance shall be acceptable to the District Attorney.

8. Road District Operations Agreement

- a. The Commissioners Court may require, as a condition of the creation of a Proposed Road District or of the issuance of Proposed Road Bonds, that an Applicant enter into an agreement with the district, that governs the rights and responsibilities of the parties with respect to any aspect of the Application, creation or operation of a Road District, issuance of Bonds, acquisition or construction of improvements within a Road District, payment of Bond Issuance Costs or other costs and expenses incurred in connection with the creation or operation of a Road District, indemnification or any other matter deemed appropriate by the Commissioners Court.
- b. The District Attorney shall approve of the form and content of the Road District Operations Agreement prior to its execution.

Section VI. Acquisition and Construction of Road District Improvements

1. Payment for Road District Improvements

The costs of Road District Improvements are payable from the proceeds of Bonds issued to finance such improvements and from no other County source.

2. Conveyance of Right-of-Way

- a. The right-of-way for Road District improvements must be conveyed to the County pursuant to agreements, in form and content acceptable to the District Attorney. The conveyance of right-of-way must be accompanied by a title insurance policy covering the property conveyed, that is acceptable to the District Attorney and to the Commissioners Court.
- b. A conveyance of right-of-way for Road District improvements must be free and clear of any indebtedness.
- c. Right-of-Way Acquisition Documents may be removed from escrow and recorded at any time after the Road District closes its first issue of Bonds. The District Attorney will provide 30 days' notice of his intent to record the grantor's Right-of-Way Easement to allow the grantor, during that 30-day period, to substitute right-of-way deeds. Any Right-of- Way Acquisition Documents no longer required will be returned to the grantors upon completion of the acquisition or conveyance.

3. Professional Service Agreements

- a. Upon creation, or as soon thereafter is practicable, the Road District shall enter into Professional Service Agreements with a bond counsel, an underwriter or any other professional or consultant the Commissioners Court deems necessary, for any and all work to be performed on behalf of such district after creation. The Road District will not pay for services or materials provided in connection with the Road District after creation, unless the provider of such services or materials enters into an Agreement with the District.
- b. It is within the discretion of the Commissioners Court to enter into a Professional Service Agreement with any Person.
- c. The form and content of a Professional Service Agreement shall be acceptable to the District Attorney.

4. General Supervision

Except as otherwise provided in a Professional Service Agreement, the acquisition and construction of Road District Improvements are under the general supervision of the Caldwell County Sanitation Department and County Engineer.

5. Inspecting and Testing

- a. Caldwell County may inspect the site of Road District Improvements at such intervals as the County Engineer considers appropriate for proper supervision of the acquisition and construction of the Improvements.
- b. Caldwell County may conduct such tests with respect to construction methods and materials for Road District Improvements as the County Engineer determines appropriate and may review the results of tests conducted by others in connection with the acquisition or construction of Road District Improvements.

6. Non-Compliance with Plans and Specifications

- a. If the County Engineer determines that Road District Improvements have not been acquired or constructed in compliance with their plans and specifications, the County Engineer shall deliver notice of the noncompliance to the District Commissioner and the Person responsible for the noncompliance.
- b. If noncompliance with Road District improvement plans and specifications is not corrected, or, if the County Engineer determines that it is unlikely to be corrected within a reasonable time, the County Engineer shall advise the commissioners Court of the noncompliance. The Commissioners Court may request the District Attorney to take appropriate legal action or may take any other action that the court determines appropriate to resolve the matter.

7. Quality Control Consultant

- a. A Road District may retain a quality control consultant who is qualified in the field of construction quality control inspection and testing. The scope of services to be performed by the quality control consultant shall be subject to the approval of the Commissioners Court, consistent with this section.
- b. The scope of services to be performed by a quality control consultant shall require quality control testing of materials and installations that meets the minimum requirements for sampling and testing as detailed in the Construction Manual of the Texas State Department of Highways and Public Transportation.
- c. The Quality Control Consultant shall employ one or more resident construction inspectors whose qualifications are acceptable to the Commissioners Court.
- d. The fees of a quality control consultant shall be paid from the proceeds of the Bonds issued to finance the Improvements inspected and tested.

8. County Fee

a. The Road District shall pay a fee for the County's services rendered in connection with the acquisition and construction of Road District improvements, in an amount equal to one-half of one percent of the aggregate principal amount of the bonds issued to finance the Improvements and is in addition to the fee received pursuant to Section II.4 of this policy. In any event, such fee shall be reasonable in relation to the work performed by the County. The Commissioners Court may waive any portion of the fee determined to be unreasonable.

- b. Except as provided by Subsection (c) of this section, the County's fee is payable from the proceeds of the Bonds issued to finance the Improvements with respect to which of County's services are rendered.
- c. If the acquisition or construction of Road District improvements begins before the Bonds financing those improvements are issued, an Estimate of the County's fee, as determined by the County Engineer, must be paid, upon the County Engineer's request, before the Improvements. The amount paid as the estimated fee shall be adjusted if the Bonds are issued in an aggregate principal amount different from that upon which the estimated fee was based, by either a reimbursement from the County of overpayment or a payment as applicable, at the time the Bonds are issued.

9. Attorney's Fees

- a. The Road District shall pay fees for any attorney's services rendered in connection with the acquisition and construction of Road District improvements and review of bond offering documents, at an hourly billing rate. The District Attorney or any other counsel retained by County shall keep careful records of time required to perform services for the Road District pursuant to this policy. The District Attorney shall charge an hourly fee comparable to those fees charged by private counsel of similar expertise, in addition to the fee received pursuant to Section II.4 of this policy. In any event, such fee shall be reasonable in relation to the work performed by the District Attorney.
- b. The District Attorney's fee is payable from the proceeds of the Bonds issued to finance the improvements with respect to which of the County Attorney's services are rendered.

Section VII. Road District Bonds

1. Bond Election

The Commissioners Court may order a bond election pursuant to the requirements of the County Road and Bridge Act, Texas Revised Civil Statutes Annotated. Article 6702-1 (Vernon Supp. 1988) upon a uniform election date.

2. Request for Bond Issuance

- a. Thirty (30) days after holding a successful bond election, any landowner in the Road District may submit a formal request to the District Commissioner requesting a bond issuance. The District Commissioner shall request a work session for the Road District and request the attendance of the County Financial Adviser, the District Attorney, the County Judge, and any other advisor he determines necessary.
- b. If the Commissioners Court determines a bond issuance to be practicable, they may retain the services of an underwriter or instruct the County Financial Adviser to begin preparation of offering documents.

3. Review and Advice of District Attorney

- a. For each issue of Road District Bonds, the District Attorney shall review the order calling the election, the order authorizing the sale and issuance of Bonds, any bond offering document, closing documents, and all other documents executed or delivered in connection with the issuance of the Bonds before such documents are executed or delivered. A copy of each aforementioned documents shall be delivered to the District Attorney not later than the 14th day before the date scheduled for execution or delivery, as applicable.
- b. The District Attorney shall advise the Commissioners Court on matters in connection with the issuance of Road District Bonds as requested by the Commissioners Court including: choice of Bond Counsel, price to be negotiated for the services, and the scope of the review necessary.

4. Review and Opinion of County Financial Advisor

- a. Prior to each sale of the District's Bonds or notes, the County Financial Adviser shall review information pertaining thereto and furnish the Commissioners Court with his opinion regarding advisability of such sale. The information to be reviewed and used as a basis for such bond counsel, opinion may be that provided by managing underwriters, market research analysts, engineers and other consultants retained by the Road District.
- b. Topics addressed by the County Financial Adviser's opinion regarding each such bond issue should include:
 - 1. the financial feasibility of the proposed issue in terms of the current market for such securities and the plan financing proposed at the time of creation or subsequent plans of financing adopted by the district;
 - 2. the impact of the proposed bond issue and the plan of financing of which it is a part upon the credit of the County and its credit rating and upon pending or future bond issues which may be needed by the County;
 - 3. the effect of the proposed district debt and tax rate for individual taxpayers within the Road District in addition to tax levies by other overlapping jurisdictions; and
 - 4. a method of selling such Bonds which will enable the Road District to secure needed funds at favorable interest rates for minimal costs and result in reasonably tax rates.
- c. Within 15 working days after the County Financial Adviser secures all needed information from the district's consultants, they shall render their written opinion to the commissioners Court based on such findings on the following:
 - 1. that the proposed bond issue can or cannot be sold in a manner consistent with the district's current plan of financing;
 - 2. that the proposed bond issue will or will not adversely affect the County's credit or credit rating; and
 - 3. that the proposed bond issue will or will not adversely affect the County's ability to conduct its overall operations in a financially sound and timely way.
 - 4. any other matters which the County Financial Adviser deems important.

5. Limit Placed on Amount of Bonds

Due to restrictions placed on unlimited tax debt of counties by Texas Constitution Article III, Section 52, the Court shall not issue District Bonds which would cause the aggregate principal amount of Road Bonds outstanding for the County Road District, at any time, to exceed 20 percent the Taxable Value of the real property in such Road District.

6. Payment for Bond Issuance Costs

- a. Bond Issuance Costs are payable by a Road District from the proceeds of the Bonds of such issue and from no other County source.
- b. The Road District shall pay the costs of issuance associated with a Road District as soon as practicable after the issuance of the Bonds.

7. Opinions of Counsel

As a condition to the issuance of Road District Bonds, the Commissioners Court, on the advice of the District Attorney, may require such opinions, addressed to the Commissioners Court, from bond counsel, purchaser's, underwriter's, or placement agent's counsel, developer's counsel, or counsel to any other person involved in the issuance of the Bonds as the Commissioners Court considers necessary or appropriate for the proper issuance of the Bonds.

8. Bond Offering Documents

- a. At the time any bond issue for the Road District is proposed, the official statement or limited offering memorandum, and other disclosure document covering such sale shall be prepared by the managing underwriter for the district under the guidance of and subject to approval by the County Financial Advisor. Such guidance and approval shall be in addition to other reviews and approvals specified in these rules. The District Attorney in scheduling such bond sales and, subject to the orders of the Commissioners Court, shall represent the Road District in all negotiations with underwriters participating in negotiated sales of the district's securities.
- b. Before Road District Bonds are issued, the Commissioners Court may require the purchaser, underwriter, or placement agent, as applicable, to deliver a certificate, or counsel for that party to deliver an opinion, in either case acceptable to the Commissioners Court to the effect that the offering document, or such portions thereof as the Commissioners Court may specify does not contain any untrue statement of a material fact or omit to state any material fact necessary to make the statements contained therein, in light of the circumstances under which made, not misleading.
- c. A disclosure document for Road District Bonds shall contain statements (in each case acceptable to the County Financial Adviser) to the effect that:
 - 1. the Bonds are not obligations of the County, the State of Texas, nor any political subdivision except the Road District and that neither the faith and credit nor the taxing power of the county, the State of Texas, nor any political subdivision except the Road District is pledged for the payment of the Bonds; and

- 2. neither the County nor the Road District makes any representation regarding the market value of the property in the Road District or regarding the ability of any taxpayer to pay taxes assessed against the taxpayer.
- d. A disclosure document shall contain, in addition to any material required by this section, such statements and disclaimers with respect to the responsibility of the Road District for information contained in the document as the Commissioners Court, on the advice of the District Attorney, may require.

9. Amount, Terms, and Method of Sale of Bonds

The principal amount and terms of Road District Bonds and the method of their sale (whether competitively bid public offering, negotiated sale, or otherwise) shall be as approved by the Commissioners Court.

10. Indemnification by Underwriter or Placement Agent

- a. In addition to any other indemnification required by this Policy, as a condition for the issuance of Road District Bonds, the Commissioners Court may require the underwriter or placement agent for the Bonds to agree in writing to indemnify the County, the Road District, the Commissioners Court (collectively and individually), all other County and Road District officers, and all other County and Road District employees and agents for such cost, liability, or damage (including attorney's fees) as the Commissioners Court may specify in connection with the placement, offer for sale, or the sale of the Bonds, as the case may be.
- b. The form and content of an indemnification agreement under this section shall be as acceptable to the District Attorney.

11. Reimbursement of Creation Costs and Expenses from Bond Proceeds

- a. All payments made by the Applicant to the County under Section II.4 and Section II.5 shall be reimbursed by the district from bond proceeds as soon as practicable after Bonds are issued and delivered.
- b. All costs and expenses the Applicant incurs with respect to the preparation, submission, and court-directed amendments to the Application or any costs related thereto, to the date of creation, shall be reimbursed from bond proceeds to a maximum amount of \$45,000.00 providing:
 - 1. such costs and expenses were required to be incurred under the provisions of this Policy;
 - 2. such costs and expenses are reasonable for the services performed and materials provided;
 - 3. such costs and expenses have been paid by the Person requesting reimbursement as evidenced by a detailed statement of the services and materials provided and cancelled checks for the payment of such statements; and
 - 4. such costs and expenses of Applicant's attorney's fees are reasonable; however, in no event, shall such costs and expenses represent amounts:

- A. paid by Applicant which were incurred for work performed solely in representing the interests of the Applicant;
- B. paid by Applicant pursuant to a contract with fees calculated to be a percentage of the bond proceeds; or
- C. paid by Applicant to represent the Applicant's interests in lobbying or persuading members of the Commissioners Court or a member of the County Reviewing Authority to waive or alter any requirements under this Policy; and
 - D. such costs and expenses are approved by the Commissioners Court.
- c. An Applicant may petition the Commissioners Court to consider expenses above the \$45,000.00 maximum amount, provided the Commissioners Court has previously authorized such expense to be incurred and the expense meets the criteria otherwise required within this section.
- d. Three copies of all requests for reimbursement under (b) above will be submitted to the District Attorney who will distribute one copy to the County Auditor and one copy to the County Judge. Requests for reimbursement of attorney's fees should be accompanied by an invoice to Applicant reflecting the hourly amounts billed and the type of work performed on each specific date when service was performed. The District Attorney shall review each request and, after consultation with the County Auditor, shall report to the Commissioners Court on whether the request complies with this section and whether the request for reimbursement should be approved by the Commissioners Court.

12. District Purchase of Existing Improvements

The Road District may, in its discretion, purchase existing improvements or work product with bond proceeds only if:

- 1. the cost of such improvements or work product is reasonable;
- 2. the purchase of such improvements or work product is approved by the Commissioners Court and in accordance with applicable law.

Section VIII. Miscellaneous Provisions

1. Discretion of Commissioners Court

a. The Commissioners Court, to the extent permitted by law, shall have sole discretion over the actions of all Road Districts created under this Policy including the discretion to call bond elections and to issue Bonds of a Road District. The Commissioners Court also may provide in any order it adopts in relation to a Road District, that any future action of the court shall be considered upon the occurrence of such events as the court may deem appropriate.

2. Effective Date of Policy Statement; Applicability to Pending Applications

a. The effective date of this Policy shall be as specified in the action of the Commissioners Court adopting this Policy.

b. This Policy is applicable to any Application that is pending or any Road District awaiting Bond Election or Issuance on the effective date of this Policy.

3. Road District Review

A Road District which has been created and has not held a bond election within one year, or which has held a bond election and has not issued Bonds within one year, shall be assessed by the Commissioners Court as soon thereafter as practical to determine whether the Road District should be abolished.

The Applicant will be notified of a Public Hearing so he may appear to address the criteria in Section V.1 of this Policy.

Should the Commissioners Court determine the Road District should no longer exist, it shall abolish the Road District pursuant to state statute. Should the Commissioners Court determine the Road District shall continue, the Review shall occur each year thereafter until bonds are issued.

4. Amendment of Policy

- a. The Commissioners Court, in its discretion, may amend any provision of this Policy after a public hearing on the proposed amendment. A public hearing is not required in case of emergency or grave public necessity.
- b. The effective date of an amendment to this Policy shall be as specified in the action of the Commissioners Court adopting such amendment. Unless otherwise stated in such action, the amendment is applicable to any Application pending on the effective date of such amendment.

5. Waiver of Policy

The Commissioners Court, in its discretion, may, on the vote of three (3) members, waive the applicability of any provision of this Policy after the waiver is submitted by the affected person in written form and is discussed at a public hearing. The Commissioners Court may waive the requirement of a public hearing only in the case of an emergency or grave public necessity.

GENERAL

This Engineering Summary Report (ESR) accompanies the Plat for the proposed Meridian Estates Subdivision. This ESR was prepared in accordance with the Caldwell County Subdivision Ordinances. The proposed subdivision consists of approximately 44 acres, according to the plat prepared by JDS Surveying, Inc. The site is located on the southeast side of Plant Road, east of the intersection between Plant Road and Meridian Lane in Caldwell County, Texas. The site is not located within the city limits or extra-territorial jurisdiction (ETJ) of any municipality.

The site consists of approximately 44.17 acres and is currently undeveloped with no sizeable man-made structures. Out of the 44.17 acres, 1.35 acres is being dedicated to Caldwell County for public right-of-way. The proposed subdivision consists of 20 lots. The proposed lot lines are shown on the plat.

SITE CHARACTERISTICS

The overall site is gently to moderately sloping to the east/southeast and is divided into two drainage areas, DA-1 and DA-2. Drainage on the site is a combination of sheet flow, shallow concentrated flow and channel flow.

The proposed development will consist of creating twenty single family residential lots. The minimum lot size is 1.00 acre, the largest lot size is 5.51 acres, with the majority of the lots being in between 1.00 acre and 1.78 acres. All lots meet the minimum required lot size for lots with public water supply and private on-site sewage facilities (OSSFs). All lots have adequate roadway frontage onto Plan Road or Meridian Lane and are able to meet the required driveway separation distances.

ROADWAYS AND DRAINAGE

The site fronts CR 116 (Plant Road) and CR 117 (Meridian Lane). All lots have adequate roadway frontage for residential driveways and are able to meet the required driveway separation distances per Caldwell County. No internal roadways or drainage structures are proposed for the subdivision, only private residential driveways.

A drainage analysis was performed by Kevin Ware, PE, for the proposed subdivision. This analysis estimated approximately 4,000 sf of new impervious cover per lot for single family residences and associated driveways, etc. The drainage analysis is included as Appendix A of this report. The evaluation performed by Mr. Ware indicated that on site detention is not required for the subdivision. The Drainage Area Map,

Figure 1, included in the drainage analysis, shows the proposed lot lines, the site topography, as well as the drainage basin areas and any drainage easements. We are requesting a Detention Waiver since the development will result in less than 15% impervious cover. Any stormwater conveyances required (other than driveway culverts) will be via open swales.

Minimal grading will take place on site to accommodate the residences and the driveways. No regrading at the site is included as part of the project. There is a portion of the property within the FEMA Flood Hazard Boundary, Zone A, an area subject to a 0.1% annual chance of flooding, as per FEMA Flood Insurance Rate Map Community Panel No. 48055C0355F, effective date December 30, 2020.

Since no internal roads or utilities are being constructed there will be no erosion control required by the developer. As each of the lots are developed with houses and utilities (water services and OSSF/ septic) temporary erosion controls need to be in place on each lot to prevent off site transport of sediment. The temporary erosion controls need to remain in place until the disturbed areas have been revegetated and the vegetation is established over 90% of those areas.

UTILITIES

Water will be provided to the site by Maxwell Water Supply. There is no municipal wastewater service available to the site. The lots will be served by individual on-site sewage facilities (OSSFs). A Facility Planning Report (FPR) was prepared by Eric Williams, RS, and is being submitted under a separate cover.

Public utility easements (PUEs) were placed along the front, side and rear lot lines, as is customary for a newly platted subdivision.

APPENDIX A DRAINAGE STUDY

Methodology

The site is analyzed by hand on a plotted 24" x 36" sheet using LiDAR data from the Texas Natural Resources Information System (TNRIS). The site was divided into two drainage basins, with DA01 totaling 122.59 acres and DA02 totaling 10.24 acres. The project is bounded on the southwest side by Meridian Lane and on the southeast side by a pre-existing creek bed. See attached drainage area map. Basin DA01 drains south and basin DA02 drains east into a pre-existing creek bed.

Lag Time

Lag time was calculated using the City of Austin Drainage Criteria Manual. Due to the size of the drainage areas it is assumed that the relatively small amount of development proposed will not significantly change the Times of Concentration and therefore the Lag Times, so the same Lag Time is assumed under existing and proposed conditions.

NRCS Method

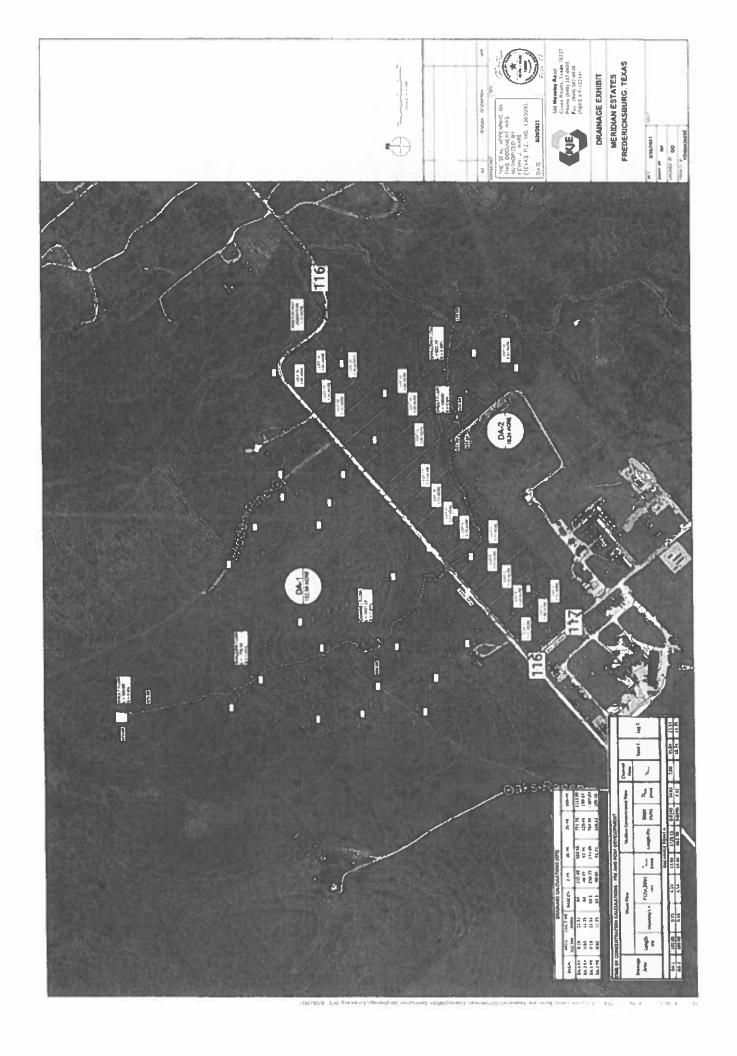
Existing and proposed runoff values were calculated using the NRCS Method and the City of Austin Drainage Criteria Manual. Curve numbers were used per Table 2-5 NRCS Method Curve Numbers for an average slope of 1-3% for basins DA01 and DA02. Intensity values were calculated in using Equation 2-1 and Table 2-2A Intensity-Duration-Frequency Curve Coefficients (Zone 1). The project area was determined to be in "Zone 1" of the two zones in the City of Austin Drainage Criteria Manual by comparing the given diagram with the location of the project area in Google Maps. Finally, the area was calculated using Civil 3D tools for bounding the areas identified using LiDAR data.

Slopes across the site currently average from 0.65-5%. The drainage basins contains Crockett, Gowen, and Mabank soil groups, which are all hydrologic type D soils. The cover type is "Pasture, grassland, or range" in Fair condition, therefore the SCS Curve

Number is 84. Under proposed conditions 4,000 sf of impervious cover is assumed for buildings and driveways, and 1 acre of lawn around the buildings and driveways. The SCS Curve Number for impervious cover is 98. The Curve Number for lawn in "good" condition with Type D soil is 80; therefore the aggregate Curve Number for the impervious cover and lawn improvements is 83.5. It is well understood that some lots will have more impervious cover and some less, but overall these assumptions were considered sufficient for this analysis. Since the aggregate Curve Number for the improvements is less that the base Curve Number of 84, and the drainage areas and times of concentration do not change, there is no increase in runoff caused by the residential improvements to the proposed large lots.
