CALDWELL COUNTY, TEXAS DECLARATION OF LOCAL DISASTER PROHIBITION OF OUTDOOR BURNING

WHEREAS, Section §418. 108 of the Local Government Code provides that the County Judge can declare a slate of Local Disaster within the county) and order, may prohibit outdoor burning in the unincorporated area of the county when he finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning and,

WHEREAS, the County Judge does find that circumstances present in all of the unincorporated area of the county create a public safety hazard that could be exacerbated by outdoor burning;

BE IT THEREFORE ORDERED, that the following emergency regulations are hereby established for all unincorporated areas of Caldwell County, Texas that are not subject to public ownership or stewardship for the duration of the above mentioned declaration:

- I. Action Prohibited:
 - (a) A person violates this order if he/she burns a combustible material outside of an enclosure, which serves to contain all flame and/or sparks, or orders such burning by others.
 - (b) A person violates this order if he /she engages in any activity outdoors which could allow flames or sparks that could result in a fire, unless done in an enclosure designed to protect the spread of fire, or orders such activities by others.
- 2. Enforcement:
 - (a) Upon notification of suspected outdoor burning the tire department assigned shall respond to the scene and take immediate measures to contain or extinguish the fire.
 - (b) If requested by a fire official, a duly commissioned peace officer, when available, shall be notified and sent to the scene to investigate the nature of the fire.
 - (c) If, in the opinion of the officer investigating and the fire official, the goal of this order can be obtained by informing the responsible party about the prohibitions established by this order the officer may at his discretion notify the party about the provisions of this order and request compliance with it, or issue a citation for: **Violation of Bum Ban Order**.

Therefore it is in accordance with Local Government Code 352.08 I, a violation of this order is a class C Misdemeanor, punishable by a fine not to exceed \$500.00.

- 3. This Order does not prohibit prescribed fire(s) conducted in compliance with guidelines set forth by federal or state natural resource agencies and conducted by a prescribed burn manager certified under Section 153.048 Natural Resources Code, and meets the standards of Section 153.047, Natural Resources Code, burned under a burn plan approved by such agencies, or outdoor burning activities related to public health and safety that arc authorized by the Texas Commission on Environmental Quality for:
 - (a) Firefighter training
 - (b) Public utility, natural gas pipeline or mining operations
 - (c) Planting or harvesting of agricultural crops

IT IS FURTHER ORDERED that an exemption be hereby granted for a bona fide commercial land clearing business, allowing said business to burn as long as all other provisions of the Order and applicable laws and ordinances are adhered to as set forth herein, and contact is made and the burning approved by the Caldwell County Emergency Management Coordinator at 1403 Blackjack St. Lockhart, TX at phone Number 512-398-1822, and receiving permission, prior to any outdoor burning.

IT IS FURTHER ORDERED that an exemption be hereby granted to those businesses where welding is an essential function of the business, allowing welding operations to proceed as long as the area of welding operations has been cleared of vegetation for a distance of no less than ten (10) feet in all directions, that there be a second capable person acting as a fire spotter with a sufficient water source available to extinguish fires which may be ignited from stray sparks, and only when all other provisions of the Order and applicable laws and ordinances are adhered to as set forth herein.

BE IT ALSO ORDERED, that the purpose of this order is the mitigation of the hazard posed by wildfire during the term of the dry, weather by curtailing outdoor burning; which purpose is to be taken into account in any enforcement action based upon this order.

This order will remain in effect for a period of 14 days, and shall expire at the end of said period.

Criminal District Attorney Contract

WHEREAS the ______ Attorney of Caldwell County, Texas, and the Sheriff's Combined Auto Theft Task Force desire to enter into a contract between the parties regulating the disposition of property and monies (as defined by law) seized by the Task Force pursuant to the civil and criminal statutes of the State of Texas; and,

WHEREAS the parties in this contract are identified as the ______ Attorney of Caldwell County, Texas (hereafter referred to as the Attorney) and the Sheriff's Combined Auto Theft Task Force (hereinafter referred to as the Task Force), and the Task Force is organized pursuant to a grant by and through the Motor Vehicle Crime Prevention Authority; and,

WHEREAS the Attorney has the duty to represent the State of Texas regarding forfeitures of property pursuant to various civil and criminal statutes; and,

WHEREAS the Task Force has the duty to provide the law enforcement service with particular emphasis on auto theft related offenses; and,

NOW, THEREFORE, it is mutually agreed by and between the Attorney and the Task Force, as follows:

1. The Attorney shall, according to the law and their own prosecutorial discretion, diligently pursue all forfeiture actions which arise from operations initiated and investigated by the Attorney and the Task Force, as follows:

a. Upon seizure of property by the Task Force under provisions of law, the Task Force shall provide for the custody of the seized property until final disposition of the forfeiture action.

b. Upon seizure of funds by the Task Force under provisions of the law, the Task Force shall turn said funds over to the Attorney to be deposited in a non-interest-bearing forfeiture account as required by law until final disposition of the forfeiture action.

c. Upon final disposition of the Forfeiture action, all funds and all property attributable to the efforts of the Task Force shall be awarded to the Task Force.

2. All property and funds awarded to the Task Force under forfeiture action represent Program Income (see IMVCPA Granit Application). Up to the grant amount these funds shall be added to the funds committed to the project in accordance with the Texas Grant Management Standards (TxGMS). Any Program Income (forfeiture, etc.) in excess of the total grant award amount may be retained by the grantee with MVCPA approval and must be used for purposes that further the objectives of the project. 3. This agreement shall be in effect for the term of the Task Force grant awards dates, **September** 1, 2021 to August 31, 2022. It is Agreed and Executed as follows:

Public Library Districts

Texas communities now have two laws for the establishment of public library districts. One law passed in 1997 and was amended in 1999 and 2001. A multi-jurisdictional library district law passed in 2005 and was amended in 2007.

I. THE 1997 LIBRARY DISTRICTS ACT and AMENDMENTS

In 1997, the 75th Legislature passed Senate Bill 1674

(http://www.legis.state.tx.us/BillLookup/History.aspx?LegSess=75R& Bill=SB1674), relating to the creation, administration, powers, duties, operation, and financing of library districts in Texas. This legislation allows the formation of library taxing districts and permits voters to choose to dedicate a portion of their sales tax revenue to support library services. The provisions of the Library Districts Act are found in **Title 10, Local Government Code, Chapter 326.** (http://www.statutes.legis.state.tx.us/Docs/LG/htm/LG.326.htm)

Supporters of Westbank Community Library introduced the original library district legislation in order to provide an ongoing, substantial source of funding for Westbank Community Library. The Library Districts Act was amended in 1999 by House Bill 1618 (http://www.legis.state.tx.us/BillLookup /History.aspx?LegSess=76R&Bill=HB1618) and amended in 2001 by House Bill 440 (http://www.legis.state.tx.us/BillLookup/History.aspx?LegSess=77R&Bill=HB440).

By 2007, the number of Library Districts in Texas has grown to fifteen. Voters have approved the creation of the following library taxing districts:

- Benbrook Library District
- Forest Hill Library District
- Blanco County South Library District
- Blanco County North Library District
- Bulverde Area Rural Library District
- Canyon Lake Community Library District
- Dripping Springs Community Library District
- East Travis Gateway Library District
- Salado Public Library District
- Wells Branch Community Library District
- Westbank Community Library District
- Wimberley Village Library District
- Liberty Hill Public Library District
- Timpson Public Library district
- Lake Travis Community Library District

II. THE 2005 MULTI-JURISDICTIONAL LIBRARY DISTRICTS ACT

Library District legislation was further enhanced during the 79th Regular Legislative Session in 2005 by passage of <u>Senate Bill 1205</u> (http://www.legis.state.tx.us/BillLookup/History.aspx?LegSess=79R& <u>Bill=SB1205</u>) creating multi-jurisdictional library districts. This new Multi-Jurisdictional Library Districts Act allows for the creation of a library district by a county or municipality that, by resolution, assumes the role of a lead governmental entity. A district created under this chapter may call an election for the purpose of approving a sales tax or an ad valorem tax, or both, on property in the district. The multi-jurisdictional library district may issue bonds to acquire, construct, equip, or improve district facilities. The provisions are found in <u>Title 10, Local Government Code, Chapter 336</u> (http://www.statutes.legis.state.tx.us/Docs/LG/htm/LG.336.htm).

Because of uncertainty as to whether statutory authority is sufficient to allow a Multi-Jurisdictional Library District to assess and collect ad valorem taxes or whether a constitutional amendment is needed to provide this specific authority, the Texas State Library and Archives requested an official opinion on these questions. In his May 12, 2008 Opinion No. GA-0626 Texas Attorney General Greg Abbot responded in summary as follows:

Summary: The Texas Supreme Court has not determined whether the Texas Constitution impliedly prohibits the Legislature from allowing a political subdivision to impose ad valorem taxes absent express constitutional authorization. However, the authority that exists indicates that a court would more likely than not find that express constitutional authority is necessary for legislation permitting a multi- jurisdictional library district established under Government Code chapter 336 to impose an ad valorem tax.

If the ad valorem tax authorized by Local Government Code chapter 336 were constitutional, the library district board could have the tax collector of the lead governmental entity collect and remit taxes to the district. Although section 336.251 limits the board's authority to negotiate the tax collector's compensation, it appears that the Legislature may amend this provision without also amending the constitution.

LIBRARY DISTRICT SALES TAX

The board may adopt bylaws to govern the district and hire any person the board considers necessary for conducting the district's affairs. [Refer to Loc. Govt. Code, Sect. 336.101-336.102.]

ELECTION PROCEBURES

DISTRICTS CREATED BY A COUNTY

A district created by a county may levy a sales tax to fund the district if authorized by a majority of the qualified voters in the creation election and if the total combined rate of all local sales and use taxes would not exceed 2 percent at any location within the district. The permissible rates for the district sales tax are 0.125, 0.25, 0.375 or 0.5 percent. [Refer to Loc. Govt. Code, Sect. 326.093 and 326.096.]

If a majority of voters approve the district and adopt the sales tax, the commissioners court must declare that the district is created and the rate of the local sales and use tax adopted and enter the results in its minutes.

The order canvassing the election results must contain a description of the district's boundaries and a map of the district. The commissioners court also must file the order in the county's deed records.

The order canvassing the election results should also include:

the date of the election;

the proposition on which the vote was held; the total number of votes cast for and against

the ballot proposition; and

the number of votes by which the proposition was approved. [Refer to Loc. Govt. Code, Sect. 326.029, and Tax Code, Sect. 323.405.]

If a majority of the votes cast is against the creation of the district, the commissioners court must declare the measure defeated and enter the results in its minutes. [Refer to Loc. Govt. Code, Sect. 326.029.]



The board by order may decrease or abolish the sales tax rate. The board may also call an election to increase, decrease or abolish the sales tax rate, with the increase or decrease becoming effective if approved by a majority of the district's voters. [Refer to Loc. Govt. Code, Sect. 326.094.]

MULTI-JURISDICTIONAL DISTRICTS

If a local sales tax in a multi-jurisdictional library district is approved by a majority of the qualified voters in an appropriate election, the board must by resolution declare the rate of sales tax and enter the result in its minutes. The order canvassing the election results must:

contain a description of the district's boundaries and a map of the district;

state the election date; and

state the total number of votes cast for and against the ballot proposition.

The board must file the order in the county's deed records.

If a majority of votes received are against the adoption of the sales tax, the board must declare the measure defeated and enter the results in its minutes, [Refer to Loc. Govt. Code, Sect. 336.028.]

The board of a multi-jurisdictional library district by resolution may dissolve the district if the governing body of the lead governmental entity by resolution consents to the dissolution. [Refer to Loc. Govt. Code, Sect. 336.351.]

The petition for a proposed library district must include the proposed boundaries.

the remaining three serve for two years. [Refer to Loc. Govt. Code, Sect. 326.030.]

After the initial election, the district must hold subsequent trustee elections annually. Trustees serve for two years. Except for the initial members of the board, trustee candidates must file for the position in accordance with the Election Code. [Refer to Loc. Govt. Code, Sect. 326.043.]

A board member must be a resident of the district and registered to vote in the county in which the district is located. [Refer to Loc. Govt. Code, Sect. 326.042.]

HOW ARE MULTI-JURISDICTIONAL LIBRARY DISTRICTS GOVERNED?

A multi-jurisdictional library district is governed by a seven-member board of trustees that controls and manages the affairs of the district. The lead governmental entity appoints four members to the board. The most populous county in which the district is located shall appoint three trustees to the board, unless the county is the lead governmental entity. If the county is the lead governmental entity, the most populous municipality in the county shall appoint three trustees. Persons eligible for appointment include those who:

reside in the district;

- are registered to vote in a county in which the district is located; and
- have recognized expertise in library services, education, information technology, local or Texas history or business management. [Refer to Loc. Govt. Code, Sect. 336.051-336.053.]

Members of the initial board of trustees serve staggered terms, with four members' terms expiring in two years and three members' terms expiring in one year. The lead governmental entity appoints an initial presiding officer to serve a two-year term. After the initial trustees have completed their terms, members serve staggered two-year terms. [Refer to Loc. Govt. Code, Sect. 336.029 and 336.054.] A library district's board may vote to abolish or decrease its sales tax or call an election to seek an increase in the tax rate.

EVALUAT DANGUAGE FOR ALLEVARY DISTRICT FLEGTIONS

Election to Create a Library District [Refer to Loc. Govt. Code, Sect. 326.028 and 326.093.]

The ballot must allow voters the choice of voting for or against the following proposition:

"The creation of the ______ (name of the district) and adoption of a local sales and use tax in the (name of the district) at the rate of ______ (rate) percent to provide revenue for the district." (Insert one-eighth, one-fourth, three-eighths or one-half of one percent as appropriate for the proposed tax rate.)

The ballot must be printed to permit voting for or against each of the five trustees listed in the petition submitted to the commissioners court under Loc. Govt. Code, Sect. 326.023. The ballot must include a blank space after the name of each candidate so that voters also may write in the names of other persons for trustees. A voter may not vote for more than five persons for trustee.

Election to Change the Tax Rate

The ballot must allow voters the choice of voting for or against the following proposition: "The increase (decrease) in the local sales and use tax rate of (name of the district) to (percentage) to be used for the purposes of the district."

 Election to Abolish the Tax [Refer to Loc. Govt. Code, Sect. 326.094.]
 The ballot must allow voters the choice of voting for or against the following proposition: "The abolition of the district sales and use tax."

NOTIFYING THE COMPTROLLER

If election results change the tax rate or type of sales tax imposed, the county judge or the presiding officer of a multi-jurisdictional library district should mail a certified copy of the order or the resolution (either by certified or registered U.S. mail) to:

The tax becomes effective after one complete calendar quarter elapses from the date the Comptroller's office receives notification of voter approval. [Refer to Loc. Govt. Code, Sect. 336.252, and Tax Code, Sect. 323.102.]

HOW CAN THE TAX REVENUES BE USED?

A single-entity district has all of the powers, authority, rights and duties necessary to accomplish its purposes. These powers include the right to hire a library director and other staff, to borrow money and to purchase, construct, acquire, own, operate, maintain, repair or improve any land, works, materials, supplies, improvements, facilities, equipment, vehicles, machinery or appliances necessary for the operation of the district. [Refer to Loc. Govt. Code, Sect. 336.050 and 326.061.]

A multi-jurisdictional district has all the authority necessary to accomplish its purposes. The district may hire an executive director and staff or contract with any person. The district also may contract with a municipality, county or other political subdivision for the district to provide public library services outside the district. The district has authority to construct, acquire, own, lease, operate, maintain, repair or improve any land, works, materials, supplies, improvements, facilities, equipment, vehicles, machinery, appliances or other property as necessary. [Refer to Loc. Govt. Code, Sect. 336.102-336.103, 336.151 and 336.154-336.156.] A single-entity district and a multi-jurisdictional district must use the tax revenues they collect to establish, equip and maintain one or more public libraries for the dissemination of general information relating to the arts, sciences and literature. [Refer to Loc. Govt. Code, Sect. 336.002, 326.095 and 336.003.]

A library district may invest its tax revenue in authorized investments. In addition, it has the authority to purchase, acquire, own, maintain or improve its facilities and equipment. The district may also pledge sales and use taxes as collateral for borrowing money to further the district's purposes. [Refer to Loc. Govt. Code, Sect. 336.061, 326.067 and 326.095.]

A multi-jurisdictional district may issue bonds for any amount it considers necessary or appropriate to acquire, construct, equip or improve district facilities. A district may not issue bonds unless the lead governmental entity's governing body consents by resolution to the issuance. [Refer to **Loc. Govt. Code, Sect. 336.302-336.303.**]

LEGAL \star Q&A

Q Are cities required to fund and operate a local library?


A No. There is no state law requirement that a city have a library.

Q What is a library district?

A library district is a political subdivision created to establish, equip, and maintain public libraries for the dissemination of information relating to the arts, sciences, and literature. Tex. Loc. Gov't Code §§ 326.002 & 326.004.

Q How is a library district created?

A Before a district may be created, the commissioners court of the county that the proposed district will be located in must receive a petition signed by at least five percent of the number of voters who voted in the most recent gubernatorial election who live in the territory of the proposed district. Tex. Loc. Gov't Code § 326.023. After receiving the petition, the commissioners court is required to call an election on the question of whether to create a library district. The library district must be approved by a majority of the qualified voters of the district. Tex. Loc. Gov't Code § 326.021.



Q Can a city be included in the territory of a library district?

A Yes. However, if the boundaries of the proposed district include any territory that is part of a city that operates a public library, then the city council must consent by resolution to allow the city to be included in the proposed library district. Tex. Loc. Gov't Code § 326.022. After a library district is created, the district may not be expanded to include additional territory unless an election is held to approve the expansion of the district.

Q Can a library district impose a sales tax?

A Yes. A library district may impose a sales tax, if the tax is approved by a majority of the voters. Tex. Loc. Gov't Code § 326.021. The permissible rates for a local sales and use tax are one-eighth of one percent, onefourth of one percent, three-eighths of one percent, and one-half of one percent. Tex. Loc. Gov't Code § 326.093. Taxes collected may only be used for the "purposes for the dissemination of general information relating to the arts, sciences, and literature." Taxes may also be pledged as collateral for borrowing money to further those same purposes.

Q What if my city that is in a proposed library district has already reached its maximum sales tax cap of two percent?

A The combined rate of all local sales and use taxes imposed by politicalsubdivisions, which includes a library district, may not exceed two percent. Thus, a district may adopt a sales tax only if as a result of the adoption, the combined rate of all local sales and use taxes in the district will not exceed two percent. Tex. Loc. Gov't Code § 326.096.

Q May the city prohibit library patrons from carrying a concealed handgun by a person who is licensed to carry?

A Generally, no. If the library is owned by the city, the city cannot prohibit open or concealed carry of a gun in the library by license holder. However, if an activity sponsored by a school or educational institution is being held at the library, then carrying an open or concealed weapon would be prohibited. Tex. Penal Code § 46.03. Additionally, if a body subject to the Open Meetings Act is meeting in a meeting room in the library, then open or concealed carry may be prohibited, if the entity provides the proper notice. Tex. Penal Code § 46.035(c).

Q Must a city follow procurement requirements for the purchase of library materials?

A Generally yes, but chapter 252 of the Local Government Code provides an exemption from the procurement requirements when the purchase is of rare books, papers, and other library materials for a public library. Tex. Loc. Gov't Code § 252.022(8). A city should 10. KOLOGIK LLC SOFTWARE-AS-A-SERVICE AGREEMENT

This Kologik LLC Software-as-a-Service ("SaaS") Agreement ("Agreement") is entered into by and between Kologik LLC, with its principal office located at 301 Main Street, Suite 810, Baton Rouge, LA 70801 ("Kologik"), and the customer named below. The effective date of this Agreement is the date of full execution of this agreement ("Effective Date").

Customer Name: Caldwell County (TX) ("Customer") Address: 110 S. Main St, Lockhart, TX 78644

RECITALS

WHEREAS, Kologik is the owner of certain computer software programs, including its Kologik software application ("Software"), and also provides configuration, training, and other services related to the Software purchased by Customer hereunder ("Services");

WHEREAS, the Software enables law enforcement agencies to document, record, manage and exchange information necessary for daily law enforcement activities;

WHEREAS, Kologik provides to customers, access to the Software by way of its centrally web-hosted platform on a subscription basis as a Software-as-a-Service (SaaS) offering, as an alternative to self-hosting or obtaining a perpetual license with managed hosting services;

WHEREAS, the Software can be configured to provide for data from various information feed sources to meet the Customer's needs;

WHEREAS, Customer now desires Kologik to provide, and Kologik desires to provide, Customer with access to the Software by way of Kologik's SaaS offering; and

WHEREAS, Kologik and Customer may sometimes be referred to herein each as "Party" or together as "Parties."

NOW, THEREFORE, based on the foregoing premises and the promises set forth below, the Parties agree as follows:

AGREEMENT

1. Grant of License.

1.1 License Grant. During the Term, and subject to the terms and conditions of this Agreement, Kologik hereby grants to Customer a limited, non-exclusive, non-transferable, non-assignable, license, on a subscription basis only, without the right to grant sublicenses, to access and use the Software via Kologik's web-based platform, over the Internet, as a SaaS solution, solely to support Customer's normal course of business, as configured by Kologik in accordance with Sections 2 and 3 below ("Solution"). The license is limited for use by Sworn Officers to the number set forth at Schedule A. Additional license fees will apply if Customer desires to add more Sworn Officers or civilian workers. Civilian workers that are directly employed by Customer may be eligible for licenses and utilize the Solution. However, Customer shall not provide any third party access to the Software or Solution without Kologik's prior written consent. The license granted in this Section 1 shall also include modifications to the Solution or Software that Kologik may make available to the Services that Customer procures from Kologik.

1.2 Restrictions on Use. Customer shall not, and shall not permit others to, without Kologik's prior written consent: (i) exceed the number of permitted licenses set forth on Schedule A; (ii) license, sublicense, sell, resell, distribute, rent, lease, assign or transfer the Software or Solution to any third party; (iii) modify, customize, reverse engineer, adapt, reverse assemble, reverse compile or create derivative works of the Software or Solution or any part thereof; or (iv) use the Software to harass, abuse, threaten, infringe intellectual property, or otherwise cause harm to Kologik or any third parties.

2. Initial Set Up and Configuration Services. Upon execution of this Agreement, the Parties will work together to define Customer's needs for configuring the SaaS Solution within the parameters of standard features in the systems purchased. Kologik's standard initial implementation, set-up and training fees are set forth in Schedule A. Customer's timely response to discovery and data requests are paramount to timely implementation (Section 8.3 herein).

3. **Professional Services and Statements of Work**. If additional Services are requested of Kologik beyond the scope of the initial standard set up and configuration services set forth in Section 2 above, the Parties will enter into a mutually agreed upon Statement of Work ("SOW") identifying the Services and tasks to be performed by Kologik, and set forth an estimate of the hours and corresponding fees for such Services. Unless otherwise set forth in the SOW, all Services will be provided by Kologik on a "time and material" basis at the rates identified in the SOW.

4. **Customer Support**. During the Term, Kologik will provide Customer with the ability to report technical issues 24 x 7 for the Software/Solution. Response times to resolve issues are set forth at Kologik's Customer Support Policy, attached hereto as Schedule B. Kologik support includes troubleshooting, basic usability and navigation assistance. If applicable, Customer agrees to provide Kologik access to production systems for purposes of customer support.

5. Service Level Agreement. Kologik will provide the Services in accordance with the Service Level Agreement attached hereto as Schedule B.

6. Fees and Payment Terms.

6.1 <u>Payment Terms</u>. Fees and payment terms for the Initial Term of the Agreement are set forth in Schedule A, and will be paid to Kologik by Customer. Fees for Services for any renewal term ("Renewal Term") will be invoiced by Kologik to Customer prior to the expiration of the Initial Term or any Renewal Term. If Customer chooses to not renew the Services, it will provide Kologik with written notice of such decision at least sixty (60) days (Initials _____) prior to the expiration of the Initial Term. Customer shall pay to Kologik all Fees due hereunder, as set forth in Schedule A or otherwise in writing by a SOW, purchase order, or other similar document, within thirty (30) days after receipt of Kologik invoice. Unless otherwise instructed by Customer in writing, Kologik shall send all invoices electronically to the email address specified at the introduction paragraph of this Agreement.

6.2 <u>Expenses</u>. Customer shall reimburse Kologik for previously-approved reasonable travel expenses incurred beyond the normal scope included in Schedule A. Such expenses are not included in any estimate in a SOW unless expressly itemized.

6.3 <u>Cancellation or Rescheduling of Meetings or Travel by Customer</u>. If meetings are rescheduled or cancelled by Customer after Kologik travel expenses have been incurred, Customer is responsible for penalties or other costs associated with changing or cancelling airline tickets. If services engagements are rescheduled or cancelled by Customer with less than twenty-four (24) hours' notice to Kologik, Customer is responsible for payment of eight (8) employee hours at current rates plus any incurred travel expenses.

6.4 <u>Interest</u>. Kologik <u>may</u> charge a service fee on late payments of the lesser of 1.5% per month or the highest rate allowable under law.

6.5 <u>Taxes</u>. Customer hereby asserts that it is exempt from the payment of taxes that might be applicable to the Services procured hereunder.

6.6 Alternate Payment Methods. Payments may be made by electronic means upon request to <u>AR@kologik.com</u>. Credit card processing or wire transfer fees will be the responsibility of the customer.

7. Ownership.

7.1 <u>Solution</u>. Customer acknowledges and agrees that it is acquiring only the right to access and use the SaaS Services, Solution and underlying Software licensed under this Agreement. Kologik, or its licensors as the case may be, is the owner of all right, title, and interest in and to the Software and Solution and all components and copies thereof, all modifications thereto (including derivative works based on the Solution or underlying Software application), and changes to the Solution made by Kologik pursuant to this Agreement, and all of the intellectual property rights in and to all of the foregoing. In no event shall title to all or any part of the Solution or underlying Software applications pass to Customer. Customer agrees that, as between the Parties, the Solution, all underlying Software applications, and all copies (in whole or part) shall remain the exclusive property of Kologik, or its licensors as the case may be, and may not be copied or used except as expressly authorized by this Agreement. Any rights not expressly granted to Customer under this Agreement are retained by Kologik.

7.2 <u>Documentation and Training Materials</u>. All Kologik documentation and training materials provided by Kologik hereunder, and all modifications thereto and intellectual property rights therein, shall be the sole and exclusive property of Kologik. Customer may make copies of such documentation and training materials for its reasonable and ordinary internal training purposes only. All proprietary rights notices contained on the Kologik documentation and training materials shall be reproduced on any copies. Subject to applicable open records laws, no copies of Kologik documentation or training materials shall be provided to any third party or competitor of Kologik.

7.3 Customer Data.

(a) Customer hereby represents and warrants to Kologik that Customer is the owner or licensee of all data and content entered into the Solution/Services ("Customer Data"). Customer acknowledges and agrees that it is solely responsible and liable for the Customer Data and its use of the Customer Data, including any data obtained or entered into the Solution by a third party. Customer further acknowledges and agrees that Kologik is merely a provider of the SaaS Services and the Solution on which the Customer Data resides, is not an authoritative source of the Customer Data, and is in no way responsible or liable to Customer or any third party for the Customer Data. Therefore, Customer will use due diligence to validate the Customer Data that resides in the Solution prior to taking action on such data. Customer shall ensure compliance with all applicable laws and regulations, including 28 CFR Part 23 and the Criminal Justice Information Services ("CJIS") requirements with respect to the Customer Data, and acknowledges and agrees that Kologik shall have no responsibility or liability with respect to Customer or the Customer Data being compliant with such regulations. Customer further represents and warrants to Kologik that the Customer Data, or Customer's use of the Customer Data in the Software/Solution, does not violate or constitute the infringement of any patent, copyright, trademark, trade secret, right of privacy, right of publicity, moral rights, or other intellectual property right recognized by any applicable jurisdiction of any person or entity, violate the civil rights of any individual, or otherwise constitute the breach of any agreement with any other person or entity. Customer further represents and warrants that the Customer Data does not contain any illegal, threatening, herassing, libelous, false, defamatory, offensive, or other material that would violate applicable law or regulation

(b) Customer hereby authorizes Kologik to access and use the Customer Data for the sole purpose of providing the Solution and Services hereunder. Kologik will not share the Customer Data with any third parties, subject to Section 12.2 herein, or modify any of the Customer Data without Customer's express written consent. Access to the Customer Data by Kologik's authorized representatives shall be conducted in a safe, secure, and reliable manner.

8. Limited Warranty; Customer Obligations.

8.1. Software/Solution Warranties.

(a) Kologik hereby represents and warrants to Customer (i) that the Solution provided under this Agreement will conform in all material respects as described in Kologik's published documentation ("Documentation") and to Customer specifications that Kologik has agreed to in writing and incorporated into this Agreement ("Specifications"); (ii) that Kologik has the legal right to enter into and perform its obligations under this Agreement; and (iii) that, at the time of Customer access, to the best of Kologik's knowledge, the Solution provided under this Agreement does not violate or in any way infringe upon the intellectual property rights of any third party. For purposes of this Agreement, "knowledge" of a business entity shall mean the actual knowledge of its executive officers and key managers. Customer must promptly report any defects in the Solution to Kologik in writing in order to receive the warranty remedy set forth in this Section 8.1(a).

(b) Customer's sole remedy, and Kologik's sole obligation, under this Software/Solution warranty shall be, at Kologik's discretion, to provide a work around or correction for, or replace, any defective or nonconforming Solution so as to enable the Solution to materially conform to the Documentation and Specifications or otherwise as warranted above. All issues will be worked in accordance with support timelines set forth in Schedule B. If Kologik does not provide a work around or correction for, or replace, the Solution so that it materially conforms to the Documentation and Specifications within the resolution time provided by Kologik to Customer, then Kologik will, upon Customer's written request for cancellation of the order, terminate the license and refund the license fee that was paid by Customer to Kologik for the order.

(c) Kologik shall have no obligation under this warranty if the Solution has been used other than in accordance with this Agreement or the Documentation and Specifications.

(d) THE REMEDIES SET FORTH IN THIS SECTION 8.1 ARE THE SOLE AND EXCLUSIVE REMEDIES FOR BREACH OF THE WARRANTIES GIVEN BY KOLOGIK UNDER THIS SECTION 8.1. KOLOGIK AND ITS SUPPLIERS MAKE NO WARRANTIES OR CONDITIONS TO ANY PERSON OR ENTITY WITH RESPECT TO THE SOFTWARE OR SOLUTION (OTHER THAN THOSE SET FORTH IN THIS SECTION 8.1) OR ANY DERIVATIVES THEREOF AND DISCLAIM ALL IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION ANY WARRANTIES OR CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, INFORMATIONAL CONTENT, SYSTEM INTEGRATION, OR ENJOYMENT.

8.2 Services Warranties.

(a) Kologik warrants to Customer that any professional services for a particular SOW will be performed in a manner consistent with generally accepted industry practices. Customer must report any deficiencies in the Services to Kologik in writing within ninety (90) days of completion of the Services for that particular SOW or order in order to receive the warranty remedy set forth in this Section 8.2.

(b) If the Services are not performed in a manner consistent with generally accepted industry practices, then Kologik's sole obligation under this service warranty shall be to re-perform the defective services at no cost to Customer. For any breach of the services warranty set forth in this Section 8.2, Customer's sole remedy, and Kologik's sole liability, shall be the re-performance of the Services at no cost to Customer, and if Kologik fails to re-perform the Services as warranted within the resolution time mutually agreed upon by Kologik and Customer, Customer shall be entitled to a refund of the fees paid by Customer to Kologik for the deficient services and to immediately terminate the particular statement of work without liability.

(c) KOLOGIK AND ITS SUBCONTRACTORS MAKE NO WARRANTIES OR CONDITIONS TO ANY PERSON OR ENTITY WITH RESPECT TO THE SERVICES (OTHER THAN THOSE SET FORTH IN THIS SECTION 8.2) AND DISCLAIM ALL IMPLIED WARRANTIES OR CONDITIONS, INCLUDING WITHOUT LIMITATION ANY WARRANTIES OR CONDITIONS OF WORKMANSHIP, MERCHANTABIITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.

8.3 <u>Customer's Actions</u>. In the event that Customer is required to provide any information or take any actions to facilitate the access and use of the Services and/or Solution, Customer will use good faith efforts to provide Kologik with the required information or take the required actions in a timely manner.

9. LIMITATION OF LIABILITY. TO THE EXTENT ALLOWED BY APPLICABLE LAW, EXCEPT FOR THE LIMITED WARRANTIES SET FORTH ABOVE, THE SAAS SERVICES, SOFTWARE AND SOLUTION ARE PROVIDED BY KOLOGIK TO CUSTOMER ON AN "AS IS" BASIS. UNLESS OTHERWISE EXPRESSLY SET FORTH IN THIS AGREEMENT, KOLOGIK DOES NOT WARRANT THAT THE SOFTWARE OR SOLUTION WILL BE UNINTERRUPTED OR ERROR FREE, OR MAKE ANY WARRANTY AS TO THE RESULTS OBTAINED FROM THE USE OF THE SOFTWARE OR SOLUTION. IN NO EVENT SHALL KOLOGIK OR ITS LICENSORS, AFFILIATES, CONTRACTORS, MANAGERS, MEMBERS OR THEIR RESPECTIVE EMPLOYEES OR AGENTS BE LIABLE FOR LOSS OR INACCURACY OF DATA OR SYSTEM USE, DOWNTIME, GOODWILL, PROFITS OR OTHER BUSINESS LOSS, OR ANY OTHER INDIRECT, CONSEQUENTIAL, EXEMPLARY, SPECIAL, INCIDENTAL, OR PUNITIVE DAMAGES IN CONNECTION WITH CUSTOMER'S USE OF THE SAAS SERVICES, SOFTWARE OR SOLUTION, KOLOGIK'S PROVISION OF ANY PROFESSIONAL SERVICES, OR THIS AGREEMENT, UNDER CONTRACT, TORT, STRICT LIABILTY OR OTHER LEGAL OR EQUITABLE THEORY. THIS LIMITATION SHALL APPLY EVEN IF KOLOGIK HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

EACH PARTY ACKNOWLEDGES THAT THIS LIMITATION OF LIABILITY REFLECTS AN INFORMED, VOLUNTARY ALLOCATION BETWEEN THE PARTIES OF THE RISKS (KNOWN AND UNKNOWN) THAT MAY EXIST IN CONNECTION WITH THIS AGREEMENT, AND THAT THIS LIMITATION WILL APPLY REGARDLESS OF THE FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY. EXCEPT FOR THE GROSS NEGLIGENCE OR INTENTIONAL MISCONDUCT OF KOLOGIK, IN NO EVENT SHALL THE TOTAL LIABILITY OF KOLOGIK AND ITS AFFILIATES, INCLUDING BUT NOT LIMITED TO DAMAGES OR LIABILITY ARISING OUT OF CONTRACT, TORT, BREACH OF WARRANTY, INFRINGEMENT OR OTHERWISE, EXCEED THE FEES PAID FOR THE SOFTWARE, SOLUTION OR SERVICES, ON A PER-ORDER BASIS, WHICH ARE THE DIRECT CAUSE OF THE DAMAGES OR LIABILITY CLAIMED. IN NO EVENT SHALL KOLOGIK HAVE ANY LIABILITY FOR CUSTOMER'S MISUSE OR FAILURE TO USE THE SOLUTION.

10. Indemnification

10.1 General Indemnification. To the extent authorized by applicable law, each Party (the "Indemnifying Party") shall indemnify and hold harmless the other against any and all third party claims of personal injury or property damage to the extent such damages are caused by such Party's gross negligence or willful misconduct. Customer will cooperate and assist Kologik in defending any third party claim resulting in any way from Customer's actions or Customer Data. The Indemnifying Party shall pay any and all damages awarded against or otherwise incurred by the other Party in connection with or arising from any such claim, suit, action, or proceeding. A Party shall be entitled to indemnification only if (a) within 15 days of its discovery of a potential claim it notifies the other in writing of such claim in sufficient detail to enable the Indemnifying Party to evaluate the claim; (b) the Party cooperates in all reasonable respects with the investigation, trial and defense of such claim and any appeal arising therefrom; and (c) it works with the Indemnifying Party in good faith and agrees to give the Indemnifying Party reasonable input into the resolution or settlement of any claim.

10.2 Infringement. Kologik will defend, indemnify and hold harmless Customer against any and all third party claims that the Software or Solution infringes any registered U.S. copyrights of such third party that are issued as of the delivery date of the Solution to Customer. Kologik shall pay any and all costs, damages, and expenses, including, without limitation, reasonable attorneys' fees and costs awarded against or otherwise incurred by Customer in connection with or arising from any such claim, suit, action, or proceeding. Customer shall be entitled to indemnification only if (a) within 15 days of its discovery of a potential claim it notifies Kologik in writing of such claim in sufficient detail to enable Kologik to evaluate the claim, and (b) Customer cooperates in all reasonable respects, at Kologik's cost and expense, with the investigation, trial and defense of such claim and any appeal arising therefrom. Should the Solution become, or in Kologik at its sole option, shall either: (a) procure for Customer the right to continue using the Solution, (b) replace such Solution with functionally-equivalent software, or modify such Solution to make it non-infringing, or (c) if neither option (a) nor (b) is reasonably available, terminate this Agreement and refund any prepaid fees to Customer, pro-rated for the balance remaining in the then-current subscription term. Kologik shall have no liability with respect to infringement of any proprietary right, except as set forth in this Section 10.2.

11. Term and Termination.

11.1 <u>Term</u>. This term of this Agreement shall commence as of the actual implementation of the software contracted for herein or sixty (60) days from the Effective Date of this agreement, whichever comes first, and continue in full force and effect for the three (3) year Initial Term set forth in Schedule A, and automatically renew annually thereafter at then current rates, each a Renewal Term, unless otherwise terminated in accordance with Section 11.2 below. (Initials____)

11.2 <u>Termination</u>. This Agreement may be terminated as follows:

11.2.1 <u>Termination for Convenience</u>. If either Party desires to discontinue any Services under this Agreement beyond the Initial Term, the Party may do so by providing written notice of non-renewal of the particular Services at least sixty (60) days (Initials____) prior to the end of the Initial Term or any Renewal Term. There is no termination for convenience during the Initial Term set forth at Schedule A or any Renewal Term.

11.2.2 <u>Termination for Cause</u>.

(a) Either Party may terminate this Agreement if the other Party breaches any of the material terms and fails to cure such breach within 30 days after receipt of written notice of such breach, or, if the breach cannot be reasonably cured within said period, to promptly commence to cure and diligently proceed until cured.

(b) Either Party may terminate this agreement if the other Party (i) becomes insolvent, (ii) makes an assignment for the benefit of creditors, (iii) files or has filed against it a petition in bankruptcy or seeking reorganizations, (iv) has a receiver appointed, or (v) institutes any proceedings for the liquidation or winding up; provided, however, that, in the case any of the foregoing is involuntary, such Party shall only be in breach if such petition or proceeding has not been dismissed within 90 days.

(c) If the breaching Party cures any such breach as provided herein, this Agreement shall continue unabated and the breaching party shall not be liable to the other for any loss, damage, or expense arising out of or from, resulting from, related to, in connection with or as a consequence of any said breach.

11.3 <u>Effect of Termination</u>. Upon termination or expiration of this Agreement, Kologik shall have the right to terminate Customer's access to the SaaS Services and Solution and discontinue Services to Customer.

11.4 <u>Data Release</u>. If requested by Customer prior to the termination or expiration of this Agreement, Kologik will assist Customer with the release or copying of any Customer Data contained within the Solution, subject to Customer signing a data release agreement. Upon such request, Kologik shall provide a work order to Customer which outlines the level of effort, at the prevailing professional services rates, in support of such data release. Customer shall either accept or reject the work order within thirty (30) days of receipt of said work order. If Customer fails to provide written acceptance or rejection of said work order within thirty (30) days, the work order will be deemed to be rejected, and Kologik shall have the right to remove, delete, or destroy the Customer Data from the Solution.

11.5 <u>Survival</u>. The provisions of Sections 6, 7, 8, 9, 10, 11 and 12 shall survive the termination of this Agreement.

12. General Provisions.

12.1 <u>Binding Agreement</u>. This Agreement is binding on the heirs, executors, administrators, successors and permitted assigns of the Parties.

Confidentiality. During the term of this Agreement and at all times thereafter, each Party shall, and shall ensure 12.2 that its respective directors, officers, employees, contractors and agents hold any and all Confidential Information disclosed by the other Party pursuant to this Agreement in the strictest confidence and in accordance with state and federal law. "Confidential Information" shall include without limitation all information and records whether oral or written or disclosed prior to or subsequent to the execution of this Agreement which has been marked "Confidential" or should reasonably be considered confidential, such as patents, utilization review, quality assessment, finances, volume of business, methods of operation, trade secrets, or other information otherwise confidential by law. Each Party shall destroy any Confidential Information received from the other following the Event for which the Solution has been designed. Each Party agrees that disclosure of the other's Confidential Information other than in accordance with this Agreement shall cause irreparable injury to the other, and that the other Party shall be entitled to injunctive relief to prevent one another's breach of this Section. Nothing in this Section shall restrict either Party with respect to information or data: (i) that such Party rightfully possessed before it received the information from the other, as evidenced by written documentation of such possession; (ii) that subsequently becomes publicly available through no fault of such Party; (iii) that is subsequently furnished rightfully to such Party by a third party (excluding affiliates of the other) not known to be under restrictions on use or disclosure; (iv) that is required to be disclosed by applicable law (solely to the extent of such requirement), provided that the disclosing Party will exercise reasonable efforts to notify the other prior to disclosure; or (v) that is independently developed by such Party without any confidential information of the other.

12.3 <u>Assignment</u>. This Agreement shall be binding upon and inure to the benefit of the Parties and their respective successors and permitted assigns. This Agreement is not assignable by either Party without the prior written consent of the other. Notwithstanding the foregoing, upon reasonable notice, either party may assign all or any part of its rights and obligations under this Agreement without consent to (a) any entity resulting from any merger, consolidation or other reorganization of the assigning party, (b) any operating entity controlling the assigning party, or owned or controlled, directly or indirectly, by the assigning party, (c) any affiliate of the assigning party, or (d) any purchaser of all or substantially all of the assigning party.

12.4 <u>No Waiver</u>. If either Party waives any breach by the other, it shall not be construed as a waiver of any subsequent breach. Each Party's rights hereunder shall be cumulative, and any rights hereunder may be exercised concurrently or consecutively and shall include all remedies available even though not expressly referred to herein.

12.5 <u>Electronic Media</u>. A copy of this Agreement and the signatures affixed hereto transmitted and delivered by facsimile or electronic mail shall be deemed to be originals for all purposes. In addition, either Party may scan or otherwise convert this Agreement into an electronic and/or digital media file, and a copy of this Agreement or the electronic data file produced from any such electronic or digital media format may serve and be given the same legal force and effect as the original.

12.6 <u>Right to Subcontract</u>. Kologik may subcontract for the provision of certain portions of the Solution under this Agreement. Customer acknowledges and agrees that the provisions of this Agreement inure to the benefit of and are applicable to any subcontractors engaged by Kologik to provide any service set forth herein to Customer, and bind Customer to said subcontractor(s) with the same force and effect as they bind Customer to Kologik.

12.7 <u>Entire Agreement</u>. This Agreement, including the attachments hereto, constitutes the entire agreement between the Parties with respect to the subject matter hereof, and supersedes and replaces all prior or contemporaneous oral or written statements, proposals, communications, negotiations, agreements, advertising and marketing including correspondence, brochures and Internet websites.

12.8 <u>Force Majeure</u>. Neither Party shall be held liable for any damages or penalty for delay in the performance of its obligations hereunder when such delay is due to earthquake, flood, fire, hurricane, power failure, tornado, terror, riot, war, or other event or disaster beyond the Party's control, provided the Party uses reasonable efforts seeking to (a) mitigate the consequences and (b) promptly notify the other Party.

12.9 Notices. Any notice required or permitted under this Agreement shall be in writing, shall reference this Agreement and will be deemed given: (i) upon personal delivery to the appropriate address; (ii) three (3) business days after the date of mailing if sent by certified or registered mail; (iii) one (1) business day after the date of deposit with a commercial courier service offering next business day service with confirmation of delivery, or (iv) upon read receipt of delivery by electronic communications at orders@kologik.com. All communications shall be sent to the contact information set forth below or to such other contact information as may be designated by a Party by giving written notice to the other Party pursuant to this provision:

If any provision of this Agreement is determined by a court or arbitrator of competent jurisdiction to be invalid or unenforceable, such determination shall not affect the validity or enforceability of any other part or provision of this Agreement, and such provisions shall be interpreted so as to effectuate the intent and purpose of the Parties.

12.11 <u>Waiver and Modification</u>. Waiver of any breach or failure to enforce any term of this Agreement shall not be deemed a waiver of any breach or right to enforce which may thereafter occur. Any waiver of any provision of this Agreement shall be effective only if in writing and signed by both Parties.

12.12 <u>Modifications</u>. Any amendment, supplementation or other modification of any provision of this Agreement shall be effective only if in writing and signed by both Parties. It is the intent of the Parties that this Section 12.12 shall expressly apply to exclude any additional or conflicting terms in any purchase order or similar ordering document ("PO") issued by Customer, and requires instead a writing between the Parties that is separate and apart from any such PO to amend or add to this Agreement.

12.13 <u>Relationship of Parties</u>. This Agreement shall not be construed as creating an agency, partnership, joint venture or any other form of legal association between the Parties and each Party is an independent contractor.

12.14 <u>Counterparts</u>. This Agreement may be executed in one or more counterparts, each of which shall for all purposes be deemed an original.

12.15 <u>Non-Solicitation of Employees</u>. Each Party agrees that during the term of this Agreement and for a period of two years after its expiration or termination, neither Party will solicit or encourage any employee or consultant to discontinue their employment or engagement with the other Party. This provision shall not apply to employment opportunities of either Party advertised to the general public (e.g., newspaper advertisement, internet advertisement or listing, etc.) to which an employee of either Party may respond.

12.16 <u>Compliance with Laws</u>. The Parties agree to fully comply with all laws and regulations in the performance of this Agreement, including all relevant export and import laws and regulations of the United States. Further, if applicable, Customer agrees to fully comply with 28 CFR Part 23.

12.17 <u>Choice of Law; Dispute Resolution; Jurisdiction; Venue</u>. This Agreement and all amendments, modifications, alterations, or supplements hereto, and the rights of the Parties hereunder shall be construed under, and be governed by, the substantive laws of the State of Texas, without regard to any conflict of law provisions. The provisions of the United Nations Convention on Contracts for the International Sale of Goods will not apply to this Agreement. If there is a dispute between the Parties relating to this Agreement, the Parties shall first attempt to resolve the dispute by escalating the dispute within their respective organizations. Any litigation arising out of or relating to this Agreement shall take place nonexclusively in the appropriate state or federal court in the State of Texas.

12.18 <u>Paragraph Headings</u>. The paragraph titles used herein are for convenience of the Parties only and shall not be considered in construing the provisions of this Agreement.

12.19 <u>Publicity</u>. No publicity, including, but not limited to press releases concerning this Agreement, or the relationship between the Parties, shall be issued by either Party without the prior written consent of the other Party, which shall not be unreasonably withheld.

12.20 Order of Precedence; Governing Documents. If a purchase order or similar ordering document is issued by Customer for the Solution and/or Services hereunder, the Parties hereby agree that the terms and conditions of this Agreement shall govern and take precedence over any different or additional terms and conditions of such purchase order or similar document.

12.21 <u>Authority to Bind</u>. Each Party hereby represents and warrants that the Party signing below has full right, power and authority to enter into this Agreement and bind such Party accordingly.

Affordable Care Act Reporting and Tracking Service (ARTS) Renewal Information

The Texas Association of Counties Health and Employee Benefits Pool (TAC HEBP) has begun the renewal process for those counties and districts participating in the Affordable Care Act Reporting and Tracking Service (ARTS). Renewal will enable your entity to produce the forms required by IRS Sections 6055/6056 for calendar year 2022, assuming this reporting continues to be a requirement. Reporting will consist of Form 1095C, which must be provided both to employees and the IRS (plus transmittal Form 1094C, filed with IRS). Current law requires all employers with 50 or more full-time equivalent employees to file these forms. ARTS will provide measurement period tracking for 2022 and beyond (to determine whether an employee must be offered health coverage), as well as affordability testing for groups that require employee contributions toward the cost of their own health coverage.

As your county or district provides health benefits through TAC HEBP, ARTS will continue to be available at NO COST in 2022, assuming program deadlines are met.

Your entity will need to continue sending employee, payroll, and unpaid leave of absence files to TAC HEBP in order to utilize this service for the 2022 reports. **Payroll data must be provided for each payroll cycle. Employee files must be provided, at a minimum, once per quarter. LOA files may be provided if and when applicable.** The information provided will be used to determine:

whether individuals are eligible for a federal premium subsidy or tax credit; and
 whether your entity is subject to penalties under the ACA employer mandate.

Some payroll vendors have worked with TAC to produce these files for you. You will be responsible for the completion of required information in your payroll system and submission to TAC, but this eliminates the need for manually producing additional spreadsheets.

If you use a payroll system that will produce the required IRS forms, and you determine that your entity does not need measurement period tracking or affordability monitoring, you may not need ARTS. It is a service offered by TAC and is completely optional.

Dear Judge Haden,

This correspondence is being written in regards to the recent decision made by the Caldwell County Commissioner's Court to remove the stop signs on St. Joseph/River Streets in Prairie Lea.

The residents of this community are concerned, as traffic along St. Joseph has increased significantly due to the incorporation of Son's Blue River Resort into the community. Several families along St. Joseph Street and River Street have small children that play outside during the busy summer months and their safety is of high priority. During the peak summer season, traffic from Son's Blue River inundates our streets and there is little to no law enforcement presence by Caldwell County which has resulted in several animals being ran over and a small child being hit. Ironically the child was hit by a Resort employee who states they were traveling at only 35 miles per hour. This speed is entirely too fast for these narrow community streets and had the stop sign been obeyed to begin with, they would not have been able to reach this speed in such a short distance. Removal of the stop signs will undoubtedly be detrimental to our community and our children. Caldwell County will be held solely responsible and will face litigation should any person, child or adult, be injured at the hands of a reckless driver on St. Joseph Street or River Street if these stop signs are removed as intended.

Caldwell County conducted a traffic study when opposition arose about the stop signs from individuals who reside in the community. These residents DO NOT live on the heavy traffic side of St. Joseph and River Streets, nor do they have children, therefore, should not have been allowed to single handedly influence the decision to have the stop signs removed. The traffic study was conducted on October 14, 2021 during a significant flood event. The first problem with this study is that it followed a flood which is enough to reduce traffic flow through the community regardless of the time of year. Secondly, it was conducted AFTER peak season which is typically from spring break until Labor Day (March-September). The community is requesting the traffic study be conducted during the summer when an accurate evaluation of traffic flow from the Resort can be obtained. Residents are also requesting regular law enforcement patrols to ensure drivers are obeying the current traffic laws and maintaining safe speeds throughout the community.

The County will immediately notify Owners of any and all damage resulting from the negligence or misconduct of the County. - 5. MUTUAL INDEMNIFICATION. 





GENERAL

This Engineering Summary Report (ESR) accompanies the Final Plat for the proposed Oakmont Estates Subdivision. This ESR was prepared in accordance with the Caldwell County Subdivision Ordinances. The proposed subdivision consists of approximately 31.58 acres, according to the plat prepared by JDS Surveying, Inc. The site is located along south of FM 672, west of Barth Road (CR 179), and north of Union Pacific Railroad in Caldwell County, Texas. The site is not located within the city limits or extra-territorial jurisdiction (ETJ) of any municipality.

The site consists of approximately 31.58 acres and is currently undeveloped with no sizeable man-made structures. Out of the 31.58 acres, 0.3 acres is being dedicated to Caldwell County for public right-of-way. The proposed subdivision consists of 12 lots. The proposed lot lines are shown on the plat.

SITE CHARACTERISTICS

The overall site is located on a knoll area that slopes gently to moderate to the north, south, east and divided into four drainage areas, DA-01, DA-02, DA-03 and DA-04. Drainage on the site is a combination of sheet flow and shallow concentrated flow.

The proposed development will consist of creating twelve single family residential lots. The minimum lot size is 1.00 acre, the largest lot size is 4.02 acres, with the majority of the lots being in between 2.00 acre and 3.39 acres. All lots meet the minimum required lot size for lots with public water supply and private on-site sewage facilities (OSSFs). All lots have adequate roadway frontage for residential driveways and meet the required driveway separation distances per Caldwell County.

ROADWAYS AND DRAINAGE

The site fronts FM 672 and Barth Road (CR 179). All lots have adequate roadway frontage onto FM 672 and Barth Road and meet the required driveway separation distances. No internal roadways or drainage structures are proposed for the subdivision, only private residential driveways.

A drainage analysis was performed by Kevin Ware, PE, for the proposed subdivision. This analysis estimated approximately 4,000 sf of new impervious cover per lot for single family residences and associated driveways, etc. The drainage analysis is included as Appendix A of this report. The evaluation performed by Mr. Ware indicated that on site detention is not required for the subdivision. The Drainage Area Map, Figure 1, included

in the drainage analysis, shows the proposed lot lines, the site topography, as well as the drainage basin areas. We are requesting a Detention Waiver since the development will result in less than 3.5% impervious cover. Any stormwater conveyances required (other than driveway culverts) will be via open swales.

Minimal grading will take place on site to accommodate the residences and the driveways. No regrading at the site is included as part of the project. According to FEMA Flood Insurance Rate Map Community Panel No. 48055C0150E, effective date June 19, 2012, the property shown is within Zone X "other areas", being defined as areas outside the 0.2% annual chance floodplain.

Since no internal roads or utilities are being constructed there will be no erosion control required by the developer. As each of the lots are developed with houses and utilities (water services and OSSF/ septic) temporary erosion controls need to be in place on each lot to prevent off site transport of sediment. The temporary erosion controls need to remain in place until the disturbed areas have been revegetated and the vegetation is established over 90% of those areas.

UTILITIES

Water will be provided to the site by Maxwell Water Supply. There is no municipal wastewater service available to the site. The lots will be served by individual on-site sewage facilities (OSSFs). A Facility Planning Report (FPR) is being submitted, by James Adams, RS, under a separate cover.

Public utility easements (PUEs) were placed along the front, side and rear lot lines, as is customary for a newly platted subdivision.

APPENDIX A DRAINAGE STUDY



Methodology

The site is analyzed by hand on a plotted 24" x 36" sheet using LiDAR data from the Texas Natural Resources Information System (TNRIS). The site was divided into four drainage basins, DA-01- 6.47 acres, DA-02 – 12.29 acres, DA-03 – 11.09 acres and DA-04 – 1.74 acres. The project is bounded on three sides, the south side of FM 672, the west side of Barth Road (CR 179) and on the North side of Union Pacific Railroad. See attached drainage area map. All drainage analysis is done in accordance to the Caldwell County Drainage Design Manual.

Drainage Areas

Drainage areas DA-01, DA-02, DA-03 and DA-04 gently slope between 0.6% - 2.5%. Drainage area DA-01 draining towards FM 672. DA-02 and DA-03 drains towards the southwest and southeast Union Pacific right-of-way, respectfully. DA-04 drains to the southwest into a channel crossing the Union Pacific Railroad near Barth Road. All drainage areas have two flow regimes, sheet flow and shallow flow. The total Tc for the four drainage areas were calculated, see results below.

Rational Method

Existing and proposed runoff values were calculated using the Rational Method, where Q(cfs) = CiA. The rainfall data was taken from the City of Austin, Drainage Design Manual, Dated 2020, that utilizes the Atlas 14 rainfall data for Zone 2. The project area in the predevelopment state is considered agricultural or open areas having a coefficient value of 0.3. In the post development each lot is to have an average 4000 ft², or 0.09 acres of drives, walks and roofs having a coefficient of 0.97. In the post development state for the 31.58 acres the weighted coefficient is 0.323, however because of the drainage divide, some lots drain the impervious run-off from the lot more into one drainage

area than the other. Thus the weighted coefficient for DA-01, DA-02, DA-03, and DA-04 in the post development is 0.326, 0.316, 0.328 and 0.335, respectfully. The run-off calculations are for the 2 year, 5 year, 10 year, 25 year, 50 year and 100 year storm events and are as follows.

Conclusion

The development will result in less than 3.5% impervious cover. As such, the run-off in the pre vs. post development state does not significantly increase the run-off for all the drainage areas. It is therefore requested that detention be waivered for this site.

RESOLUTION 28-2022

RESOLUTION OF CALDWELL COUNTY COMMISSIONERS COURT

WHEREAS, Caldwell County obtained information indicating that certain drug companies and their corporate affiliates, parents, subsidiaries, and such other defendants as may be added to the litigation (collectively, "Defendants") have engaged in fraudulent and/or reckless marketing and/or distribution of opioids that have resulted in addictions and overdoses; and

WHEREAS, these actions, conduct and misconduct have resulted in significant financial costs in the past to the County and will undoubtedly result in significant financial costs in the future; and
