2018 Property Tax Rates in Quanah Hospital District

This notice concerns 2018 property tax rates for Quanah Hospital District. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's effective tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's rollback tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

Notice of Tax Revenue Increase

The Quanah Hospital District conducted public hearings on August 23, 2018 and August 27, 2018 on a proposal to increase the total tax revenues of the Quanah Hospital District from properties on the tax roll in the preceding year by 10.094752 percent.

The total tax revenue raised last year at last year's tax rate of 0.275839 for each \$100 of taxable value was \$865,605.00.

The total tax revenue proposed to be raised this year at the proposed tax rate of 0.302100 for each \$100 of taxable value, excluding tax revenue to be raised from new property added to the tax roll this year, is \$952,182.19.

The total tax revenue proposed to be raised this year at the proposed tax rate of 0.302100 for each \$100 of taxable value, including tax revenue to be raised from new property added to the tax roll this year, is \$957,133.19.
