REQUEST FOR PROPOSAL (RFP) FOR ADMINISTRATION PROFESSIONAL SERVICES FOR THE AMERICAN RESCUE PLAN ACT "EXHIBIT B"

Two proposals were submitted and scored: Gary Traylor & Associates scored 361 and Grant Works 379. Judge Deaton stated the County has worked with Grant Works as they took care of the grants for TXDOT and Gary Traylor &

Associates has taken care of all the grants for water and sewer. Mike Medina made a motion to accept Grant Works to handle RFP for Crockett County. G L Bunger seconded, all in favor. Motion carried.
