CTTC is seeking approval of a ROW Permit on CR 422 in the town of Rochelle in Precinct #4, originating from its existing buried fiber mainline at 2K2-8/HH9 and traveling northeast on the north side of CR 422, placing two additional hand holes, 2K2-8/HH10, and 2K2-8/HH11, boring south under CR 422 to serve a local residence. This construction is necessary to provide a constituent of Pct.#4 with access to 911, telephone, & internet services. Said construction route shall contain (2) 1-1/4" poly duct conduits with fiber cable inside-Drew McCarn-(attachment)
2. Permit for Rochelle WSC-proposing new tie into existing water line in county road right of way-Luke Van Diest-(attachment)
3. McCulloch County Resource Center (food pantry) is requesting funds from the ARPA Grant, in the amount of \$12,000. The money will allow us to purchase food for our clients for one year. Each month the food pantry serves 655 people/276 households-Ingrid McDonald
