1. Request approval for use of County Courthouse lawn for Christmas in the Heart activities on December 14, 2024-Daniel Mendoza
2. CTTC is seeking approval of a Road Crossing Permit on Tenth St. in the town of Mercury in Precinct #4, originating from its existing buried fiber mainline at 601-6-2 and crossing under Tenth St, using existing conduit, and placing a hand hole, 601-6-2 and traveling south on the east side of Tenth St and exiting the R.O.W. into private. This crossing is necessary to provide a local community building in Pct #4 with access to 911, telephone & internet services. Said bore shall contain two (2) 1-1/4" poly duct conduits with fiber cable inside.-Drew McCarron- (attachment)
3. Consider and approve quote number 640 from Pierce Air Conditioning in the amount of \$14,600.00 to replace two five ton air conditioner units at the old jail. Funds will be used from the CSLFRF monies-Judge Trull (attachment)
