## PRESS RELEASE, FOR IMMEDIATE RELEASE: IMPACT OF COVID-19

Current Situation: At least 443 new coronavirus deaths and 18,014 new cases were reported in Texas on Feb. 3. Over the past week, there has been an average of 16,778 cases per day, a decrease of 20 percent from the average two weeks earlier. As of Thursday afternoon, there have been at least 2,453,639 cases and 38,232 deaths in Texas since the beginning of the pandemic, according to a New York Times database.

The Texas Department of State Health Services (DSHS) is currently reporting a total of 2,132,595 cases of COVID-19 in the State of Texas which includes an estimated 354,724 active cases. 2,037,888 individuals have recovered from the virus and 37,727 confirmed COVID-19 related fatalities. Across Texas, a total of 17,846,886 COVID-19 molecular tests have been completed. DSHS is also reporting, Texas has received and distributed a total of 3,759,9500 doses of COVID-19 vaccine, which has been administered to 2,755,737 people in 254 Texas Counties. The Texas Department of State Health Services (DSHS) is currently reporting a total of 7,337 cumulative tests have been administered in Presidio County. ## **COVID-19 Vaccine Information**

## Marfa

On Tuesday, February 9, 400 doses of Covid-19 vaccine will be administered in Presidio County by a team from Midland Memorial Hospital. Vaccination will take place at the **Marfa Visitors Center (USO)**. Everyone will enter the Visitors Center through the main doors on Highland Avenue and proceed to the ballroom to receive vaccine. Volunteers will be present to assist.

Vaccination will begin at 10:00 am and end at 4:00 pm. Appointments are necessary for Marfa Vaccination Clinic. You must call Marfa Country Clinic at 729-3000 to make an appointment in order to be vaccinated. Registration is open to tri-county residents.

Registration forms will be available online on the Presidio County website or can be picked up at the County Judge's Office in advance. If you need additional information, please call Judge Guevara's' office at 432-729-4452. **Registration is open to tri-county residents.** 

Vaccination is open to anyone in the Phase 1A category (health care workers and first responders) or the Phase 1B category (people 65 years of age or older, and people 16 years of age and older with at least one chronic medical condition that puts them at increased risk for severe illness from the virus that causes COVID-19). You must qualify as 1A or 1B to receive vaccine at this time.
