- 3. The Court approved the increase from \$70.00 to \$85.00 for court appointed attorney fees effective January 1, 2023. Commissioner Behrens made the motion and Commissioner Deans seconded. All in favor Motion carried. 5-0
- 4. The court discussed and approved the selection of nominees for the 2023 Board of Directors of the County Appraisal District with Channing Booker and Chris Popp being nominated. The county has no nominations at the time No Action motioned. Commissioner Deans made the motion with Commissioner Behrens seconded. All in favor Motion carries. 5-0
- 5. The court considered and accepted the resignation letter from Commissioner of Precinct #4 Rick Kemp. Mr. Kemp has been offered two Pastoral positions in which he intends to accept one upon the acceptance of his resignation. The resignation will be effective November 1, 2022. - 7. The Court approved the 2022-2023 Investment Policy for McCulloch County with Commissioner Behrens made the motion with Commissioner Anderson seconding. All in favor Motion carries. 5-0
