- CTTC request to bore CR 414 from its existing buried fiber optic plant within the east ROW across
 the west ROW and exiting into private property in order to provide fiber optic service to Pct. #4
 resident was approved with Commissioner Anderson made the motion with Commissioner Deans

- 2. CTTC request approval to extend its buried fiber optic cable to conduit within the south ROW of CR 468 in Pct. #4, in order to provide service to a Pct. #4 resident at 469 CR 468 Rochelle, said extension would entail approximately 1,900 feet of new buried fiber within the south ROW. Commissioner Deans made the motion and Commissioner Anderson seconded. All in favor Motion carried. 4-0.
