Code § 2155.504 which states "Purchases from Texas Smart Buy are deemed to satisfy competitive bid requirements. Commissioner Behrens made the motion with Commissioner Deans seconded. - 4. The Court approved to go into Closed Executive Session pursuant to Local Government Code, Chapter 551.071 for consultation with the County Attorney Bruce James to discuss subdivision regulations.
