**Discussion:**

1. Commissioner Anderson brought to the court the discussion of setting workshops regarding Subdivision Regulations. The court agreed to set a meeting on the agenda for March 28, 2022 as to give time for County Attorney Bruce James to look over and research the regulations for McCulloch County.

**Action:**

1. The Court acted and approved for Central Texas Telephone Co-op to install buried fiber optic cable on county road right of way. The plan includes all installations, lengths, locations and roads involved. This will help improve the phone and broadband service in the rural area. Commissioner Deans made the motion with Commissioner Behrens seconded. All in favor Motion carries. 5-0.
2. The Court approved the Rotary Club to place Texas Flags on the courthouse lawn in March for Texas Independence Day and during the Heart of Texas Music Festival. The dates will be March 17<sup>th</sup> through the 26<sup>th</sup> for the music festival. Commissioner Behrens made the motion with Commissioner Deans seconded. All in favor Motion carries. 5-0.
3. The Court approved the Resolution on the Improved Officer’s safety project for McCulloch County presented by Sheriff Officer Chief Deputy Jason Corbell. Commissioner Anderson made the motion with Commissioner Deans seconded. All in favor Motion carried. 5-0
4. The Commissioners Tabled the Order of Special Constitutional Election for Saturday May 7, 2022 until further confirmation from the Secretary of State that it has the correct language. Commissioner Behrens made the motion with Commissioner Deans seconded. All in favor Motion carried. 5-0
